Dear Chair Elefante and Members of the Committee,

On behalf of GIFFORDS, I submit this testimony in strong support of SB 1030, which builds upon Hawai'i's already robust protections against firearms at polling places and drop boxes by taking a more comprehensive approach to preventing armed intimidation in elections.

The Growing Threat of Armed Intimidation in Elections

Hawai'i has been a leader in ensuring that polling places and drop boxes remain free from firearms, recognizing that guns have no place in the democratic process. However, threats to democracy have evolved. Increasingly, bad actors seek to weaken the electoral process not necessarily through direct violence, but through intimidation—using the mere presence of firearms to discourage participation and sow fear among voters and election workers.

This bill acknowledges the reality that armed intimidation is a tactic explicitly designed to erode trust in our elections. In recent elections across the country, we have seen armed individuals¹ gathering near polling sites and drop boxes, engaging in surveillance² and, increasingly, escalating to direct confrontations and threats.³ While no shots have yet been fired, the chilling effect on democracy is undeniable.

Emerging research confirms that the presence of firearms can deter civic engagement, particularly among historically disenfranchised groups. For instance, a 2022 Global Project Against Hate and Extremism study⁴ found that 41% of voters feel unsafe at polling places, with nearly one-third fearing Election Day violence—concerns even higher among minority voters.

Additionally, the Brennan Center for Justice⁵ has found that over a third of election workers have faced threats and harassment, fueling a historic exodus⁶. This climate of intimidation has worsened amid surging gun sales, with nearly 1 in 4 Americans now believing political violence may be necessary to "save the country."⁷

Recent reports, including GIFFORDS' *Guns & Voting⁸* report (written in partnership with the Brennan Center for Justice) and *Engines of Extremism: How the Gun Industry Profits from Fear⁹*, further detail how firearms are increasingly being used as tools of voter suppression and intimidation. The latter report also highlights how gun industry marketing strategies have exacerbated fears of political violence, contributing to an environment where armed intimidation at election sites has become normalized.

The Need for a Comprehensive Approach

SB 1030 strengthens existing protections by clarifying that armed intimidation includes carrying firearms near voter service centers, places of deposit, and polling places. To provide the strongest safeguards, we recommend a 100-foot prohibition around these locations—a standard already adopted by several states including: Colorado (Colo. Rev. Stat. § 1-13-724), Michigan (Mich. Comp. Laws Serv. § 750.234d(3)), and New Mexico (N.M. Stat. Ann. § 1-20-24) have all enacted similar measures, while Virginia passed a comparable law that was later vetoed by the governor (VA HB 939 (2024)). Adopting this standard will align Hawai'i with other states committed to protecting elections from armed intimidation.

Conclusion

Safe and accessible elections are fundamental to our democracy. No voter or election worker should feel unsafe due to the presence of firearms when participating in or administering our elections. SB 1030 takes a proactive and necessary step to ensure that intimidation does not become a tool for suppressing voter participation in Hawai'i. We thank the committee for addressing this critical issue and urge swift passage of SB 1030.

In furtherance of Brady's goal to reduce firearm violence across Hawaii, the Hawaii Chapter of the Brady Campaign to Prevent Gun Violence is proud to offer its strong endorsement of SB 1030.

For decades, Hawaii leaders have prioritized the safety and well-being of the people of Hawaii by enacting and implementing proactive, research-informed policy solutions that prevent gun violence, save lives, and spare entire communities from loss, trauma and cycles of violence. However, the data from the Centers for Disease Control and Prevention as of 2024 is disturbing:

- Every year, 34 people in Hawaii die by firearm suicide.
- Every year, 15 people in Hawaii are victims of firearm homicide.
- On average, 55 people in Hawaii are killed by gun violence each year and an average of 30 of those deaths occur in Honolulu County.
- Every 7 days, someone in Hawaii is shot and killed.

Since the US Supreme Court has eased the way for more firearms to permitted in our public places, there has been an increase of gun-related violence in Hawaii. This bill is needed more than ever.

Assuring our citizens are not intimidated while exercising their constitutional right to vote should be a priority.

Testimony of Ramya Swami, State Policy Manager, Brady Campaign to Prevent Gun Violence Support for SB 1030 Before the Senate Committee on Public Safety and Military Affairs February 13th, 2025

Dear Chair Elefante, Vice-Chair Wakai and Distinguished Members of the Senate Committee on Public Safety and Military Affairs,

Founded in 1974, Brady works to change the law, change the industry, and change culture to free America from gun violence. Our organization today carries the name of Jim Brady, who was shot and severely injured in the assassination attempt on President Ronald Reagan. Jim and his wife, Sarah, led the fight to pass federal legislation requiring background checks for gun sales. Brady continues to uphold Jim and Sarah's legacy by uniting Americans across the country in the fight to prevent gun violence.

There are evidence-based policy solutions that we know will help to prevent gun violence in Hawaii. The bill before you today, **SB 1030**, will help protect our democratic spaces by specifying that the practice of election fraud intimidation includes carrying any firearm or weapon at or near a voter service center, place of deposit, or polling place.

Voter intimidation is not only dangerous, it is unlawful. It is against the law to engage in any efforts to intimidate, threaten, or coerce a person to vote, not to vote, or support or oppose a particular candidate.¹ Voter intimidation or suppression has many forms but one of the most frightening forms is *armed* intimidation, which further contributes to the growing gun violence epidemic in our nation.² Armed intimidation threatens one of our most fundamental rights in democracy's most sensitive location - the voting booth. Allowing firearms at polling locations is voter intimidation, plain and simple. The presence of guns at or around these spaces poses a danger to the process of fair and free elections simply because of the inherent threat to voters' emotional and physical well-being.

Threats of armed intimidation have grown in size and scale in the past decade. This issue is one that has plagued a variety of states, and is of chief concern for law enforcement officers and election officials alike. Just five days prior to the 2024 presidential election, an 18-year-old man was arrested and charged with aggravated assault for threatening two supporters of Vice President Kamala Harris outside of a polling place in Florida.³³ Two months prior to the 2020 election, the United States Department of

Homeland Security released a draft threat assessment that asserted "open-air, publicly accessible parts of physical election infrastructure," including polling places and voter registration events, could be "flash points for potential violence."⁴

This bill poses no threat to the Second Amendment rights of Hawai'ians, as the Supreme Court has recognized that the prohibition of guns in sensitive places - in this case, polling places - is one of several "presumptively lawful regulatory measures."⁵ There are common sense solutions that we know are necessary to protect the electoral rights of the people of Hawai'i at such a fragile time in our republic, and this bill is one of them.

The rate of firearm ownership has grown exponentially alongside deepening ideological divides; this potent combination has led to the proliferation and increased threat of extremist militia organizations nationwide that continue to use firearms in threatening and intimidating ways, including near or at polling locations or outside recount locations. Clear instances of armed voter intimidation plagued the 2020 election⁶ and public officials must assume that this behavior will continue in order to best protect their constituents. Proactive steps like **SB 1030** must be taken to ensure the safety and security of our electorate.

Brady strongly encourages a favorable report for SB 1030, which will help protect our democratic spaces by specifying that the practice of election fraud intimidation includes carrying any firearm or weapon at or near a voter service center, place of deposit, or polling place.

Chair Rhoads, Vice Chair Gabbard, Chair Elefante, Vice Chair Wakai and Members of the Committees,

The Hawaiian Islands Republican Women support free and fair elections that are within the rule of law.

The Hawaiian Islands Republican Women STRONGLY OPPOSE SB1030 for the following reasons:

- 1. There are currently sufficient laws protecting voters as well as laws defining election procedures.
- 2. What constitutes "intimidation" in SB1030? This is subjectively stated in SB1030.
- 3. If someone is perceived to be intimidating, does that equate to election fraud? NO

The US Elections Assistance Commission (EAC) defines election fraud as, "The misrepresentation or alteration of the true results of an election." Source: www.eac.gov

The use of the word "intimidation" to the term "election fraud" has no literal relationship. It creates a term that technically has nothing to do with the definition of election fraud.

SB1030 duplicates already existing Sensitive Places law, and at the same time unlawfully reextends it to certain public places that have been successfully challenged in court.

The August 8, 2023, ruling on Hawai'i's Sensitive Places law in the United States District Court, District of Hawaii Wolford vs. Lopez case struck down the section of the law pertaining to firearms at public parks.

All of Oahu's ballot places of deposit are in public parks, except the ones at Kapolei Hale and Honolulu Hale. The other counties also have ballot places of deposit in parks. This bill is in direct contradiction to the Wolford vs. Lopez case.

It is our 1st Amendment right to photograph in public places. The ACLU and state of Hawaii Attorney General agreed that it is a 1st Amendment right to take photographs in public, as affirmed in the 2016 case brought by the ACLU. If our lawmakers want to change the laws regarding photography in government buildings open to the public, it needs to be addressed in a separate bill.

Please vote NO on SB1030. Thank you for the opportunity to testify.

I stand in **Strong Opposition** to this bill. It attempts to criminalize one right while exercising another and is poorly worded and thought out. Simply walking within a certain distance of a mailbox with a self defense tool would now be a crime without any intent to intimidate or harass other voters. And given that Hawaii engages in early voting, it would mean weeks of people being forbidden to go near these places or face arrest.

Current laws should be enough to prevent this, or at least allow for add on charges for those who would break this law as it currently is. Openly carrying a firearm is not available to the average citizen and is a crime. If someone is concealing a firearm, how can they be acting in a manner meant to threaten someone? They can't, as they would need to make a verbal or visual threat which is already covered under this law. Brandishing a firearm on its own is a crime, and doing the same with any other dangerous implement can catch you a terroristic threatening charge.

And again this bill is so poorly worded that now law enforcement would be breaking the law if they simply go near a polling place and are simply doing their jobs and would leave such places vulnerable. Yet if you were to attempt to fix this by amending an exemption for police officers or security guards, it could easily be abused by those officers who would wish to intimidate others during an election.

- Criminalizing the presence of firearms near polling places could deter voters, particularly in areas where personal security is a concern, from participating in elections. Additionally, it might foster a sense of distrust towards electoral processes, suggesting that elections are inherently dangerous or confrontational when they should be seen as safe and civic.

7. **Resource Allocation:**

- Enforcing this expanded definition would require additional resources, both in terms of law enforcement presence and judicial processing, which could be better allocated to actual security threats or to improve election integrity in more direct ways.

In conclusion, while the intent to ensure fair and safe elections is commendable, Senate Bill 1030 takes an approach that is overly broad, potentially unconstitutional, and not supported by evidence of a widespread problem. I urge you to reject this bill and instead focus on proven, balanced approaches to secure our elections without infringing on individual rights.
