The Department of Business, Economic Development, and Tourism (DBEDT) supports the intent of SB1186 SD2 HD2, which establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Agribusiness Development Corporation (ADC) and appropriates funds for 3.00 temporary full-time equivalent positions for DBEDT.

DBEDT has established an internal working group comprising the ADC, Office of Planning and Sustainable Development (OPSD), Department of Agriculture (DOA), University of Hawai'i College of Tropical Agriculture and Human Resources (UHCTAHR), and the Department of Education (DOE). This group focuses on addressing the farm-to-export pipeline, aligning inputs to the Food and Product Innovation Network (value-added production), DOE's regional kitchens (Farm-to-School, Act 175), and Farm-to-State initiatives (Act 176).

DBEDT Testimony SB 1186, SD2, HD2 Page 2 of 2

These collaborative efforts aim to fulfill the mandate outlined in Act 151 to double local food production and exports by 2030. DBEDT has shared its progress and findings with the interagency food systems working group during the interim, in accordance with SR111, and will continue to engage in these efforts. Our ongoing projects are designed to reduce Hawai'i's dependence on imports, strengthen our food security ecosystem, and support the construction of resilient food production facilities.

DBEDT respectfully requests 1.00 FTE permanent position: Crop Commodity Coordinator with a salary of \$85,765 for FY26 and \$83,315 for FY27. The Crop Commodity Coordinator will support Hawai'i's agricultural sector by providing strategic guidance, coordination, and market expansion for local crop commodities. This position will focus on identifying high-value crops, improving supply chain efficiencies, and developing strategies to enhance Hawai'i's agricultural competitiveness in both local and export markets. With the state's goal of doubling local food production, there is an urgent need to strengthen coordination among farmers, processors, and distributors. The Crop Commodity Coordinator will play a critical role in supporting growers, facilitating market linkages, and addressing production challenges such as pest and disease management, mechanization, and sustainability practices. This position will also assist in leveraging federal and state programs to support crop innovation and market access, ensuring a stable and resilient agricultural economy for Hawai'i.

Mahalo for the opportunity to testify on this measure, and we look forward to continued collaboration to achieve our shared goals of enhancing Hawai'i's agricultural capacity and food security.

The Hawaii Cattlemen's Council **<u>supports SB1186 SD2 HD2</u>** which establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture.

The state has many goals for increasing local food production and increasing departmental local food purchasing. However, progress towards these goals have been slow and more attention is needed to identify where the bottlenecks are and what is needed to start meaningfully supporting our farmers and ranchers and making local food more accessible to our community.

We support this measure because Hawaii's cattlemen are ready and willing to supply a high quality protein for our community, but there are procurement and procedural issues to overcome. If solutions can be found for the state to begin consistently sourcing local beef, it would provide ranchers with a reliable market to encourage more local beef production, increase our access to a high quality protein source, improve community health, and move the needle on the states local food production goals.

In the 2023-2024 school year, beef contributed the highest number of local food purchasing for school lunches at 3%. The DOE is currently tasked with increasing local food served in public schools to 30% by 2030. Hawaii's paniolo can supply more than 3%, but the procurement system is a barrier. Our hope is that this Interagency Food Systems Coordination team will help us to help the state meet its local food goals.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, manufacturers and distributors of food and beverage related products in the State of Hawaii.

HFIA is in support of this measure. As the measure notes, food insecurity in Hawaii is alarmingly high, and there are many barriers that make it challenging for businesses that want to produce food locally. HFIA has long advocated for initiatives that will reduce food insecurity; supported local food manufacturing and other local businesses; and served as the voice of Hawaii's food and beverage industry. We have high level understanding of Hawaii's food systems and industry expertise.

We are in agreement with this measure that "achieving a sustainable, resilient, and equitable food system requires collaboration across state agencies, producers, retailers, non-governmental organizations, and community members."

As one of the tasks of the Interagency Food Systems Working Group the measure states that the group shall:

"(2) Coordinate with county and community-led organizations that are involved with food systems planning;"

On behalf of Hawai'i Foodbank, I express our support for SB1186, Relating to Food Systems. This bill establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture, requires reports to the Legislature, establishes positions, and appropriates funds.

As the state's largest hunger-relief organization, Hawai'i Foodbank has been committed to ensuring no one in Hawai'i goes hungry since 1983. We work with over 250 hunger-relief partners on O'ahu and Kaua'i to distribute food, and programs like Food 4 Keiki and 'Ohana Produce Plus provide nutritious meals to children and families. In addition to addressing daily needs, our organization mobilizes during emergencies to provide immediate relief and aid long-term recovery efforts.

Food insecurity is a growing crisis in Hawai'i, with nearly 1 in 3 households struggling to access adequate food. One in ten households go a whole day without food some or most months. A statewide strategy developed in collaboration with partners across the food system is a necessary step to developing a more sustainable and resilient food system in Hawai'i, and we are supportive of this important effort.
