households.<sup>3</sup> This increased disease burden significantly impacts both individual health and
 community wellbeing.

For more than five years, the DOH has supported Food Access Coordinators in every county to convene stakeholders, coordinate activities, and develop infrastructure to build community-based food systems across the state. The intention of these collaborative networks is to develop coordinated projects and build capacity within partner organizations and food-insecure populations.

The DOH recognizes that complex food system challenges and ensuring that healthy food access available to all, requires coordinated solutions. The DOH supports S.B. 1186, S.D. 1, is committed to continued collaborate in these efforts, and looks forward to participating in an interagency food systems working group.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 1186, SD1, which establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture (DOA). This measure aims to improve coordination among state agencies to strengthen Hawai'i's food system, requires reports to the Legislature, establishes positions, and appropriates funds for its implementation.

A coordinated approach to food system development can help address challenges related to local food production, distribution, procurement, and market access. Farmers and ranchers often face regulatory barriers and logistical challenges that limit their ability to expand local food production. By facilitating collaboration between government agencies and agricultural stakeholders, this initiative has the potential to streamline policies, improve procurement processes, and increase opportunities for farmers to participate in state food programs such as Farm to School and Farm to State.

However, we have concerns regarding the proposed salary amounts for the new positions. Ensuring that salaries align with comparable state positions is necessary to maximize funding efficiency and ensure that resources are directed toward direct support for farmers and food producers rather than administrative overhead.

Additionally, there is uncertainty regarding who the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group report to and where their authority is derived from. Clarification is needed to define their decision-

making role, ensure accountability, and prevent duplication of efforts with existing programs and agencies already working to improve Hawai'i's food system. Without clear oversight and guidance, the effectiveness of these teams may be limited.

To improve SB 1186, SD1, we recommend:

- Ensuring that farmers and ranchers are actively represented in the working group to provide real-world perspectives on the challenges and opportunities within Hawai i's food system.
- Ensuring salary levels are consistent with similar positions within the DOA and other state agencies to ensure fiscal responsibility.
- Defining the reporting structure and decision-making authority of the coordination team and working group to ensure clear oversight and prevent redundancy.
- Developing clear performance metrics and accountability measures to assess the effectiveness of the coordination team and working group in improving food system outcomes.

As both a citizen and food system scholar, I am writing in strong support of SB 1186, which advances food system planning as a critical tool for achieving Hawai'i's economic, cultural, public health, and ecological goals. Food system planning is a structured, interdisciplinary approach to developing resilient, equitable, and sustainable food systems that enhance food security, economic development, and climate change adaptation. Given Hawai'i's geographic isolation and dependence on food imports, a well-integrated, locally focused food system is essential for reducing vulnerabilities and ensuring long-term sustainability.

Hawai'i has made important strides in food system planning through the inter-agency Food System Working Group, led by the Hawai'i Department of Agriculture, the Office of Planning and Sustainable Development, the Department of Health, the Office of Hawaiian Affairs, and grower organizations. Their report to the Legislature (available at: <a href="https://document.org/html/>
HDOA Report">HDOA Report</a>) outlines key policy priorities and systemic challenges. However, additional resources and long-term commitments are needed to implement a comprehensive, statewide food system strategy that meets Hawai'i's economic, environmental, and public health needs.

Investing in food system planning will yield significant benefits for the state. The ongoing challenges of chronic household food insecurity—currently affecting 30% of Hawai'i's residents—and high rates of diet-related illness disproportionately impacting Native Hawaiian and Pacific Islander communities underscore the urgency of action. The externalized costs of the current food system—including healthcare expenditures related to diet-related disease, environmental degradation, and economic losses due to the decline of local agriculture—represent a substantial burden on state resources. Addressing these issues through

coordinated food system planning will create long-term economic efficiencies and improve public health outcomes.

Supporting SB 1186 will also position Hawai'i as a leader in national food system transformation. Michigan State University's Center for Regional Food Systems is forming a National Community of Practice for state-level food system planning (MSU CRFS National CoP), and Hawai'i has the opportunity to be an active participant in shaping national policy and best practices. By formalizing food system planning efforts, Hawai'i can strengthen its position as an innovator in sustainable food systems, serving as a model for other states and island nations seeking to enhance food security, climate resilience, and agricultural sustainability.

SB 1186 aligns with existing state mandates related to food and agriculture and will help realize Hawai'i's long-term goals of economic self-sufficiency, environmental stewardship, and cultural preservation. I urge you to support this critical legislation and provide the resources needed to advance comprehensive, equity-centered food system planning across the state.
