Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify in support of SB 1186 which establishes a Statewide Interagency Food Systems Coordination Team and Interagency Food Systems Working Group within the Department of Agriculture.

Farmers face costs that are 40% higher on average than those faced by producers in the continental U.S. Biosecurity is driving those costs up every day.

Including local food in our school and state institutions has the potential to positively impact our local farmers as well as our keiki. The need to work together across agencies is paramount toward getting regional food kitchens off the ground.

As we see in those examples, multiple agencies are needed to coordinate on complex issues like biosecurity and school food - the same is true for many other complex issues Hawai'i farmers and the local food system faces such as land, capital and market access. Coordination is essential to make sure we work together effectively.

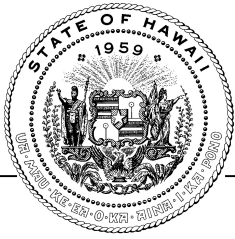
The Senate Resolution 111 Sustainable Food Systems working group has already completed a report outlining initial priorities for coordinating statewide food systems over the next year. A number of foundations supported this initial work.

Appropriations to officially house a Statewide Food Systems Coordination team within the Department of Agriculture is integral to taking this coordination beyond 2025-2026 and making progress on key food systems issues like biosecurity and farm to school.



The HDOA is optimistic that the effort of the Working Group will result in a measurable, science-based, and functional Plan that will promote the State's highest priorities of increasing the economic viability of existing agricultural operations and assist in the establishment of new ones in direct support of increasing local food self-sufficiency and exports.

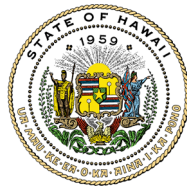

Thank you for the opportunity to submit testimony to **COMMENT ON** Senate Bill 1186.

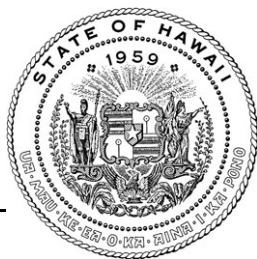

Chair Gabbard, Vice Chair Richards, and members of the Committee:

The Department of Business, Economic Development, and Tourism (DBEDT) supports the intent of SB1186 and defers to the Department of Agriculture regarding positions and funding considerations related to this measure.

DBEDT has established an internal working group comprising the Office of Planning and Sustainable Development (OPSD), Agribusiness Development Corporation (ADC), Department of Agriculture (DOA), University of Hawaii College of Tropical Agriculture and Human Resources (UHCTAHR), and the Department of Education (DOE). This group focuses on addressing the farm-to-export pipeline, aligning inputs to the Food and Product Innovation Network (value-added production), DOE's regional kitchens (Farm-to-School, Act 175), and Farm-to-State initiatives (Act 176).

These collaborative efforts aim to fulfill the mandate outlined in Act 151 to double local food production and exports by 2030. DBEDT has shared its progress and findings with the interagency food systems working group during the interim, in accordance with SR111, and will continue to engage in these efforts. Our ongoing projects are designed to reduce Hawaii's dependence on imports, strengthen our food security ecosystem, and support the construction of resilient food production facilities.

Mahalo for the opportunity to testify on this measure, and we look forward to continued collaboration to achieve our shared goals of enhancing Hawaii's agricultural capacity and food security.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 1186, which establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture (DOA). This measure aims to improve coordination among state agencies to strengthen Hawai'i's food system, requires reports to the Legislature, establishes positions, and appropriates funds for its implementation.

A coordinated approach to food system development can help address challenges related to local food production, distribution, procurement, and market access. Farmers and ranchers often face regulatory barriers and logistical challenges that limit their ability to expand local food production. By facilitating collaboration between government agencies and agricultural stakeholders, this initiative has the potential to streamline policies, improve procurement processes, and increase opportunities for farmers to participate in state food programs such as Farm to School and Farm to State.

However, we have concerns regarding the proposed salary amounts for the new positions. Ensuring that salaries align with comparable state positions is necessary to maximize funding efficiency and ensure that resources are directed toward direct support for farmers and food producers rather than administrative overhead.

Additionally, there is uncertainty regarding who the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group report to and where their authority is derived from. Clarification is needed to define their decision-

making role, ensure accountability, and prevent duplication of efforts with existing programs and agencies already working to improve Hawai'i's food system. Without clear oversight and guidance, the effectiveness of these teams may be limited.

To improve SB 1186, we recommend:

- Ensuring that farmers and ranchers are actively represented in the working group to provide real-world perspectives on the challenges and opportunities within Hawai'i's food system.
- Adjusting salary levels to be consistent with similar positions within the DOA and other state agencies to ensure fiscal responsibility.
- Defining the reporting structure and decision-making authority of the coordination team and working group to ensure clear oversight and prevent redundancy.
- Developing clear performance metrics and accountability measures to assess the effectiveness of the coordination team and working group in improving food system outcomes.

HFIA is in support of this measure. As the measure notes, food insecurity in Hawaii is alarmingly high, and there are many barriers that make it challenging for businesses that want to produce food locally. HFIA has long advocated for initiatives that will reduce food insecurity; supported local food manufacturing and other local businesses; and served as the voice of Hawaii's food and beverage industry. We have high level understanding of Hawaii's food systems and industry expertise.

We are in agreement with this measure that "achieving a sustainable, resilient, and equitable food system requires collaboration across state agencies, producers, retailers, non-governmental organizations, and community members."

Under Section 2 paragraph (c) the measure states that "The co-chairs may invite other representatives of interested organizations with relevant experience and expertise to participate in the interagency food systems working group, as necessary."

We encourage the co-chairs to ensure that when they are inviting representatives of interested organizations that members of the food and beverage industry in general, and HFIA specifically are included.

Chair Gabbard, Vice Chair Richards, and Members of the Committee,

The Hawaii Cattlemen's Council **supports SB1186** which establishes the Statewide Interagency Food Systems Coordination Team and the Interagency Food Systems Working Group within the Department of Agriculture.

The state has many goals for increasing local food production and increasing departmental local food purchasing. However, progress towards these goals have been slow and more attention is needed to identify where the bottlenecks are and what is needed to start meaningfully supporting our farmers and ranchers and making local food more accessible to our community.

We support this measure because Hawaii's cattlemen are ready and willing to supply a high quality protein for our community, but there are procurement and procedural issues to overcome. If solutions can be found for the state to begin consistently sourcing local beef, it would provide ranchers with a reliable market to encourage more local beef production, increase our access to a high quality protein source, improve community health, and move the needle on the states local food production goals.

In the 2023-2024 school year, beef contributed the highest number of local food purchasing for school lunches at 3%. The DOE is currently tasked with increasing local food served in public schools to 30% by 2030. Hawaii's paniolo can supply more than 3%, but the system is currently too complicated and the purchases aren't happening. Our hope is that this Interagency Food Systems Coordination team will help us to help the state meet its local food goals.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75%



of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.

Position: MetroGrow Hawaii is in strong support of this measure.

Testimony: Thank you for the opportunity to offer testimony in full support of this measure. I applaud the recognition by the parties involved of the critical need for our small, isolated and vulnerable island community to prioritize local food production to ensure food security and self-sufficiency.

MetroGrow Hawaii was established in 2014 as the first indoor, vertical hydroponic farm in the state and has been supplying premium produce to local restaurants and markets for over 10 years. Our experience has established that controlled environment agriculture is a technology that works very well to grow a wide variety of crops. We have also been researching how we can expand our farming operations to contribute to the State's goals of local food production, especially to meet the demands of institutional customers such as the Department of Education.

The establishment of the proposed interagency working group will promote a more comprehensive, cohesive, holistic and strategic approach to the critical issue of strengthening our local food systems in

the face of the environmental, economic and societal challenges facing Hawai'i. The broad composition of the committee is admirable and will foster creative thinking and solutions to this daunting task. As the president/owner of an agricultural/technology company I would like to suggest that the committee also include additional representatives from the agricultural community. The College of Tropical Agriculture and Human Resilience most recent strategic plan puts and emphasis on food systems and with their capacity for research, education and outreach needs to be included in any discussions about our future food needs. I also believe a representative to represent our farming community will strengthen the efforts of the committee. A representative from an agency such as the Hawaii Farm Bureau that already advocates tirelessly in the legislature for local agriculture will offer a valuable perspective.

I am encouraged by this proposal and the willingness of the legislature to provide the necessary funding to foster its success. I urge the passage of this important measure and stand ready to assist in any way to advance this effort for our food future. Thank you very much.

Thank you for the opportunity to testify in **strong support** of SB 1186 establishing a Statewide Interagency Food Systems Coordination Team and Interagency Food Systems Working Group within the Hawai'i Department of Agriculture.

The following are just a few of the goals, mandates and visions we have for our local food and agriculture system:

Ensure 50% of foods are local agriculture or valued-added/food products within key state institutions by 2050 (Act 176, SLH 2021).

Farmers, ranchers, aquaculturists, and plant nursery growers experience reduced risk to production, broaden local and export markets, and receive effective support to detect and control pests (Hawai'i Interagency Biosecurity Plan, Vision Section 1.1).

Double local food production by 2030 (Act 151, SLH 2019).

How are we currently coordinating a systematic effort to achieve them?

An Interagency Food Systems Working Group with “backbone” support from a coordination team is essential to answer this question.

With high and increasing agricultural production costs – as well as local food costs – effective and coordinated policy and action are critical to strengthening our economy, food system and ensuring no residents face hunger, now or in times of natural disaster.

There are more than 25 similar state-level efforts across the U.S. as well as multiple food systems planning efforts led by our own counties. This bill will enable us to coordinate our local efforts, while drawing lessons from innovations across the country.

Our farmers, food producers, distributors and most importantly, residents, are depending on our efforts.

Hello Chair Gabbard, Vice Chair Richards, and members of the Committee:

My name is Taylor Wilson, and I am an Indigenous food sovereignty scholar and Ph.D. student at the University of Hawai'i at Mānoa. I strongly support SB1186, which seeks to establish a Statewide Interagency Food Systems Coordination Team and an Interagency Food Systems Working Group within the Department of Agriculture. This bill is a crucial step toward strengthening Hawai'i's food system, enhancing local food production, integrating Native Hawaiian and Pacific Islander food systems, and building a more resilient and sustainable food economy. It also serves as a model for interagency collaboration and Indigenous-led food sovereignty initiatives, demonstrating how policy-driven food system reform can enhance climate resilience, economic stability, and public health at national and international levels.

Hawai'i faces significant food security challenges, with nearly one-third of households experiencing food insecurity—a rate higher than the national average (Hawai'i Foodbank, 2023). The state imports 85-90% of its food, making it vulnerable to supply chain disruptions, climate-related disasters, and economic instability (Kurashima et al., 2019).

Despite past legislative efforts, such as Act 151 (2019) (which aimed to double local food production by 2030) and Acts 175 and 176 (2021) (which promoted local food procurement), major barriers to food system sustainability remain:

- Limited interagency coordination between government agencies and stakeholders (Rowe et al., 2024).
- Insufficient infrastructure and resources to support local farmers and food producers (Kurashima et al., 2019).
- Lack of comprehensive data and strategic planning to measure and implement effective food system policies (Millin, 2020).

Additionally, only 11.6% of food available for consumption in Hawai'i is locally produced, highlighting extreme dependence on food imports (Loke & Leung, 2013).

This bill directly addresses these challenges by:

1. Establishing a Statewide Interagency Food Systems Coordination Team
 - Creates a centralized body to oversee food system initiatives and align state efforts with sustainability goals.
 - Promotes collaboration among government agencies, local farmers, businesses, and community organizations to strengthen Hawai'i's food systems.
2. Creating an Interagency Food Systems Working Group
 - Ensures food policy is developed with representation from agriculture, education, health, planning, and Native Hawaiian and Pacific Islander governance structures.
 - Supports community-led food systems planning at county and local levels.
3. Investing in Infrastructure and Workforce Development
 - Allocates funding for key positions to oversee planning, policy evaluation, and operational needs.
 - Provides resources for stakeholder engagement, public meetings, and strategic planning.
4. Integrating Indigenous Food Sovereignty and Traditional Food Systems
 - Native Hawaiian and Pacific Islander food systems, such as loko i'a (fishponds) and lo'i kalo (taro fields), are sustainable and climate-resilient, producing food without artificial inputs (Millin, 2020).
 - Revitalizing Indigenous agriculture could match modern food production levels, even under future climate change scenarios (Kurashima et al., 2019).
 - Native Hawaiian and Pacific Islander communities face disproportionately high rates of food insecurity, largely due to land displacement and the loss of traditional food systems (Rowe et al., 2024).
 - Strengthening Indigenous food sovereignty aligns with global best practices, including the Paris Agreement's recommendation to integrate Traditional Ecological Knowledge (TEK) into climate adaptation and food security policies (Millin, 2020).
5. Enhancing Climate Resilience and Reducing Reliance on Imports
 - Hawai'i's Indigenous agricultural systems, such as dryland 'uala (sweet potato) farms and colluvial agroforestry, are highly resilient to climate change (Kurashima et al., 2019).
 - 71% of traditional agricultural lands remain zoned for farming, meaning they can be revitalized to increase local food production (Kurashima et al., 2019).

- Investing in local food systems and interagency collaboration will reduce dependency on imports and strengthen community resilience in the face of disasters (Rowe et al., 2024).

6. Improving Public Health Outcomes

- Native Hawaiians and Pacific Islanders experience disproportionately high food insecurity rates, which are strongly linked to diabetes, hypertension, and other chronic diseases (Rowe et al., 2024).
- Increasing access to fresh, local food through better food system coordination can help reduce diet-related chronic diseases.
- Federal food assistance programs like SNAP and FDPIR fail to provide culturally appropriate foods, exacerbating health disparities in Native Hawaiian and Pacific Islander communities (Rowe et al., 2024).

SB1186 is a vital step toward ensuring food security, economic stability, and climate resilience for Hawai'i. The evidence is clear: coordinated efforts to strengthen local food production, revitalize Native Hawaiian and Pacific Islander food systems, and integrate sustainability practices will create a more equitable, resilient, and sustainable food system.

For these reasons, I strongly urge the committee to pass SB1186.
