In consideration of S.B. 1200 RELATING TO WORKFORCE HOUSING.

Chair Chang, Vice Chair Hashimoto, and members of the Committee.

HHFDC **supports** SB 1200, which establishes the Workforce Housing Regulatory Sandbox Program within the Hawai'i Housing Finance and Development Corporation (HHFDC) and establishes an Advisory Council within the Workforce Housing Regulatory Sandbox Program to advise on environmental and cultural practices within specific developments. It also requires annual reports to the Legislature, appropriates funds, and repeals 6/30/2030. HHFDC supports the measure so long as it does not adversely impact priorities identified in the Executive Budget Request for FY 2026.

There are systemic barriers that impede the production of affordable housing development in Hawaii. Addressing these barriers will require a comprehensive and coordinated approach that integrates stakeholder collaboration, regulatory reforms, infrastructure investments, and enhanced financing mechanisms.

HHFDC supports the regulatory sandbox that allows developers to test innovative housing solutions under relaxed permitting and regulatory requirements that could accelerate the creation of workforce housing while addressing broader housing shortages in the State.

HHFDC supports the \$5 million appropriation to seed the new program. HHFDC requests one full-time equivalent (1.0 FTE) I position to help with the administration of the new program.
