**MAKING EMERGENCY APPROPRIATIONS FOR LAW ENFORCEMENT
PERSONNEL COSTS**

The Department of Budget and Finance supports this bill with proposed amendments inserting in the necessary appropriation dollar amounts and providing the necessary dollar amounts and percentage by which the FY 25 appropriations in this bill would exceed the FY 25 expenditure ceiling.

Senate Bill No. 1364, S.D. 1, makes emergency appropriations to the Department of Accounting and General Services (DAGS) and the Judiciary for transfer payments to the Department of Law Enforcement (DLE) for payroll costs of sheriffs.

Section 3 of Act 164, SLH 2023, as amended by Act 230, SLH 2024, appropriated general funds to DAGS in FY 25 for transfer payments to DLE for payroll costs of sheriffs. Similarly, Section 3 of Act 70, SLH 2023, as amended by Act 233, SLH 2024, appropriated general funds in FY 25 to the Judiciary for transfer payments to DLE for payroll costs of sheriffs. While appropriations out of the general fund of the State of Hawai'i exclude fringe benefit costs, fringe benefits must be included if an appropriation from a non-general fund is used to fund positions. Because these

aforementioned appropriations did not include fringe benefits, a critical funding shortage exists, and additional funds must be appropriated to cover fringe benefit costs.

We recommend that the following dollar amounts be inserted into the bill:

1. In Section 3 of the S.D. 1 (page 2, line 12), \$2,480,509; and
2. In Section 4 of the S.D. 1 (page 2, line 20), \$4,673,616.

Additionally, a commensurate appropriation of interdepartmental transfer fund ceiling for DLE is necessary, to read as follows:

"SECTION 5. There is appropriated out of interdepartmental transfer funds the sum of \$7,154,125, or so much thereof as may be necessary in fiscal year 2024-2025 for personnel costs, including payroll and fringe benefits.

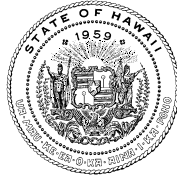
The sum appropriated shall be expended by the department of law enforcement."

We also recommend the addition of the required expenditure ceiling declaration to read as follows:

"SECTION 6. In accordance with section 9 of article VII of the Constitution of the State of Hawaii and sections 37-91 and 37-93, Hawaii Revised Statutes, the legislature has determined that the state general fund expenditure ceiling for fiscal year 2024-2025 has already been exceeded by \$8,551,795, or 1 per cent. The appropriations contained in this Act will cause the state general fund expenditure ceiling for fiscal year 2024-2025 to be further exceeded by \$7,154,125, or 1 per cent. This declaration takes into account the additional general fund appropriations authorized for fiscal year 2024-2025 in this Act only. The reasons for exceeding the general fund expenditure ceiling are that the appropriations made in this Act are necessary to serve the public interest and to meet the needs addressed by this Act."

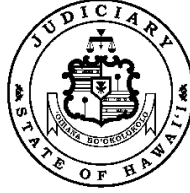

WRITTEN TESTIMONY

Bill No. and Title: Senate Bill 1364, S.D. 1, Making Emergency Appropriations for Law Enforcement Personnel Costs.

Purpose: Makes emergency appropriations to cover payroll and fringe benefit costs for law enforcement personnel of the Department of Law Enforcement for the Department of Accounting and General Services and for the Judiciary.

Judiciary's Position:

The Judiciary strongly supports this bill which seeks to appropriate general funds to cover payroll and fringe benefit costs for law enforcement personnel which were not covered by Section 3 of Act 164, Session Laws of Hawai'i 2023, as amended by Act 230, Session Laws of Hawai'i 2024; and Section 3 of Act 70, Session Laws of Hawai'i 2023, as amended by Act 233, Session Laws of Hawai'i 2024.

The Judiciary has conferred with the Department of Budget and Finance and is agreeable with receiving an appropriation for this purpose and transferring the appropriated amount to the Department of Law Enforcement for deputies who serve the Judiciary.

The Judiciary notes that there appears to be an error in Standing Committee Report Number 283, in which the Senate Committee on Public Safety states in pertinent part, "your Committee respectfully requests that it consider inserting an appropriation amount of \$2,480,509 for the Department of Accounting and General Services and \$4,673,616 for the Judiciary, and

\$7,154,125 for an interdepartmental transfer from the Judiciary to the Department of Law Enforcement.” (Emphasis added). The Judiciary believes that the emphasized portion of this Committee Report is in error, and that \$7,154,125 is the total amount for the measure. Based on calculations by the Department of Budget and Finance, the Judiciary understands that the amount to be appropriated to the Judiciary for transfer to the Department of Law Enforcement is \$4,673,616.
