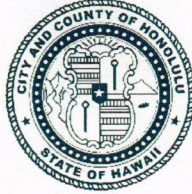



Comments:

Honorable Chair, Vice Chair, and Members of the Committee,

I respectfully oppose SB1382 because it undermines the foundational principle of equality before the law by creating arbitrary legal distinctions based on occupation. While the intention behind the bill may be to protect individuals in certain professions, such as National Guard members, emergency responders, and correctional officers, it risks elevating the value of their lives above those of other citizens. This creates an imbalance where individuals in certain roles are granted heightened protections, which undermines the fundamental tenet that all people should be treated equally under the law. I have great respect for those who choose to put on the uniform to serve our country, and I myself had the privilege of serving as a military officer for nearly 10 years. In defending our Constitution and the American way of life, I remain steadfast in my advocacy for equality and fairness, which are the cornerstones of our democracy.

The principle of equal protection under the law is a cornerstone of a just and free society. It asserts that no individual's life or rights are inherently more valuable than another's, regardless of their occupation or role in society. This bill, however, creates a hierarchy by granting special legal protections to certain groups based solely on their professional roles. By doing so, it implicitly suggests that the harm caused to a National Guard member, for example, is somehow more significant than harm caused to an ordinary citizen. This type of legal distinction fosters inequality and erodes the very foundation of fairness that ensures all individuals are treated impartially.

While supporters of this bill may argue that certain professions face unique risks that warrant special legal protections, we must be cautious not to create a system where some lives are considered more worthy of protection than others. The role of the National Guard, emergency medical workers, and others in this bill is important, but that does not justify their legal status being elevated above that of any other citizen. Treating people differently based on their occupation undermines the universal right to equal protection and sets a dangerous precedent for further division within the legal system.

The law must remain neutral and impartial, ensuring that all individuals—regardless of their job—receive the same level of protection and justice. Equal treatment under the law does not mean that every individual is treated identically in every instance, but rather that no one should be subjected to special legal privileges simply because of their role. The expansion of legal distinctions, especially in the context of National Guard members and other protected groups,

risks creating a system where some individuals enjoy more rights and protections than others, which is fundamentally unjust.

In conclusion, I urge you to reject this bill, as it undermines the principle of equality before the law. Enacting such a policy would set a harmful precedent, enabling further divisions within the legal system and eroding the rights of ordinary citizens. The state must prioritize fairness, treating all individuals equally and ensuring that no citizen's rights are subordinated to another's based on their occupation.
