Bill Title: SB 1391, SD1 RELATING TO EDUCATION.

Purpose of Bill: Appropriates funds to the Department of Education for teacher-requested classroom supplies. Effective 7/1/2050. (SD1)

Department's Position:

The Hawaii State Department of Education (Department) strongly supports SB1391 SD1.

Through an existing public-private partnership, the Department is able to provide teachers and students with financial resources to fund teacher-led projects for their classroom.

Through our public-private partnership, the Department is able to receive matching funds from individual donors, corporate partners, and foundation partners. Since 2007, 45,055 projects have been funded for 11,072 teachers. Of which, 21,208 projects have been funded for 8,035 teachers with Department funds. With the \$3,000,000 appropriation (and funds matched by donors), the Department estimates it may be able to fund 8,000 more projects next school year. The Department will have 13,000 teachers in the school year 2025-2026.

Funding to continue this program will support teachers with providing books, computers and tablets, art supplies, educational kits and games, lab equipment and other resources that they would not otherwise be able to purchase on their own.

Chair Dela Cruz, Vice Chair Moriwaki, and members of the committee,

The Hawai'i State Teachers Association stands in strong support of SB 1391 SD 1, which appropriates funds to the Department of Education for teacher-requested classroom supplies for fiscal years 2025-2026 and 2026-2027.

When adjusted for cost-of-living, Hawai'i's teachers are some of the lowest paid educators in the nation. However, our educators have hearts that are much larger than their paychecks, and regularly purchase items like art supplies, notebooks, and food for students with their own money. In fact, a January 2023 survey reported that HSTA members "spend an average of \$953 out of pocket a year on supplies."

DonorsChoose.org is an incredible resource for teachers to get the exact supplies they need, fast. Many teachers have shared their frustration with the Department of Education's purchasing process that often won't allow teachers to get the supplies they want most, without jumping through extensive bureaucracy. The "No Gatekeepers" model exemplified with DonorsChoose.org honors teachers as professionals who can be trusted to make their own classroom decisions.

We trust educators to know what their students need to thrive in our state's classrooms. Therefore, this bill is a step in the right direction to help teachers get needed classroom supplies. The Hawai'i State Teachers Association asks your committee to **support** this bill.



SENATE BILL 1391, SD1, RELATING TO EDUCATION

FEBRUARY 12, 2025 · WAM HEARING

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus <u>supports</u> SB 1391, SD1, relating to education, which appropriates funds to the Department of Education for teacher-requested classroom supplies.

According to the National School Supply and Equipment Association, public school teachers annually spend \$1.6 billion of their discretionary income on supplementary school supplies and instructional materials. On average, teachers surveyed spent a total of \$485 on school supplies and instructional materials, with more than 10 percent spending over \$1,000 of personal income each school year to educate their keiki. <u>Those figures have risen as inflation has gotten</u> worse. In September of 2024, our state's inflation rate was 4.2 percent, roughly 1.8 percent higher than the national inflation rate.

That trend is, if anything, worse in Hawai'i, which consistently ranks at the bottom in national teacher compensation studies. Pay cuts, rising health care costs, adjusted insurance co-pays, and the loss of the state's \$1,690-per-special-education-teacher classroom supply fund have all aggravated the financial burden borne by teachers' pocketbooks. In a recent survey conducted by HSTA, 47 percent of respondents cited personal expenditures between \$250 and \$500 each

year on classroom supplies, with many claiming expenditures in excess of \$1,000. Lawmakers must take action to lighten their financial load.

Ensuring that educators do not have to pay for their own classroom supplies effectively increases their purchasing power, puts money back into the local economy, and incentivizes the teaching profession at a time when our state's high cost- of-living and low adjusted-average income levels compel many would-be teachers to choose more highly compensated professions or, even worse, leave the state altogether. Today, approximately half of Hawai'i's teachers leave our state's classrooms every five years. Therefore, to recruit and retain quality teachers for our schools, we should provide fiscal incentives that offset the inflationary cost of classroom supplies that support the learning growth of our keiki.

My name is Jenny Anne Villanueva. I am a teacher at Wilcox Elementary School in Kauai School District on Kauai Island. I am submitting testimony in support of SB 973, which seeks to establish and fund salary differentials for teachers who provide direct services to English learners (ELs).

This is my first year teaching ELL at this school. They had to hire a second line due to the high number of ELL students at this school, and it is only increasing. There are only two people working together in the ELL department, and we are in charge of servicing the whole school. To ensure we are providing services to all 62 ELL students in the school, we must stretch ourselves to great lengths so we know each student is provided with the language support they need to succeed. Not only are we in charge of creating our own curriculum and teaching it for Grades K-5, but we are also filling the roles of other professions. For example, we are translators for families of multiple languages, we are advocates for families and students to get ample support and recognition, we are social workers constantly having to contact families (majority of students come from low-income households with unstable means of communication and transportation.) TESOL certified teachers are hard to find but are necessary for schools to provide the best support possible to their students.

This legislation is a necessary step toward addressing the shortage of qualified teachers and ensuring that our multilingual students receive the high-quality instruction and support they need to succeed academically.

These students face unique challenges in acquiring academic English while keeping pace with their peers. Research consistently shows that well-trained teachers play a crucial role in closing the achievement gap for these learners. However, the persistent shortage of qualified teachers has made it difficult to provide consistent, high-quality support.

By offering a pay differential, this bill will attract and retain skilled teachers in this essential field. Competitive compensation rewards the specialized training and expertise required to effectively support English learners and will lead to increased teacher retention and less turnover. Investing in our teachers directly benefits students, schools, and communities by promoting educational equity and improving long-term academic outcomes.

For these reasons, I urge the Legislature to pass this bill and fully fund the proposed pay differentials. Doing so will help ensure that Hawaii's multilingual learners receive the educational opportunities they deserve, while also strengthening the state's commitment to an inclusive and effective public education system.

My name is Katie Jacintho. I am a beginning teacher at Maui High School in the BKM complex area on Maui. I am submitting testimony in fervent support of SB 1391 which seeks to continue funding for teacher-requested classroom supplies through the Department of Education (DOE).

I could not do my job effectively without the help and support of Donor's Choose and the HIDOE partnerships. Last year, I was able to purchase fidget toys to help my students focus, along with books for our Shakespeare curriculum. In addition to these materials, I was also able to purchase supplies for classroom celebrations, and snacks for hungry students. None of these things would have been provided without the generous donations I received through Donor's Choose, and HIDOE's partnership with the company. In total, I received \$2,713 in funding. If I had provided these materials out of my own pocket, it would take saving 3 entire paychecks to do so.

This year, I increased my funding through Donor's Choose by securing funding for personalized Burn After Writing journals for each student, along with other materials for classroom success. These journals and class supplies have been invaluable to help boost student writing skills, and integrate important SEL benchmarks into the curriculum. In addition, just within the first semester, I also purchased snacks and microwavable food to help alleviate childhood hunger in my classroom. As of January, I also received funding for thank you letters we will write at the end of the school year. All of this totaled \$3,063, and I'm still submitting projects for review to complete our school year. All of these requests fall outside of my department budget money, and way outside the \$300 we've received at the beginning of the school year.

Without HIDOE's partnership with Donor's Choose, my students would not have pencils to write with. They would not have snacks throughout the day or have microwavable meals they can take home. They would have no paper to write with, they would have no tissues to blow their nose. They would have to share books for class reading and provide their own materials for all class projects. This—in a world where even teachers do not make a living wage, where our students are often working 2 jobs not for themselves, but so they can contribute to household finances. This—in a world where the 14th Amendment guarantees a right to free public education, but we've seen firsthand how that right is not always executed effectively. HIDOE's partnership with Donor's Choose allows my students to have full access to the content of my classroom so they can concentrate on the learning itself rather than worrying about how they will access the learning without their own pencils or paper, or even without the worry of their stomach growling from skipping meals.

HIDOE's partnership with Donor's Choose shows their commitment to each student in Hawaii's classrooms and their investment in our students' education. In addition, these partnerships help students meet their basic needs. I don't know many teachers who aren't using Donor's Choose to buy food for their students.

As a beginning teacher, I have a unique position to see what these partnerships do as well. Without the support of HIDOE and Donor's Choose, I would not be able to provide these things out of pocket. It is ridiculous that in a state where beginning teachers do not make a livable wage, we are expected to provide thousands of dollars out of pocket, just so our students have fair access to education. No teacher wants to leave their students with no materials and an empty belly, but the choice for most beginning teachers is paying our own rent and groceries, versus buying supplies for our students. It's an impossible choice in an industry where no one gets into it for the money, and we're all here because we love our students.

I implore you: please continue supporting this valuable funding by passing this bill. It will ensure that teachers have access to the resources they need to help foster an effective, highly engaging learning environment. In addition, and most importantly, this money has a direct impact on our students and their success. If we want to build a strong community, we must start from the ground up, and that starts in our classrooms, with our keiki.

Chair Dela Cruz and Members of the Committee,

Aloha. My name is Rabayah Akhter. I am a 3rd year Special Education teacher at Kealakehe schools in the HKKK school district in Kona on Hawai'i Island. I am submitting testimony in strong support of SB 1391 which seeks to continue funding for teacherrequested classroom supplies through the Department of Education (DOE). I'm deeply grateful for the classroom project supplies my students and I received through the HIDOE partnership with DonorsChoose, and I've witnessed the tremendous positive impact of this initiative.

Receiving funding for supplies from the DOE made me feel relieved and encouraged. It demonstrated the state's commitment to investing in new teachers, acknowledging the unique challenges we face in our first years, and providing the necessary support to help us succeed.

The funding allowed my students to have access to crucial items they otherwise would not have exposure to. Special education students are often looked at as a burden, even though they are capable of learning; they need different modalities to learn. That means we need to try and use different tools and see what works. When it works - WOW. You would be amazed and heartened to see a child learning who was dismissed as incapable of learning by previous adults; just because he or she was using specific grade-level materials for the average general education student and it wasn't working for them.

Just as important is the fact that these items help non-Special Education students as well. All students learn in their own way. Its not fair to them that we can't help them just because we aren't offering them the right tools to use to help them learn. We have so many English Language Learner students that our schools are clearly not prepared for. Items I purchased (such as special grooved workbooks for tracing letters, numbers, etc..) ended up being incredibly valuable to students who have such limited exposure to English that they barely feel competent in their classes. I honestly could not do my job well without this kind of funding. I get a new student with specific needs, I need to be able to order them something (like noise cancelling headphones for example) as soon as possible - I can't wait for POs. Often I buy things with my own money because I see a child every minute who needs something. Some things are too expensive for me to buy. Our classrooms aren't well built for as many students as we have. For example, we're in portable buildings that don't have adequate ventilation, so we have to open the windows but then its loud outside and the students can't concentrate. I needed to buy a divider so I could help those students with sensory issues have a small area where we could learn better. This is so basic; but that DonorsChoose money through DOE allows me to take care of those needs. My co-teacher bought umbrellas. Can you imagine what its like when there's a downpour in the middle of the day and we have 7 grades of students trying to walk to lunch on this hilly, outdoor campus? It might seem insigificant, but it changes the entire day and gives kids a better chance to learn when their minimum needs are taken care of.

I can barely think of all the things to write in this little box. The amount of funding this school gets is insufficient for what this community needs; but at the very least, this allows teachers flexibility to adapt to their students. It will be that much harder for the students without this funding.

I urge you to continue supporting this valuable funding by passing this bill, which will help ensure that teachers have the resources they need to create effective learning experiences for students.

Not only am I a new teacher but I am a military spouse. So often I have to start over in classrooms each time we move. It is hard not only creatively but financially as well. Each school I teach at I am servicing a different set of students with various needs. Here in Hawai'i I have been working as a Special Education teacher in a Fully Self Contained (FSC) classroom. Our classroom is composed of the students on campus who need the most support. Their abilities cover a wide range.

We often need breaks throughout the day to regulate ourselves. With the funds from the HIDOE partnership I have been able to update our sensory room with twinkling lights, a speaker for soothing music, a light table and other sensory items to provide students with ways to help regulate their processing needs.

I have also been able to stock my classroom with supplies needed for just basic projects that we complete throughout the year. Having simple things such as cardstock and construction paper help us prepare art projects for units of study. Highlighters make great writing support tools for students who need support in this area.

Flexible seating items such bouncing bands, cushioned floor seats and wobble cushions help give students opportunities to sit in different locations. These items also allow students to get the wiggles out of themselves but inside in the classroom during instruction without being disruptive.

I urge you to continue supporting this valuable funding by passing this bill, which will help ensure that teachers have the resources they need to create effective learning experiences for students.

This generous support allowed me to transform my room into the nurturing space my students deserved. A key element of this transformation was the creation of a calming corner, a safe haven where students can deescalate and find comfort. This area is equipped with age-appropriate seating, a variety of fidget toys, magnetic blocks, and sensory items. To further foster a sense of belonging and inspire my students, I also used the funds to purchase diversity posters, art supplies for engaging projects, and motivational stickers. This support was instrumental in building not just a classroom, but a true home away from home for my students, and I am deeply grateful for the impact it has had on their learning and well-being. I was certain that my students would not want to learn until they feel safe in their environment and I was able to do that with this special funding.
