Position: Support

This measure would appropriate funds to the Department of Health to expand access to emergency aeromedical services.

The ongoing critical physician shortage that is most severe on the neighbor islands as well as the overall aging of Hawaii's population have contributed to the increased use of emergency medical services in our state. When combined with the unique geographic and logistical challenges of air travel, the barriers for our Hawaii patients to receive timely medical care, particularly in our rural and underserved areas, are considerable. Expansion of emergency aeromedical medical services as based on the Maui medevac model will allow more patients to receive prompt quality medical care that they urgently need and reduce the stressful and costly burdens of air travel placed upon them and their loved ones.

HMA supports this measure that will improve emergency healthcare access for the rural and underserved communities of Hawaii.

Comments:

I have been a physician in the emergency room at Maui Memorial Medical center for over 20 years so I am very aware of the challenges we face here when it comes to transferring patients to Honolulu. I think it would be beneficial for the state to audit the necessity of many of the transfers. This would provide valuable insight into the services required on the neighbor islands to keep patients near their homes and families. Instead of allocating more funds to transferring patients, I believe spending those monies on expanding services would make more sense. Maui Memorial Medical Center transferred 8 adolescent behavioral health patients in January of this year alone via air ambulance. This puts tremendous strain on the transport service and can adversely affect those needing life saving, time sensitive care. Funding inpatient mental health for adolescents in this case might make more sense.

I am writing in support of SB 1426. I work as a paramedic on Lanai. I have firsthand experience of the issues this bill will reduce. We have sick patients needing to fly out that are waiting up to 10 hours or more to fly out to a higher level of care. Since Hawaii Life Flight is stretched out even our 911 Medevac helicopter is doing interfacility transfers. This means we are now getting delays on the 911 helicopter for critical scene calls. Since the Hawaii Life crash in 2022, the Aeromedical services in Hawaii have not fully rebounded. Delays have been increasing and people are suffering because of it. Please pass this bill.

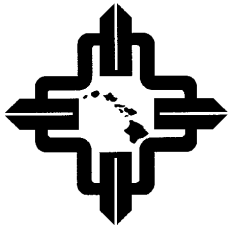

i certainly support this effort to increase the funding for the aeromedical services. i am presently a paramedic (35 year tenure) serving Hana, maui and have on numerous occasions have been without aeromedical service due to lack of availability. yes, flight support can be limited due to weather, maintenance. that is true for any system. however, when it is due to lack aircraft availability due to call volume (Maui county's aircraft is busy) or due to personnel (pilot or medic downtime), people suffer and increases the chance of permanent damage or death. If you couple this with a rural clinic whose medical/trauma resources are limited, this invariably results in poor patient outcome for the people you represent and have a duty to take care of.

With this necessary funding, please help up bring this necessary service to proper and optimum health and health care standards.

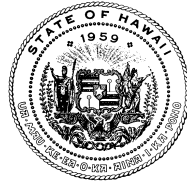
