Department Testimony: The Department of Health (DOH) strongly supports SB1424, which is
part of Governor Green's Administrative Package, to clarify that the scope of services authorized
to be provided under a home care agency (HCA) license does not include services that otherwise
require a license pursuant to chapter 457, Hawaii Revised Statutes (HRS).

6 This bill is needed to clarify that the Department may take enforcement action against HCAs that 7 provide services outside of the scope of their license. Some operators of HCAs provide skilled 8 nursing services to clients that are not rendered by a nurse licensed pursuant to chapter 457, 9 HRS. Because the State Board of Nursing may not have the authority to regulate unlicensed 10 providers of nursing care employed by HCAs, providing the Department with the authority to 11 ensure appropriate services are provided will more effectively protect patient safety.
