### Re: S.B. 1503 SD1 RELATING TO WORFORCE DEVELOPMENT

#### I. OVERVIEW OF PROPOSED LEGISLATION

The DLIR supports the intent of this measure, provided it does not conflict with the priorities outlined in the Governor's Executive Budget request and offers the following comments. Currently, there is uncertainty regarding whether the federal administration's efforts to reduce the budget and size of the federal government will lead to a reduction in defense-related funding in Hawaii, outside of the Department of Defense (DoD) budget.

SB1503 SD1 requires the DLIR to develop and implement training programs, public-private partnerships, funding opportunities, and recruitment strategies to develop a local workforce to meet the growing demand in defense-related personnel and promote economic diversification.

#### II. CURRENT LAW

Act 251, SLH 1969, established Chapter 394 and was enacted to support the training needs of the State's economy by "increasing trained local labor." Act 251 envisioned the DLIR assisting Hawaii's workforce to obtain suitable employment by supporting training needs and thereby supporting Hawaii's economy.

The federal Workforce Innovation and Opportunity Act (WIOA) includes a major focus on providing work experience or internships for youth in a planned, structured, time-limited learning experience that takes place in a workplace within the private or public sector (20 CFR § 680.180).

20 CFR Part 680 Subpart F—Work-Based Training outlines the requirements of On-the-Job training (OJT), which includes a contractual arrangement for the provision of occupational training between a sponsor and an employer wherein the sponsor provides reimbursement "for the extraordinary costs of providing the training and supervision related to the training."

#### III. COMMENTS ON THE SENATE BILL

While the DLIR supports the intent of this measure, the department notes that, although increases for defense-related personnel and other aspects of the DoD budget have been consistent, there is uncertainty regarding whether the current federal administration's efforts to reduce the budget and size of the federal government will lead to a reduction in defense-related funding in Hawaii.
