The Department of Law Enforcement (DLE) supports Senate Bill 1526, Senate Draft 2, House Draft 1. Honorable Chair Dela Cruz, Vice-Chair Morimaki and Members of the Committee on Ways and Means. The County of Hawai'i, Office of the Prosecuting Attorney submits the following testimony in support of Senate Bill No. 1526 SD2 HD1.

This bill was drafted with the intent to extend the lapse date for funds appropriated out of the Drug and Alcohol Toxicology Testing Laboratory Special Fund for fiscal years 2023-2024 and 2024-2025 for the establishment and maintenance of a drug and alcohol toxicology testing laboratory.

At present, blood and urine samples in certain DUI cases are tested by laboratories situated outside of Hawaii. When these test results are used in court cases, the expenses can quickly escalate, as the prosecution is often forced to issue subpoenas to experts and lab staff to testify. This becomes especially costly when the required witnesses are from out-of-state laboratories, as it involves not only their fees but also travel and accommodation arrangements. Additionally, there are situations that Non-Hawai'i witnesses may encounter travel disruptions, such as canceled flights or inclement weather, which could prevent them from attending hearings and further delay the legal process. This situation adds a considerable financial and logistical burden to DUI cases, making the entire process more expensive and complicated.

The County of Hawai'i, Office of the Prosecuting Attorney remains committed to pursuing justice with integrity and commitment. For the foregoing reasons, the County of Hawai'i, Office of the Prosecuting Attorney supports the passage of Senate Bill No. 1526 SD2 HD1. Thank you for the opportunity to testify on this matter. The Department of the Prosecuting Attorney, County of Maui respectfully submits the following comments in support of S.B. 1526 SD2 HD1, Relating to The Drug and Alcohol Testing Laboratory. This bill extends the lapse date for funds appropriated for the establishment and maintenance of a drug and alcohol toxicology testing laboratory.

The Department of the Prosecuting Attorney, County of Maui supports this bill because current testing of blood and urine samples in some DUI cases is performed by laboratories located outside of Hawaii. Court cases involving these test results can become extremely costly when the prosecution is required to subpoena experts and lab personnel to testify in court, especially if these witnesses are from laboratories located out of state and require travel and lodging arrangements. Non-Hawai`i witnesses also run the risk of flights being canceled and weather disturbances preventing travel to hearings.

Dear Chair Yamashita, Vice Chair Takenouchi, and Committee Members,

The Oahu Metropolitan Planning Organization (OahuMPO) **supports SB1526 SD2 HD1** which extends the lapse date for funds appropriated out of the Drug and Alcohol Toxicology Testing Laboratory Special Fund for fiscal years 2023-2024 and 2024-2025 for the establishment and maintenance of a drug and alcohol toxicology testing laboratory.

Data produced by the Fatality Analysis Reporting System (FARS) indicates that between 2016-2020, nearly one-third of all traffic deaths in Hawaii involved alcohol; an alarming statistic exceeding the national average. This bill would help us achieve our goal of reducing traffic deaths and serious injuries to zero, as outlined in our 2050 long-range plan, specifically related to our objective of reducing dangerous driving behaviors.

Allowing more time to establish an in-state drug and alcohol toxicology testing laboratory, including hiring necessary personnel, procuring equipment, developing Standard Operating Procedures, and attaining necessary accreditations and certifications will assist in provide law enforcement and adjudicators with the resources they need to protect our public from impaired drivers.

The OahuMPO is the federally designated Metropolitan Planning Organization (MPO) on the island of Oahu responsible for carrying out a multimodal transportation planning process, including the development of a long-range (25-year horizon) metropolitan transportation plan, referred to as the Oahu Regional Transportation Plan (ORTP), which encourages and promotes a safe, efficient, and resilient transportation system that serves the mobility needs of all people and freight (including walkways, bicycles, and transit), fosters economic growth and development, while minimizing fuel consumption and air pollution (<u>23 CFR 450.300</u>).
