



More time is needed to establish an in-state drug and alcohol toxicology testing laboratory, which includes hiring personnel; procuring instruments; developing Standard Operating Procedures, methodologies, etc.; and attaining accreditations and certifications.

HDOT is primarily concerned about improving highway safety and protecting the lives of our community members and visitors. Chair Kila, Vice Chair Grandinetti, and members of the Committee:

The Department of Law Enforcement (DLE) supports Senate Bill 1526, Senate Draft 2, which extends the lapse date for funds appropriated out of the Drug and Alcohol Toxicology Testing Laboratory Special Fund for fiscal years 2023-2024 and 2024-2025 from June 30, 2025 to June 30, 2028.

The bill extends the timeline for establishing and maintaining a state drug and alcohol toxicology testing laboratory, which is a critical component of law enforcement infrastructure across the state. This three-year extension will provide the necessary time to complete the building, equipping, and establishment of this essential facility.

A centralized toxicology testing laboratory operated at the state level will significantly enhance the DLE's investigative capabilities by ensuring consistent, timely, and accurate toxicology testing across all counties. Currently, inconsistencies in testing methods, processing times, and availability of services between jurisdictions create challenges for law enforcement operations, criminal prosecutions, and public safety

efforts.

The establishment of this laboratory will particularly strengthen our ability to detect and analyze dangerous substances such as fentanyl, xylazine, and other emerging drug threats that pose significant public safety risks. Our experience with these substances has shown that accurate and rapid toxicology testing is vital for both investigative purposes and for preventing fatal overdoses.

The DLE recognizes that building such a specialized facility requires significant planning, coordination with multiple agencies, procurement of advanced equipment, hiring of qualified personnel, and establishment of administrative frameworks that meet rigorous scientific standards. The extension of the funding lapse date is therefore prudent and necessary to ensure the successful implementation of this important project.

Chair Kila, Vice Chair Grandinetti, and Members of the Committee:

The Department of the Prosecuting Attorney, County of Maui respectfully submits the following comments **in support of S.B. 1526 SD2, Relating to The Drug and Alcohol Testing Laboratory**. This bill extends the lapse date for funds appropriated for the establishment and maintenance of a drug and alcohol toxicology testing laboratory.

The Department of the Prosecuting Attorney, County of Maui supports this bill because current testing of blood and urine samples in some DUI cases is performed by laboratories located outside of Hawaii. Court cases involving these test results can become extremely costly when the prosecution is required to subpoena experts and lab personnel to testify in court, especially if these witnesses are from laboratories located out of state and require travel and lodging arrangements. Non-Hawai'i witnesses also run the risk of flights being canceled and weather disturbances preventing travel to hearings.

**Relating to the Drug and Alcohol Toxicology Testing Laboratory**

Dear Chair Kila, Vice Chair Grandinetti, and Committee Members,

The Oahu Metropolitan Planning Organization (OahuMPO) **supports SB1526 SD2** which extends the lapse date for funds appropriated out of the Drug and Alcohol Toxicology Testing Laboratory Special Fund for fiscal years 2023-2024 and 2024-2025 for the establishment and maintenance of a drug and alcohol toxicology testing laboratory.

Data produced by the Fatality Analysis Reporting System (FARS) indicates that between 2016-2020, nearly one-third of all traffic deaths in Hawaii involved alcohol; an alarming statistic exceeding the national average. This bill would help us achieve our goal of reducing traffic deaths and serious injuries to zero, as outlined in our 2050 long-range plan, specifically related to our objective of reducing dangerous driving behaviors.

Allowing more time to establish an in-state drug and alcohol toxicology testing laboratory, including hiring necessary personnel, procuring equipment, developing Standard Operating Procedures, and attaining necessary accreditations and certifications will assist in provide law enforcement and adjudicators with the resources they need to protect our public from impaired drivers.

The OahuMPO is the federally designated Metropolitan Planning Organization (MPO) on the island of Oahu responsible for carrying out a multimodal transportation planning process, including the development of a long-range (25-year horizon) metropolitan transportation plan, referred to as the Oahu Regional Transportation Plan (ORTP), which encourages and promotes a safe, efficient, and resilient transportation system that serves the mobility needs of all people and freight (including walkways, bicycles, and transit), fosters economic growth and development, while minimizing fuel consumption and air pollution ([23 CFR 450.300](#)).
