Chair Yamashita, Vice Chair Takenouchi and members of the Committee.

The Stadium Authority provides the following comments regarding Senate Bill 1589, SD3, HD1 which adds language to HRS Chapter 109 restricting private donations to be used on stadium infrastructure and stadium development costs and lapses all funds in the stadium development special fund to the general fund if the New Aloha Stadium Entertainment District (NASED) project is terminated. This bill also appropriates \$49.5M in budget ceiling for Fiscal Year 2025-2026.

Act 248, Session Laws of Hawaii 2022, appropriated \$350 million of general obligation bond funding for the Capital Improvement Program (CIP) and \$49.5 million of general funds for the NASED project. While the general obligation bond funds are blanket-encumbered and will fund the stadium development and operations agreement and master development agreement for the NASED project, the \$49.5 million in general

funds has been deposited in the Stadium Development Special Fund and has been reserved for project consultant fees, construction management services and contingency costs for the project. The Stadium Authority supports the proposed increased Stadium Development Special Fund ceiling to contract these expenditures.

Comments:

Dear Chair Yamashita, Vice Chair Takenouchi, and Committee Members:

Stanford Carr Development (SCD) **supports** SB 1589, SD3, HD1, which proposes to limit gifts or grants from private sector sources deposited into the Stadium Development Special Fund (SDSF) to be used only for infrastructure and costs associated with the development of the stadium. The bill appropriates funds and proposes to lapse all funds in the SDSF if the New Aloha Stadium Entertainment District (NASED) is terminated.

We are pleased with the continued support for the NASED, which aligns with legislative actions since 2019. Act 268 (SLH 2019) initiated funding and redevelopment efforts for Aloha Stadium, recognizing the site's economic and cultural significance. Act 4 (SLH 2020) subsequently adjusted the funding mechanism while reaffirming commitment to redevelopment, and Act 146 (SLH 2021) reinforced that commitment by expanding community participation and establishing a dedicated special fund for the project.

Over the past four years, the Stadium Authority, SCD, and numerous stakeholders have invested substantial resources—both time and financial capital—into assembling a team of industry experts, developing conceptual plans, and formulating a financially sustainable business strategy. To date, millions have been allocated toward planning, environmental impact studies, and preliminary designs. Additionally, economic projections indicate that the NASED project could generate over \$1.5 billion in direct and indirect economic activity, creating an estimated 12,000 construction jobs and 3,000 permanent jobs post-completion.

Community engagement remains a cornerstone of this initiative. Our team has actively collaborated with neighborhood boards, community associations, and legislative leaders to ensure the redevelopment remains aligned with the vision set forth in Act 268, SLH 2019:

"To redevelop, renovate, or improve the parcel in a manner that will provide suitable recreational, residential, educational, and commercial areas—where the public can live, congregate, recreate, attend schools, and shop—as part of a thoughtfully integrated experience."

Providing funding flexibility will allow the State and the development team to maintain momentum and preserve existing resources to create a vibrant entertainment complex integrated with livable residential neighborhoods. This flexibility ensures that essential infrastructure, including roads, utilities, and public spaces, can be developed in tandem with the stadium, maximizing the long-term economic and social benefits for the region.
