Chairs Elefante and McKelvey, Vice Chairs Wakai and Gabbard, and Members of both Committees:

The Department of Corrections and Rehabilitation (DCR) supports the intent of House Bill (HB) 358, which seeks to require all public buildings, including public school buildings, constructed after January 1, 2026, to be designed to withstand category five hurricanes and be used as shelters in the event of an emergency.

Under DCR are eight (8) correctional institutions throughout the state that house justice involved individuals. We are currently in the planning phase for proposed relocations of the Oahu Community Correctional Center (OCCC), the Kauai Community Correctional Center (KCCC), and the Maui Community Correctional Center (MCCC). We support that design of these correctional facilities must withstand Category five hurricanes, however, because we are responsible for the care and custody of justice involved individuals, our capacity to provide shelter for others is very limited.

Bill Title: SB 0239 RELATING TO DISASTER PREPAREDNESS.

Purpose of Bill: Requires all public buildings, including public school buildings, constructed after

January 1, 2026, to be designed to withstand category five hurricanes and be

used as shelters in the event of an emergency.

Department's Position:

The Hawaii State Department of Education (Department) is providing comments on SB 239.

The Department agrees that Hawaii is vulnerable to natural disasters and more shelters are needed; however, the proposed bill to require all public buildings to be constructed to withstand Category 5 hurricanes and to be used as shelters should consider the feasibility of this measure.

The current Hawaii State Building Code includes life safety design criteria for enhanced hurricane protection areas (EHPA) in high occupancy state- and county-owned buildings occupied during hurricanes of up to Category 3. High occupancy is defined as 300 or more occupants. To meet EHPA design requirements to withstand a Category 3 hurricane restrooms are required to be accessible from the interior, the facility must withstand projectiles, emergency generator power must be provided, a higher level of structural integrity is factored in, and other design considerations have to be met. The Department would have to overhaul the design requirements for school facilities and greatly increase the cost to design and construct any school building to withstand a higher Category 5 hurricane. In addition, the current Hawaii State Building Code does not include requirements for a building that can withstand a Category 5 hurricane in Appendix U, Hawaii Hurricane Sheltering Provisions for New Construction, Section 430 State- and County-Owned Public High Occupancy Buildings - Design Criteria for Enhanced Hurricane Protection Areas.

The Department would also request greater specificity on the type of public facilities impacted. For

example, covered play court structures are not fully enclosed so it would not be a desirable shelter during a hurricane but would still be required to meet the requirements under the proposed bill.

The Department of the Attorney General provides the following comments on this bill.

This bill would require all **public** buildings constructed after January 1, 2026, to be designed to withstand Category Five hurricanes and serve as shelters in the event of an emergency. This bill amends section 107-27, Hawaii Revised Statutes (HRS), which requires the design and construction of all State of Hawaii owned and operated buildings to be in compliance with the Hawaii State Building Codes.

The Use of the Term "Public Buildings"

The bill proposes to change the title of section 107-27, HRS, from "Design of state buildings" to "Design of **public** buildings." Page 3, line 10. However, the term "**public** building" is neither used nor defined in part II, chapter 107, HRS, creating potential confusion. This ambiguity raises questions about whether the specified design requirements would apply to buildings owned and operated by the federal government, which fall outside the State's jurisdiction. Additionally, the buildings owned and operated by the various counties could be included in this term. However, section 107-28, HRS, authorizes counties to adopt their own version of the building codes, making the applicability of this requirement unclear.

Ambiguity in Implementation Date

The proposed section 107-27(d) provides that the new requirements would apply to "all public buildings . . . constructed after January 1, 2026[.]" It is unclear whether this date applies to the groundbreaking or completion of a construction project.

Construction projects often take months before completion and it would be difficult, if not impossible, to predict whether a particular construction project would be completed before January 1, 2026 (not required to meet the new requirements), or after January 1, 2026 (required to meet the requirements). Moreover, design work for construction projects is often drafted months in advance of the actual groundbreaking date, particularly for projects that are large enough to be used as emergency shelters.

Based upon the above, we suggest that all references in this bill to "**public** buildings" be changed to "**state** buildings." We also recommend amending the proposed section 107-27(d), HRS, to specify that the new requirements apply to projects whose design work commences on or after January 1, 2026, rather than the ambiguous "constructed after" date.

We respectfully ask the Committees to consider these recommended amendments. Thank you for the opportunity to testify.

Chairs Elefante and McKelvey, Vice Chairs Wakai and Gabbard, and Members of the Committees, thank you for the opportunity to submit testimony on S.B. 239.

The Department of Accounting and General Services (DAGS) offers

comments on this measure, which requires all public buildings, including public school buildings, constructed after January 1, 2026, to be designed to withstand category five hurricanes and be used as shelters in the event of an emergency.

We note that public buildings currently under design will be constructed using funds appropriated in prior years. Those projects in design may not have been appropriated sufficient funds to satisfy the structural requirements for category five hurricane resistance and will require appropriation of additional design and construction

funds to satisfy the related design criteria.

In addition, there are some types of public buildings for which the cost of designing and constructing to category five hurricane resistance requirements may not be appropriate (such as small storage facilities, vehicle carports, and similar incidental facilities) as those buildings are not intended to be used as emergency shelters.

Therefore, the department suggests that the measure be amended to require that all public buildings intended to serve as shelters during and after a category five hurricane for which construction is anticipated to commence on or after July 1, 2026, shall be designed and constructed to withstand category five hurricanes and be used as shelters in the event of an emergency. The change in date is intended to provide the responsible agencies with the opportunity to request any additional required funding during the 2026 legislative session.

Thank you for the opportunity to submit a testimony to **SUPPORT** Senate Bill 239 – with comments.

The Hawai'i Emergency Management Agency endorses any and all initiatives aimed at strengthening public buildings, particularly in our efforts to improve the state's preparedness against hurricane winds. HIEMA's mitigation projects reflect our commitment to making concerted efforts and proactive investments in the safety and resilience of our communities.

To comment on page 4, line 16 (d) of SB 239 - while the use of public schools as emergency shelters can provide immediate assistance during crises, there are several reasons why this may not always be the best option. Public schools are primarily designed for educational purposes, not as shelters. There may be concerns about the safety and security of students, staff, and shelter occupants, particularly in terms of overcrowding and potential conflicts among individuals sheltering together.

Dudley's revised testimony SB239

SB239

Aloha, Chair Elefante and Chair McElvey and Members,

I am Dr. Kioni Dudley.

We have only known for a few years that with warming seas, the spawning area for hurricanes over by Mexico has moved northward. And now Hawaii is directly in the path of hurricanes crossing the Pacific.

The Oahu Dept. of Emergency Management tells us they have only 38 places of refuge ad they will only hold 100,000 people. But they expect that 200,000 will need places to go. That means 100,000 people will be left outside, with no place to go. But that's not the worst news. Those 38 places will only stand up if a Category 1 or possibly 2 hits. They won't stand in a Cat 3, 4, or 5. In a Cat 3, 4, or 5, there will be nowhere for anybody to go. And with warmer seas we are having more and more of these strong hurricanes. Category 5s will be coming. Keep in mind that Hurricane Iniki had 227 mph winds, among the strongest in history.

Where will you go? Where will your family go?

This bill would require that all new schools and public buildings be built to withstand Category 5 hurricanes.

Some good points have been made in the testimony of others. It is true that prisons are public buildings. And there are buildings on the school campus that are inappropriate for shelters. So, in Section II, (d) which begins with "All public buildings, including public school buildings," I would add "that can reasonably be used as hurricane shelters."

The point has been made that buildings which receive appropriations in this session will be caught without enough funding, so I would cross out "constructed after January 1, 2026," and add, "and for which appropriations are made in the 2026 legislative and county council sessions and in the years following.

And I think we need to be more specific about the wind speeds -- and access to bathrooms. To the words "designed to withstand category 5 hurricanes," I would add "with winds of 200 mph, and have interior passages to bathrooms."

Section II (d) would then read: "All public buildings, including public school buildings, that can reasonably be used as hurricane shelters, and for which appropriations are made in the 2026 legislative and county council sessions and in the years following, constructed after January 1, 2026 shall be designed to withstand category five hurricanes with winds of 200 mph, and to have interior passages to bathrooms, and so that they can be used as shelters in the event of an emergency.
