Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 245, Proposed Senate Draft 1 that seeks to prohibit certain entities from acquiring or holding any interest in agricultural land within the State and engaging in farming operations in the State. The Department of Agriculture (Department) offers the following comments.

The Department shares the concerns expressed by the Hawaii Farm Bureau Federation and the Agribusiness Development Corporation that the effect of this measure does not inadvertently preclude otherwise legitimate investment in Hawaii's agricultural lands for agricultural production.

The measure assigns DOA the responsibility of receiving an annual report from exempt entities that must demonstrate continued compliance with the proposed requirements. SD1 also assigns DOA the responsibility of enforcing compliance and imposing penalties in the form of fines of not less than \$50,000 and divestiture of agricultural land and farming operations by prohibited entities who choose not to meet the exemption criteria within a period of five years. SD1 does not address the need for a special fund, the authorization to hire personnel to carry out the regulatory responsibilities, the appropriations necessary to establish and maintain the regulatory function, and the authorization for rulemaking.

Otherwise, the Department supports all bona fide agricultural operations and looks to both the landowners and legislators at the State and county levels to seek ways to support access to agricultural lands with improvements necessary to support agricultural production.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau provides comments SB 245, Proposed SD1, which prohibits certain entities from acquiring or holding agricultural land and engaging in farming operations in the State.

While we share the legislature's commitment to preserving agricultural lands for farming and food security, we have significant concerns regarding the potential unintended consequences of this measure.

HFB has long supported policies that protect agricultural lands from urbanization and speculative uses. However, restricting certain entities from owning, leasing, or engaging in farming operations may have far-reaching impacts on agricultural investment, infrastructure development, and operational sustainability. Many farming operations rely on partnerships, cooperatives, and structured investments to access capital, share resources, and scale their operations. By expanding restrictions beyond ownership to include farming operations, this bill may discourage legitimate agricultural investment, preventing necessary infrastructure improvements and farm expansion.

Agricultural cooperatives often operate as corporations or partnerships to provide shared resources, marketing, and distribution for local farmers. The restrictions outlined in this bill may unintentionally prevent these cooperatives from acquiring land or participating in farming operations, despite their role in supporting Hawai'i's agricultural community.

The bill exempts nonprofit organizations (501c3) and entities majority-owned by Hawai'i residents, but it is unclear how these exemptions will be applied or verified. Further clarity

is needed on whether corporate-owned family farms or investment-backed agricultural ventures will qualify under the exemptions. The requirement that exempt entities submit annual compliance reports adds an administrative burden, which could be challenging for small-scale farms.

Many farmers in Hawai'i lease farmland from trusts, corporations, and partnerships. Restricting these entities from holding agricultural land could reduce the availability of farmland for lease, making it harder for farmers to access land without outright ownership. Additionally, the requirement that prohibited entities divest their land within five years could disrupt existing lease agreements, potentially displacing farmers who rely on long-term leases to sustain their operations.

By prohibiting certain entities from acquiring and holding agricultural land, this measure could limit the pool of available farmland, further exacerbating the challenge of securing affordable and accessible farmland for farmers. The proposed five-year timeline for compliance and mandatory divestiture may not provide sufficient time for businesses and agricultural entities to restructure their operations. Forcing divestiture could disrupt active farming operations, leading to unintended economic and agricultural consequences. The proposed fine of at least \$50,000 per year for non-compliance could pose a significant financial burden, especially for agricultural businesses that may need time to transition under the new restrictions.

HFB supports efforts to preserve Hawai'i's agricultural lands for food security, local food production, and long-term agricultural sustainability. However, we urge the committee to consider the potential negative impacts of this bill and provide greater flexibility in its application. Specifically, we recommend:

- Clarifying and refining exemptions for legitimate agricultural entities, such as cooperatives, investment-backed farming ventures, and agricultural partnerships that directly support local farmers.
- Ensuring that land leasing arrangements remain viable so that farmers who do not own land but lease from restricted entities are not adversely affected.
- Reevaluating the five-year mandatory divestiture requirement to allow for a more gradual transition that avoids disruption to active farms.
- Reviewing the proposed fines and penalties to ensure they are fair, reasonable, and do not place an excessive burden on legitimate farming operations.

HAPA supports SB245. There is increasing concern about the ownership of large amounts of Hawaii's agricultural lands by foreign corporations. This creates an increasingly uneven playing field for local producers who are struggling to gain access to affordable lands. For Hawaii to move towards increased food security, the state should prioritize access for local producers, and Native Hawaiian practitioners with lineal ties to place.

This issue is of particular importance on Maui, where the Canadian Pension Fund. Public Sector Pension Investment Board (PSP) is the island's largest private landowner through Mahi Pono-- and is now seeking to control East Maui water leases.

For clarification, Mahi Pono Holdings, LLC's sole member is Canadian pension fund PSP, both of which are registered as foreign entities in Hawai'i. PSP is a Crown Corporation with \$265 billion in assets that invests the pension funds of the Canadian Forces, the Royal Canadian Mounted Police, the federal public service, and the Reserve Force.

Many of those workers are represented by the Public Service Alliance of Canada (PSAC) union, which has more than 200,000 members. James Infantino, the National Pension Officer for PSAC, spoke at the September 2024 East Maui Water Authority meeting and gave a very clear message to Water Authority members and the community: "Don't let PSP investments anywhere near this long-term lease."

The basis for his message was PSP Investment's well-known record of international water grabs exploitation of water resources and local communities, which PSAC – representing PSP beneficiaries – does not support.

This is just one example of why we need to ensure that Hawai'i's lands are protected from foreign interests. Twenty five states already have enacted restrictions on foreign ownership of agricultural lands. Please support SB245. Thank you for your consideration.

The Hawai'i Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFU supports the intent and provides comments on SB245.**

HFU previously supported SB 245 to address speculative landholding and corporate market consolidation while ensuring that Hawai'i's agricultural land remains accessible to local farmers. Our original testimony recommended targeted exemptions, enforcement provisions, and a transition period to ensure the bill would effectively protect family farms and agricultural sustainability.

However, SB 245 SD 1 expands the bill's scope beyond its original intent, introducing new concerns that must be addressed to avoid unintended impacts to Hawai'i's farmers.

The Bill Title Requires a Focus on Land Ownership, Not Farming Bans

The title of this bill—"RELATING TO OWNERSHIP OF AGRICULTURAL LAND" —establishes a clear legislative intent to regulate who owns agricultural land, not who is permitted to farm on it. However, SD1 expands restrictions beyond land ownership to include farming operations, introducing prohibitions that go beyond the bill's scope.

Background on Corporate Farming & Land Ownership Laws

Several states regulate or restrict certain corporate ownership interests in agricultural land. Corporate farming laws—such as those in Iowa, Minnesota, Missouri, North Dakota, Oklahoma, South Dakota, and Wisconsin—prevent corporate consolidation in agriculture to protect family farms. These laws typically:

- Prohibit non-family corporate entities from owning agricultural land unless they meet specific exemptions.
- Allow exemptions for family farm corporations, cooperatives, and banks holding farmland for debt collection.
- Withstand legal challenges when properly structured.

At the same time, courts have struck down corporate farming laws that violate the U.S. Constitution's dormant Commerce Clause. Laws must be carefully crafted to avoid discriminating against out-of-state entities while still protecting local farmers.

Hawai'i has the opportunity to adopt best practices from other states while ensuring that locally owned and operated agricultural entities remain viable.

Recommended Modifications to SB245 SD1

Restore the Bill's Focus on Land Ownership Restrictions

Remove the prohibition on certain entities engaging in farming operations, and instead

focus on land ownership to prevent market consolidation without harming legitimate farming models. The original bill focused on restricting land ownership by certain entities to prevent market consolidations. SD1 now prohibits certain entities from engaging in farming operations altogether, a shift that could impact farmer cooperatives, family farm corporations, and joint ventures that rely on shared resources to survive.

HFU's testimony on the original bill specifically recommended tailored exemptions for cooperative models, recognizing that the issue is not the legal structure itself. SD1 does not clarify how cooperatives, family farm corporations, and joint ventures will be treated, potentially making it harder for local farmers to form collaborative entities for land access and shared farming operations.

Clarify & Strengthen Exemptions for Local Farming Entities

States with successful corporate farming laws (e.g., Minnesota, Missouri) include clear exemptions for family farm corporations, cooperative associations, and certain trusts to ensure local farmers are not inadvertently restricted. SD1 should thus:

- Explicitly exempt agricultural cooperatives and family farm corporations where a majority of ownership and control is held by Hawai'i residents actively engaged in farming.
- Clarify that exemptions apply to locally controlled farming entities, regardless of their legal structure (LLC, partnership, corporation, etc.), as long as their primary purpose is farming.

Remove Unnecessary Registration Requirements for Exempt Entities

The original bill targeted land ownership, but SD 1 now requires annual compliance reports for all exempt farms, effectively creating a statewide farm registration system. Instead of requiring all exempt entities to register annually, limit reporting requirements to "prohibited entities".

HFU supports transparency in agricultural land ownership, but Hawai'i does not currently have a farm registration program—and SD 1 introduces one without deliberation. Farm registrations programs have been used successfully elsewhere (e.g., Nevada, Vermont, Guam) to support conservation and local food procurement. If a farm registration system is needed Hawai'i should implement such a program through a deliberate, farmer-driven process—not as an unintended consequence of SD1.

Revising SB245 SD1 to align with its original title and intent—focusing on ownership restrictions rather than farming bans—and to adopt these amendments to ensure SB245 SD1 effectively supports Hawai'i's farmers while addressing the issue of speculative land ownership and outsized market power.

Dear Members of the Hawaii State Legislature,

I am writing to underscore the urgent need for and support of Senate Bill No. 245 concerning the ownership and sustainable management of agricultural land in Hawaii. Below, I provide an indepth analysis, incorporating recent statistics and data, to argue for the bill's passage with proposed enhancements.

Support Points with Data:

- Preservation of Local Agriculture:
 - Hawaii imports approximately 85-90% of its food, underscoring the necessity for robust local agriculture (Source: NIFA Growing Hawaii's New Farmers).
 - The 2022 USDA Census reports over 7,300 farm operations in Hawaii, but there's been a decline, with more than 700 farms lost since 2017 (Source: Honolulu Civil Beat).
- Mitigation of Land Speculation:
 - In 2020, only 8% of land zoned for agriculture in Hawaii was actively used for crop cultivation, highlighting potential speculative holding rather than active farming (Source: Civil Beat - Hawaii Has A Lot Of Agricultural Land).
 - The state has seen a significant drop in agricultural land use, from 1.1 million acres in 1980 to about 350,830 acres by 2015, largely due to the end of the plantation era (Source: HDOA Agricultural Land Use Study).
- Promotion of Sustainable Practices:

• The University of Hawaii's GoFarm Hawaii program has trained numerous farmers, emphasizing sustainable and indigenous agricultural practices, with over 40 graduates starting commercial farming (Source: NIFA).

Areas for Improvement:

- Narrow Exemption Criteria:
 - Current criteria for exempt entities might exclude beneficial community-oriented organizations. The 2022 Census showed 4,162 new and beginning producers in Hawaii, indicating a vibrant, yet nascent, farming community needing support (Source: Farm Flavor Census of Agriculture).
- Clarity in Enforcement:
 - Clear, fair enforcement is vital to avoid legal disputes, which could deter potential agricultural investors or farmers.
- Support for Transition:
 - The 2023 USDA/NASS data indicates that agricultural sales in Hawaii were predominantly from diversified agriculture (\$370.9 million), suggesting a need for supportive measures during transition periods (Source: USDA/NASS).

Recommendations for Amendments:

- Establish a Farmer Transition Fund:
 - Propose an amendment for a state-backed fund to assist farmers in transitioning to new ownership or operational models. This could mirror models like the Important Agricultural Lands (IAL) incentives, providing tax credits or direct financial aid (Source: CTAHR - Voluntary Long-Term Protection of Agricultural Land).
- Victim Assistance Program:
 - Suggest the creation of a legal and financial assistance program for farmers affected by land speculation, ensuring they receive the support needed to continue or restart operations. This could leverage existing frameworks from the Department of Agriculture's data collection efforts for targeted assistance (Source: Civil Beat - Federal Farm Census).
- Land Stewardship Education:
 - Amendments should mandate educational programs on sustainable practices, particularly for new landowners or those transitioning under the bill. The University of Hawaii at Manoa's College of Tropical Agriculture and Human Resources could be instrumental in this education (Source: Wikipedia -Agriculture in Hawaii).
- Specific Amendments:

- Section -5 Exemptions: Expand to include agricultural cooperatives or community land trusts, recognizing their role in sustainable and community-focused agriculture.
- Section -6 Enforcement: Clarify procedures with an emphasis on transparency and fairness, possibly including an independent review board for appeals.
- Section -8 Divestiture: Propose rights of first refusal for local farmers or community organizations when lands are divested, preventing speculative purchases and encouraging local stewardship.

In conclusion, while S.B. No. 245 aims to protect and enhance Hawaii's agricultural landscape, incorporating these data-driven recommendations will ensure the bill not only addresses current issues but also fosters a resilient, locally-empowered agricultural future.

For clarification, Mahi Pono Holdings, LLC's sole member is Canadian pension fund PSP, both of which are registered as foreign entities in Hawai'i. PSP is a Crown Corporation with \$265 billion in assets that invests the pension funds of the Canadian Forces, the Royal Canadian Mounted Police, the federal public service, and the Reserve Force.

Many of those workers are represented by the Public Service Alliance of Canada (PSAC) union, which has more than 200,000 members. James Infantino, the National Pension Officer for PSAC, spoke at the September 2024 East Maui Water Authority meeting and gave a very clear message to Water Authority members and the community: "Don't let PSP investments anywhere near this long-term lease."

The basis for his message was PSP Investment's well-known record of international water grabs exploitation of water resources and local communities, which PSAC – representing PSP beneficiaries -- does not support.

This is just one example of why we need to ensure that Hawai'i's lands are protected from foreign interests.

Aloha Chair Gabbard, Vice Chair Richards and Committee Members

Hawaii's Thousand Friends, a non-profit organization dedicated to ensuring that appropriate planning, management and land use decisions are made that protect the environment, human health and cultural resources and that decision are made in conformity with the law supports SB 245 which seeks to ensure that Hawaii's agricultural lands remain locally owned.

There is a nationwide growing concern, not just in Hawaii, over foreign entities purchasing farmland. This concern is not unfounded.

In 2023, foreign investors owned 45.85 million acres of U.S. agricultural land, which is 3.6% of all privately held agricultural land, a 3.6% increase from 2022 and a 12.2% increase from 2025.

There are concerns that foreign ownership could threaten U.S food security and defense and that foreign ownership could affect local land rights and agricultural production.

Over the past five years foreign ownership of Hawaii's agricultural land has increased from 166,000 acres to 278,000, a 65% increase. (USDA Farm Service Agency report)

There is growing concern that a large portion of Hawaii's agricultural lands are owned by large corporations and businesses, leading to limited access for small-scale producers, and could lead to land development over farming

Hawaii's Aloha+Challenge has a goal of 20-30% of food consumed is grown locally and Hawaii's 2050 Sustainability Plan seeks to double local food production by 2030

These goals, that are meant to ensure food security for Hawaii, cannot be met if there is no land available to grow food for local consumption.

Since there are no federal restrictions on foreign ownership of agriculture land it is up to each state to protect its farmland.

We urge you to pass SB 245 and keep Hawaiian land in Hawaiian hands.

My name is Christina Busby and I am a Native Hawaiian woman and resident of Honolulu. I am a former public school educator and a current doctoral student in Education. I support SB245 which prohibits certain entities from owning, purchasing, or acquiring ownership of agricultural lands. With extensive experience teaching Aloha Aina Education with secondary age students, I have had the opportunity to volunteer at many farms and traditional food production sites around Oahu such as lo'i (taro terraces) and loko i'a (fish ponds). Various organizations have spent the last several decades rebuilding traditional food sites in order to develop Hawai'i's food sovereignty. Traditional sites like Pu'uloa (Pearl Harbor) and Waikiki were fertile lands abundant with fishponds and lo'i which produced enough food to feed tens of thousands of people. As you know, Hawai'i today depends on the majority of its food being imported from out of state. For Hawai'i to move toward increased food security again, the state should prioritize access for local producers, especially Native Hawaiian practitioners with lineal ties to place and aina. It is the Indigenous people, who are descendants of the land, who have intimate knowledge on the proper stewardship of the land.

I appreciate the changes made to this legislation from the previous version; however, I continue to have deep concerns over what the bill labels as "Prohbited Entities". There would be value in ensuring greater scrutiny over foreign land acquisition attempts, particularly from adversarial countries and sanctioned entities. This bill remains *too broad* in its prohibition applications.

I continue to urge this Committee to OPPOSE further consideration of this bill OR include amendments to more narrowly tailor the prohibited entity section.
