SENATE BILL 254
RELATING TO PROCUREMENT

Chair McKelvey, Vice Chair Gabbard, and members of the committee, thank you for the opportunity to submit testimony on Senate Bill 254. The State Procurement Office (SPO) opposes Section 2, page 1, lines 13-14, which amends the small purchase threshold for goods and services, and construction. SPO also opposes the revised language in Section 2, page 2, lines 7-8, which increases the threshold by which procurements must be conducted through an electronic procurement system. The SPO furthermore opposes increasing the threshold to \$10,000, by which agencies are required to verify compliance that is proposed in Section 3, page 3, lines 1.

In 1993, when the Hawaii Procurement Code was first enacted, the small purchase threshold was \$10,000 for services and supplies, and \$25,000 for construction. The threshold for services and supplies remained at that level until 1997, at which time the threshold was increased to \$25,000 for goods and services. It was again increased in 2006 to \$50,000 for goods and services, and added the electronic procurement component. In 2009, another increase to \$100,000 was made for goods and services and \$250,000 for construction, where they remain today.

In a recent survey of the 50 states and the District of Columbia, the small purchase threshold for goods and services varies from \$1,000 to \$250,000. However, 31 states' small threshold is under \$100,000, 14 states are at \$100,000, and only 6 states exceed \$100,000. This information shows that **90%** of all states have a small purchase threshold of \$100,000 or less. None of the states exceed \$250,000 for construction.

The proposed changes to the small purchase threshold will impact the purpose of the Hawaii Procurement Code, which is "to foster effective broad-based competition within the free enterprise program and to provide safeguards for the maintenance of a procurement program of quality and integrity."

Increasing the thresholds to \$100,000 to use an electronic procurement system would result in less transparency and reduced competition, which may lead to increase costs, procurement irregularities, and higher risk of parceling, which is the artificial division of goods, services, and construction in order to evade the statutory competitive requirements.

As the table indicates, there are a substantial number of transactions which fall into this category. That is **\$45 MILLION to \$50 MILLION** in transactions that would have been impacted.

By raising the threshold for procurements to be conducted on an eProcurement system, this would allow procurements of less than \$100,000 to be competed through a non-electronic system, Procurements less than \$100,000 may not be viewable and competed to all that could be considered, and requests for quotes or bids or even proposals may be solicited to the limited group that a procuring agency deemed to be on a "favorites" list.

All jurisdictions should utilize technological advances rather than resorting to labor-intensive, manual processes. Reverting to dated manual processes is contrary to enhancing operational efficiencies. Procurement automation is one way to supplement the process in the wake of labor shortages. By using an electronic procurement system, accurate procurement data should be immediately available to jurisdictions, negating the need for agencies to compile data manually.

Public procurement's primary objective is to provide everyone with an equal opportunity to compete for government contracts, and to prevent favoritism, collusion, or fraud in awarding contracts. Additionally, obtaining quotes without an electronic procurement system may lead to the agency only going to the same "favorite" vendors repeatedly, which would be in violation of HRS 103D-101(a)(6)(A) - Encourage competition by:

"Ensuring that all persons are afforded an equal opportunity to compete in a fair and open environment."

Furthermore, by raising the requirements to comply with all laws governing entities doing business with the State upon award would mean contracting with potentially bad contractors that may be delinquent in paying their taxes, keeping up with insurance, or adhering with labor laws. Raising the threshold to \$10,000 could diminish the state's goal of receiving goods, services, and construction from quality and compliant contractors.

We understand that with the rising costs of just about everything it has also affected purchasing systems. Therefore, we can understand the need to increase the limit to some extent. Our concern, however, is that there are many small contractors who specialize in those "small purchases". In most cases they are just getting started and don't have a sufficient employee count to handle larger jobs, or they don't have the financial wherewithal to bond jobs larger than this and finally, they prefer short term jobs as opposed to larger jobs where prompt payment and retention become issues.

Lastly, we note that 103D-305(b) still requires performance and payment bonds for jobs larger than \$50,000. If the government is to be protected it is only fair that contractors also be protected so we believe that section 103D-302(b) should still apply. We respectfully request that a reference be made in this bill that that section will apply.

With that necessary amendment, we can support the bills.

I am Elgin Arquero, Major of the Finance Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports Senate Bill No. 254, Relating to Procurement.

Increasing the threshold from \$25,000 to \$100,000 will allow departments within the jurisdictions to procure goods and services outside of an electronic system, without going through a central purchasing area. This bill will benefit the goals and operations of the HPD and allow us to better service the community.
