### **RELATING TO TREES**

Chair McKelvey, Vice Chair Gabbard, and Members of the Committee, thank you for the opportunity to testify on S.B. 2.

The Department of Accounting and General Services (DAGS) offers **comments** for S.B. 2, which requires the State to the extent practicable, to plant fruit trees in new or renovated landscaping that includes trees. Provides that the State is not liable for any injuries or illnesses resulting from the harvesting or ingesting of fruit, including food-borne illness.

DAGS provides the following comments:

- Unlike non-fruit bearing trees, there would be additional resources needed to properly clear/dispose of fallen fruit along with the general maintenance required to keep the fruit trees healthy.
- 2. New polices would be required for public access to fruit trees as well as a proper maintenance scope/schedule.

3. There may be additional liability concerns for the State from injuries to the public resulting from fruit trees.

### In consideration of SENATE BILL 2 RELATING TO TREES

Senate Bill 2 proposes that the State, to the extent practicable, plant fruit trees in new or renovated landscaping that includes trees. The bill would authorize persons to harvest fruit from those fruit trees and provides that the State is not liable for any injuries or illnesses resulting from the harvesting or ingesting of fruit, including food-borne illness. The Department of Land and Natural Resources appreciates the intent of this measure and offers the following comments.

The Department agrees with the need for more urban trees and the need to support food security. Selecting the proper tree species for any site and purpose is key to maximizing the long-term benefits of any tree or urban forest setting. Beyond planting, providing maintenance of trees is essential for their survival. Fruit trees often require additional maintenance (i.e., irrigation, proper pruning to make fruits accessible, and pest control) to produce edible and desirable fruit.

Kaulunani, the Urban and Community Forestry Program of the Department, supports community efforts to plant, maintain, and manage fruit trees and agroforestry systems. There may be opportunities to achieve some of the objectives of Senate Bill 2 through Kaulunani programming.
