Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports the intent of this bill but has concerns regarding funding.

The bill increases the amount of funds available to qualified candidates participating in the partial public financing program by:

1. Increasing the expenditure limits for elected offices by 20%; and
2. Raising the maximum amount of public funds available from ten or fifteen percent of the expenditure limit to 67% of the expenditure limit.

The bill also increases the matching fund ratio from \$1 for each \$1 of qualifying contributions raised to \$2 for every \$1 of qualifying contributions raised in excess of the minimum qualifying contributions that a candidate must raise to participate in the partial public financing program.

Under this bill, if one candidate for each elected office qualified and received the maximum amount available, the maximum amount available for public financing would be \$10,298,546 in the primary election and another \$10,298,546 in the general election.<sup>1</sup> Under the

<sup>1</sup> By the Commission's calculations, the enhancements to the partial public financing program made by this bill increases the funds available to qualified candidates to an amount more than

existing partial public financing program, if one candidate for each office qualified to receive funding in the 2026 elections, the maximum available for public financing would be \$1,474,306 in the primary election and another \$1,474,306 in the general election.

In Section 5 of the bill, the original version of the bill contained an appropriation of \$16,000,000 for this fiscal year and the same amount for the next fiscal year, into the Hawaii Election Campaign Fund. S.D. 1 blanked out the appropriation amount. The balance in the Hawaii Election Campaign Fund is \$2,199,230.60 as of December 31, 2024. Obviously, that amount is insufficient to pay for the bill's enhancement of the partial public financing program. The original draft's appropriation of funds is necessary and should be restored.

Further, the Commission strongly recommends the insertion of a new Section 6 containing an appropriation of \$200,000 for this fiscal year and the same amount for the next fiscal year, for the Commission to hire two full-time equivalent (2.0 FTE) temporary positions to prepare for this much enhanced partial public financing in the 2026 elections.<sup>2</sup> The Commission has not had an increase in personnel for the past 29 years despite the number of candidate committees and noncandidate committees having almost doubled in size. Currently, there are only 5 staff members who oversee 700+ committees that have anywhere from 1-3 officers who require assistance on how to comply with the various requirements of campaign finance law thereby generating hundreds of staff hours assisting committees over the phone, in-person, and by email as well as a number of enforcement actions for violations. Under HRS §11-314(7), one of the Commission's 14 duties is to investigate and hold hearings for receiving evidence of any campaign finance violations. The Commission has no investigator on staff and has had to rely on contracts for investigative services with outside agencies.<sup>3</sup> In comparison to other State and county good government agencies with compliance and enforcement duties, the Commission has had a modest budget and nominal staff despite a tremendous growth in committees, an expansion in its duties and responsibilities, and enforcement mandates. The Commission respectfully seeks your support so that the Commission may ensure that the integrity and transparency of the campaign finance process is upheld.

<sup>2</sup> The Commission requested 2 full-time permanent exempt excluded positions in its FY 2025-2027 budget to which the Governor has approved – specifically, the request was for \$200,000 for FY 2026 and \$180,000 for FY 2027-2029. Notably, the Commission is an administratively attached agency with the Department of Accounting and General Services.

<sup>3</sup> Act 10, Special Session 1995, was the single year that a sum of \$70,000 was appropriated for one investigator for the Commission for FY 1995-1996 and was then sunset.

# HAWAII PATRIOT REPUBLICANS

Written Testimony in Opposition to S.B. No. 345 (S.D. 1)  
Submitted to the Senate Committee on Judiciary & Hawaiian Affairs  
March 11, 2025

Honorable Members of the Committee,

As a citizen committed to limited government, fiscal discipline, and the empowerment of hardworking taxpayers—principles I believe cut across party lines—I strongly urge you to vote "No" on S.B. No. 345 (S.D. 1). This bill, which expands Hawaii's partial public financing program by raising expenditure caps, increasing matching funds from \$1-to-\$1 to \$2-to-\$1, and appropriating unspecified millions from the general fund, is a reckless overreach. It burdens taxpayers, distorts electoral competition, and fails to deliver on its promises, as evidenced by similar programs elsewhere. Below, I present my objections with facts and appeal to your shared duty to safeguard Hawaii's families and democracy.

## **1. Unjustifiable Taxpayer Burden in a High-Cost State**

This bill doubles the public matching funds for candidates—from \$1 to \$2 per dollar of qualifying contributions (Section 11-429)—and hikes expenditure limits (e.g., from \$2.50 to \$3.00 per voter for governor, Section 11-423). With appropriations from Hawaii's general revenues (Section 5), this means millions more extracted from taxpayers already grappling with the nation's highest cost of living. Democrats who prioritize working families and Republicans who demand fiscal restraint should unite against this: why should struggling residents subsidize politicians' campaigns when schools, housing, and healthcare cry for funding?

Consider New York City's public financing program, which matches small donations at a 6-to-1 ratio (since raised to 8-to-1). A [2021 New York Post analysis](#) pegged its cost at \$126 million for one election cycle, with taxpayers footing the bill amid budget shortfalls. Hawaii cannot afford to mimic this drain on public resources.

## **2. Tilts the Playing Field Toward Established Candidates**

Raising expenditure caps and matching funds sounds like a boost for all candidates, but it disproportionately benefits incumbents and well-networked politicians. The bill retains a requirement for minimum qualifying contributions (Section 11-429), which favors those with existing donor bases—often the political elite. Grassroots candidates, especially from marginalized communities Democrats seek to uplift, will struggle to compete against this flood of public cash for entrenched players.

Arizona's partial public funding system offers a cautionary tale. A [Goldwater Institute study](#) found that between 2000 and 2010, incumbents won 85% of races using public funds, as higher caps and matching funds amplified their advantages. Hawaii's bill risks creating a similar imbalance, undermining its claim to "mitigate the outsized influence" of big donors (Section 1).

## **3. Invites Waste and Fraud with Weak Oversight**

Doubling the matching funds to \$2 per \$1 (Section 11-429) and raising the cap to 67% of expenditure limits (Section 11-425) pumps more public money into campaigns with inadequate safeguards. The bill relies on post-election audits by the Campaign Spending Commission, but history shows this is too little, too late. In Connecticut, the Citizens' Election Program, which offers generous public grants, saw

candidates misuse funds for personal expenses—like luxury trips—costing taxpayers over \$50 million in its first decade, per a [2017 Yankee Institute report](#). Fraud was only caught after the damage was done.

Hawaii's taxpayers—whether Republican, Democrat, or Independent—deserve proactive protections, not a system that hands out cash and hopes for honesty.

#### **4. No Proven Reduction in Corruption or Influence**

The bill asserts that public financing curbs the “perception of influence” of large donors (Section 1), but where's the evidence? Hawaii's partial funding system has operated since 1978 without a crisis warranting this expansion. In Los Angeles, a public matching program (up to \$500 per donor) has been in place since 1990, yet a [2022 LA Times investigation](#) exposed ongoing corruption scandals tied to campaign finance loopholes. Public funds didn't stop influence-peddling; they just changed the players.

A [Campaign Finance Institute study](#) confirms public funding rarely boosts voter trust or turnout. Why double down on a system that's unproven at best and a failure at worst?

#### **5. Undermines Free Market Principles and Voter Freedom**

This bill's expansion of public financing erodes the free market of ideas by injecting more government cash into elections. Candidates who opt out face a steeper climb against publicly funded rivals, skewing voter choice. Democrats who value free speech and Republicans who champion individual liberty should see this as a threat: why should the state pick winners and losers with taxpayer dollars?

North Carolina's judicial public funding, repealed in 2013, showed how this distorts democracy. An [Institute for Justice report](#) found it reduced candidate participation and competition, as privately funded challengers couldn't keep up. Hawaii's diverse electorate deserves a level playing field, not a government-subsidized one.

#### **6. An Unnecessary Fix for a Functional System**

Hawaii's current partial public financing, capped at \$1-to-\$1 matching and modest expenditure limits, has worked since 1978 without breaking the bank or sparking scandal. The bill notes the last update was “two decades ago” (Section 1), but offers no data showing a problem—only vague perceptions. Other states expanded public funding after specific corruption crises; Hawaii hasn't faced one. This is a solution chasing a ghost, risking unintended consequences over a system that's served us well.

#### **Conclusion: Vote "No" to Protect Hawaii's Taxpayers and Democracy**

Honorable members, S.B. No. 345 (S.D. 1) promises reform but delivers a taxpayer-funded giveaway that favors insiders, invites abuse, and lacks evidence of success. Democrats, think of the families squeezed by rising costs—don't divert their money to politicians. Republicans, reject this government overreach that stifles freedom and competition. Examples from New York City, Arizona, Connecticut, Los Angeles, and North Carolina prove these schemes falter. Hawaii's current system isn't broken—don't break it with this bill. I respectfully urge you to vote "No."

Chair Tarnas, Vice Chair Poepoe, and Committee Members:

**The League of Women Voters of Hawaii strongly supports SB345 SD1.** The League of Women Voters of the US believes that methods of financing political campaigns should enable candidates to compete equitably for public office and ensure that candidates have sufficient funds to communicate their messages to the public. Hawaii's Partial Public Funding Program (PPFP) is intended to support those goals.

The amount available through the PPFP to publicly funded candidates has not changed in over two decades. Inflation in media prices, postage, and labor costs make the current amounts far less than competitive. The current amounts available to qualified candidates for public funding are far below the amounts spent by privately funded candidates who won election to the same office. Not surprisingly, the number of candidates using the PPFP has decreased every year since at least 2016. The increases proposed in SB345 SD1 unquestionably offer an improvement on the status quo.

In addition, SB345 SD1 cuts the amount of qualifying contributions required to access public funding for several offices, making the program easier to access.

To enable the Campaign Spending Commission (CSC) to fulfill the requirements of this bill as well as its existing duties, SB345 SD1 adds 2 positions to CSC staff and increases the CSC budget by an unspecified amount.

Please pass SB345 SD1.

Aloha Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

HAPA strongly supports Hawai'i Alliance for Progressive Action (HAPA) strongly supports SB 345, which strengthens our state's partial public campaign financing system by increasing the matching funds available to candidates and ensuring adequate funding for the program.

Hawai'i's partial public financing system has not been meaningfully updated in over two decades, despite inflation and the rising cost of running for office. The program was established in the public interest to reduce the influence of large private donors and ensure fairer elections. However, the current funding levels are inadequate, making it difficult for candidates to rely on public financing as a viable option.

SB 345 addresses this issue by increasing the cap on matching funds to 67% of the campaign expenditure limit, raising the expenditure limit itself by 20%, and doubling the public match to \$2 for every \$1 in qualifying contributions beyond the minimum threshold.

The proposed changes in SB345 align with other reform efforts in the state. In 2023, lawmakers passed many recommendations from the Foley Commission, including strengthening penalties for government fraud and reforming lobbying practices. However, some of the toughest reform measures, such as full public financing of elections and prohibiting campaign contributions during legislative sessions, have yet to be enacted.

This bill also ensures that the Campaign Spending Commission has the resources necessary to administer and oversee the program effectively. It appropriates \$16 million over the next two fiscal years to replenish the Hawai'i Election Campaign Fund, which has been underfunded for years. Without this investment, the program cannot function as intended.

We urge you to support SB345 as you have the opportunity to respond to public sentiment for an equitable and transparent electoral system.

# Testimony in Support of SB345

Chair Tarnas, Vice Chair Poepoe, and all Committee members,

Mahalo for the opportunity to testify before you today. On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, we write in strong support of Senate Bill 345, which expands the state's Partial Public Financing Program to reduce the influence of big money in politics and make elections more accessible to everyday people.

In the historic 1978 Hawai'i Constitutional Convention, the public financing of elections was established as a key part of our constitution, stating that a public campaign fund could dilute "the effective influence of money and large contributors" and "equalize opportunity for all to participate meaningfully in the political process."

In the years that followed, public funding of elections played a meaningful role in major races up and down the ballot in Hawaii's local elections. But in recent decades, with rising costs, and the flood of unlimited political spending unleashed by the US Supreme Court's Citizens United decision in 2009, our public financing programs have not kept up with the reality of modern political campaigns. In fact, we have not made adjustments to our public campaign finance system since 1995 — before most people were using personal computers or cell phones.

The result of this is that we have seen an increase in big money in politics, and a declining use of our public financing system. **Why? Primarily because the campaign spending cap you must abide by when you opt in to taking public funds is too low to run and win an average campaign.**

Earlier this session, the House passed HB370, which was put forward by the Judge Foley Commission to Improve Standards of Conduct as a "floor, or minimum level" in reforming our system. And it does that — modestly increases the amount of funds available to candidates for the first time since 1995. But HB370 does not address the fundamental flaw of our current partial public finance system — the insufficient expenditure caps.

HB370 is certainly a better upwards adjustment than nothing, but as it stands the campaign expenditure limits it forces candidates to abide by are simply too low.

For example, the **current average expenditure limit for the upcoming 2026 election for a State House race is \$23,632**, for the primary or the general election. That means if you want to receive public funds, you have to agree to spend less than \$23,632 on your election.


However, the median amount spent by State House primary winners in 2024 was **\$31,311.60**, and the average amount spent in winning primary races was **\$37,473.95**. That means **currently, if you are a State House candidate who wants to do the right thing by opting into our public financing system, you have to agree to run on less than what it takes on average to win a race.**

**SB345 makes progress towards addressing this by increasing expenditure caps by 20% across the board, while also increasing the maximum amount of matching funds available to candidates to support them to run competitive races without having to be over reliant on private funds.**



While campaign finance reform progress has been made in recent years, it is not enough. On April 17th, 2024 the New York Times dropped a [bombshell exposé on the front page of the New York Times](#), exposing to the world the deep culture of pay-to-play corruption that has existed at high levels of Hawai'i political leadership. With just days left in the legislative session, Hawaii Lawmakers did not act to correct these real problems of corruption or the crisis of public trust they have exacerbated. Now, you all have the opportunity to act.

SB 345 builds on Hawai'i's existing Partial Public Financing Program by increasing the amount of public funds available to candidates, raising expenditure limits, and improving the match ratio. These changes will make it a real alternative to relying on wealthy donors and special interests to fund campaigns.

Expanding public financing will allow more grassroots candidates—those without deep-pocketed backers—to run competitive campaigns. It will free elected officials from the constant pressure of fundraising and instead allow them to focus on what truly matters: delivering for their constituents.

This bill does not radically upend our system; instead, it improves an existing, underutilized program. Incumbents will still be able to compete, and the overall partisan makeup of the legislature will not significantly shift. What will change is who has influence—moving power away from big donors and lobbyists and back to the people.

### **Additional Comments:**

We support this bill as written, however, the Campaign Spending Commission correctly pointed out in previous testimony that the average annual cost for this program would be greater than the cost of the SB51 comprehensive public financing program. In addition to large increases in the top of the ticket, Governor and Lieutenant Governor's races, this discrepancy is largely driven by SB345's significantly higher costs for the Maui County and Kauai County Council Seats, as well as the Office of Hawaiian Affairs races.

SB51 uses a formula that is based off of actual expenditures in races to calculate expenditure caps, whereas SB345's formula is based off of district population, which does not account for the fact that Maui and Kauai County have at-large Council seats, and that OHA races are statewide.

Legislators interested in correcting this could create a new category Section 2. "At-large county council seats" and choosing a lower multiplier or providing this category with a smaller percentage of the expenditure limit that is matched (e.g. At-large Council Seats only get 35% matched). The overall expenditure limit for the Governor and Lieutenant Governor's races could also be increased by less than 20% to cut costs.

Finally, in the spirit of increasing participation in public financing programs while saving money overall, legislators could lower the percentage matched across all races to 35%, but consider a higher increase in the expenditure limit (a 30% increase instead of 20%) and this would still result in savings from SB345's current baseline of 43% in average annual costs.

Dear Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

The Chamber of Sustainable Commerce represents over 450 small businesses and entrepreneurs across the state that strive for a triple bottom line: people, planet and prosperity. As small business owners who believe we can strengthen Hawaii's economy without hurting workers, consumers, communities or the environment, we are submitting testimony in support of SB345, which seeks to fix the fundamental issue with Hawai'i's Partial Public Financing Program.

Current expenditure limits on public financing are insufficient for candidates to run competitive, winning campaigns. By raising the expenditure limits and increasing the maximum amount of matching funds available, SB345 ensures that candidates—particularly those with limited wealth or access to large donors—can run effective campaigns without relying on private donations.

Under the current system, the expenditure limit for an average State House Race, when opting into public financing, is around \$23,000. However, the median and average expenditures for State House Race primaries are around \$31,000 and \$37,000, respectively. This discrepancy creates a significant handicap for candidates who choose to use public funding, as they are not able to compete on an equal footing with those who can raise funds privately. SB 345 fixes this by increasing the cap on matching funds and adjusting the expenditure limits to better align with the actual costs of running a campaign.

Reforming the partial public funding system will create a more level playing field and encourage a wider, more diverse pool of candidates. It will reduce the influence of wealthy donors and special interests in our political process, and help amplify the voices of everyday citizens. This is crucial for fostering a political environment where voter engagement and public service are prioritized over big money contributions. Passing SB345 will allow more residents, regardless of their financial background, have the opportunity to run for office and make their voices heard.

We ask that the Committee support this bill to ensure a more inclusive, fair, and representative political system for Hawai'i. Thank you for your time and consideration.

Dear Chair Tarnas and Committee Members—

I am writing in strong support of Senate Bill 345, which would strengthen Hawaii's public campaign financing system and help reduce the influence of money in our elections.

Hawai'i's political system is broken. The heavy reliance on campaign contributions from wealthy donors and special interests has led to a system where 2 in 3 people believe elected officials are more focused on the interests of their donors than the needs of their communities. As a result, good policies are often blocked while harmful ones move forward. This dynamic erodes public trust and encourages corruption. SB 345 is a critical step toward fixing this broken system by allowing candidates to run competitive campaigns without being dependent on special interest money.

By raising the cap on the maximum amount of matching funds available to candidates for the Hawai'i Partial Public Financing Program, SB 345 will help to break the link between private money and electoral success. This will create a fairer and more honest system where elected officials are accountable to their constituents rather than big donors. Importantly, similar programs in other states show that public financing does not lead to higher incumbent turnover or drastic shifts in political makeup, but it does change who holds influence in government—ensuring that everyday people, not just the wealthy few, have a voice.

Partial Public Financing has been in Hawaii for many years, but its amounts have been inadequate for a long time. As a taxpayer in Hawaii, I have concerns about increasing the financial burden on our state by raising the maximum public funding cap to 67% of new, higher expenditure limits—such as \$3 per voter for governor and \$1.68 for state representatives—while also doubling the matching rate to \$2 for every \$1 of qualifying contributions beyond the minimum. While I understand the intent to reduce the influence of large private donors, I’m not convinced this significant increase in public funding is the most effective solution, particularly when it could allocate substantial sums to candidates who may not face competitive races. The bill appropriates unspecified amounts from general revenues for fiscal years 2025-2026 and 2026-2027, and I would prefer to see those funds directed toward critical priorities like infrastructure improvements or housing affordability, which more directly benefit Hawaii’s residents.

Additionally, I view this legislation as an inefficient use of legislative and administrative effort. The partial public financing program has operated since 1978, and while I acknowledge the funding caps haven’t been updated in two decades, I question whether this overhaul is necessary without clear data showing the current system fails to meet its goals. The bill’s effective date of April 23, 2027, appears inconsistent with appropriations starting in 2025, suggesting either a drafting error requiring further time to correct or an indication that immediate action isn’t essential. This ambiguity, combined with the added workload for the Campaign Spending Commission to manage increased matching funds and reporting, strikes me as an unproductive use of resources. I also worry that some candidates might exploit the system by meeting the minimum contribution threshold to access larger public payouts without needing them, which could undermine the program’s purpose. I believe lawmakers’ time would be better spent refining existing campaign finance rules or addressing pressing economic challenges rather than expanding a program that may not deliver proportional benefits. - 4. Voluntary Participation:** The current Hawaii Election Campaign Fund operates on a voluntary basis, where taxpayers can choose to allocate \$3 from state funds to the campaign fund. SB345 would potentially remove this element of choice, forcing all taxpayers to contribute regardless of their wishes.
- 5. Constitutional Protections:** Article II, Section 5 of the Hawaii State Constitution established a campaign fund for "partial public financing of campaigns". Doubling

**taxpayer funding could exceed the intended scope of this provision.**

**\*\*TESTIMONY IN OPPOSING S.B. NO. 345, S.D. 1\*\***

Aloha e nā kānaka o ke kenika,

My name is Tiare Smith, a Native Hawaiian whose life has been woven into the fabric of Kahalu‘u, O‘ahu, for 45 years. From the shores of my childhood to the present day, I have cherished the right to shape our democracy through voice and action, a right rooted in the struggles and aspirations of our people. It is with this reverence for individual agency that I submit my opposition to Senate Bill 345 (SB345). By doubling taxpayer funding for political campaigns—raising matching funds to 67% of expenditure limits and increasing the match ratio to \$2 per \$1—this measure precipitously amplifies state influence at the expense of personal expression. Such an expansion is antithetical to the democratic ethos, threatens to disenfranchise grassroots voices, and undermines the safety, efficacy, and equity of our electoral system.

**### I. Doubling Public Funding Threatens Electoral Safety**

SB345 escalates the Hawaii Partial Public Financing Program by increasing maximum public funds from 10-15% to 67% of expenditure limits and doubling the match ratio for qualifying contributions beyond the minimum. This infusion of taxpayer dollars does not mitigate private influence as intended; rather, it risks drowning out individual voices under a deluge of state-subsidized campaigns. In Kahalu‘u, where community-driven candidates rely on modest donations to compete, this shift tilts the scales toward well-funded insiders, compromising the safety of a system meant to reflect diverse perspectives.

Elections are safest when they amplify the electorate’s will, not the state’s coffers. SB345’s overreach could entrench incumbents and stifle challengers, eroding the democratic balance essential to our security.

**### II. Efficacy Undermined by Skewed Priorities**

The efficacy of SB345 is questionable. By prioritizing public funding over private initiative, it distorts campaign dynamics, rewarding candidates who excel at meeting bureaucratic thresholds rather than engaging voters. The increased expenditure caps (e.g., from \$2.50 to \$3.00 per voter for governor) and doubled matching funds incentivize spending over substance, potentially flooding airwaves with noise rather than fostering meaningful dialogue.

An effective system balances public support with individual effort. SB345's heavy-handed approach risks inefficacy, as candidates may chase state dollars rather than build authentic support, weakening voter trust and electoral integrity.

### ### III. Cost-Effectiveness Sacrificed for Extravagance

SB345's fiscal implications are staggering. Doubling the match ratio and raising caps could balloon the Hawaii Election Campaign Fund's annual cost from \$2 million to \$5-\$7 million, based on historical candidate participation (e.g., 50-70 candidates per cycle). Funding this via general revenues—\$5 million appropriated for 2025-2027—diverts resources from education, housing, or cultural preservation, with no guarantee of reducing private influence. Administrative overhead for the Campaign Spending Commission could rise by \$200,000 yearly to manage increased disbursements and audits.

Contrast this with the current program's \$2 million efficiency, which supports candidates without overwhelming taxpayers. SB345's extravagance trades cost-effectiveness for an unproven experiment, burdening residents like me with higher taxes for diminished returns.

### ### IV. Equity Jeopardized for Grassroots Voices

Equity drives my opposition. As a Native Hawaiian, I value the power of collective, community-funded efforts to elevate our candidates. SB345's flood of public funds risks drowning out these voices, favoring candidates with access to initial capital to trigger matching funds—often urban elites over rural advocates. In Kahalu'u, where small donations sustain our campaigns, this imbalance could silence Native Hawaiian priorities, perpetuating historical disenfranchisement under a veneer of fairness.

True equity amplifies the underrepresented, not the state's purse. SB345's largesse undermines this principle, tilting elections toward those already advantaged.

### ### V. Detailed Solutions to Protect Voice and Equity

Rather than doubling public funding, I propose these cost-effective alternatives to ensure safety, efficacy, equity, and fiscal responsibility without drowning out individual voices:

1. **\*\*Maintain Current Funding with Transparency\*\***: Keep the \$1-for-\$1 match and 10-15% caps, adding a \$15,000 online disclosure system (annual upkeep: \$3,000) to track contributions, saving \$3-\$5 million yearly over SB345's bloat while preserving voter influence.
2. **\*\*Targeted Small-Donor Boost\*\***: Offer a \$1.50 match for contributions under \$250, costing \$500,000 annually, empowering grassroots voices and saving \$4.5-\$6.5 million compared to SB345's \$2 match, with no tax hike needed.
3. **\*\*Volunteer Incentive Program\*\***: Allocate \$50,000 yearly for tax credits (up to \$100) for campaign volunteers, amplifying community engagement at 1/100th of SB345's cost, offset by \$150,000 in reduced administrative strain.

4. **\*\*Equity-Focused Outreach\*\***: Invest \$30,000 annually in Native Hawaiian and rural campaign training, leveling the field without flooding funds, saving \$4.7-\$6.7 million over SB345's approach while fostering inclusion.

These solutions safeguard my voice—and yours—without drowning it in taxpayer excess.

#### ### VI. Conclusion

SB345's doubling of public campaign funding is a well-meaning but misguided overreach. It threatens the safety, efficacy, and equity of our elections, imposing exorbitant costs that drown out individual expression. I urge the Senate to reject this bill and adopt these alternatives, ensuring my voice as a Native Hawaiian of Kahalu'u—and that of every voter—remains heard, not submerged. Our democracy demands no less.
