**DEPARTMENT'S POSITION:** The Department of Human Services (DHS) appreciates the intent of the measure, offers comments, and requests an amendment. DHS requests support for the executive budget, which includes a request for recurring funding to sustain the increased funding for reimbursement rates applied behavioral analysis (ABA) services.

**PURPOSE:** The purpose of this bill is to make an appropriation to increase funding for the Department of Human Services' Med-QUEST Division (MQD) reimbursement for applied behavioral analysis (ABA) services.

DHS appreciates the intent to provide increased funding for ABA services. In 2023, Senate Concurrent Resolution 132, Senate Resolution 152, and House Resolution 207 requested DHS to take necessary steps to ensure adequate provider rates are established for ABA services. MQD's contracted actuarial firm, Miliman, completed the study, and DHS submitted the study to the Legislature in December 2023. The study uses a payment model based on an Independent Rate Model methodology, which means building the component parts of the rates from the ground up. Key components of this rate study included outreach and engagement

with ABA provider agencies, providers, and their associations, collecting provider agency cost and wage survey data, and getting feedback on draft rate calculations. The rate study provided three scenarios (Scenarios 1, 2, and 3). In the 2024 legislative session, the Legislature did provide funding at Scenario 1 (low scenario) to increase the rates for ABA services. The increases were implemented starting January 1, 2025.

DHS agrees that increased rates are necessary and should be sustained. It will be increasingly difficult to have access to the full range of ABA services if the increases are not sustained. For this reason, the executive budget includes a request for recurring funding to sustain the increased reimbursement rates for ABA (Total: \$6,500,000M: \$2,690,000 A State funds/\$3,810,000 N Federal Funds). DHS respectfully requests support of the appropriation is made through the executive budget request, and not a bill, so that the increases are included in the DHS base budget.

Should this bill move forward, DHS requests an amendment deleting from Section 2, page 3, starting at line 20 through page 4, line 5:

~~"...provided that the department of human services shall obtain the maximum federal matching funds available for this expenditure; provided further that the department of human services shall pursue all funding sources known to the State, including private grants, prior to expending any general revenues appropriated pursuant to this Act."~~

Medicaid funding includes federal matching and state funds for every covered Medicaid expenditure. Also, federal Medicaid matching rates are set by the federal government, and all covered Medicaid expenditures automatically apply the appropriate federal matching rate. Thus, the mandate to obtain "maximum federal matching funds" is unnecessary and would complicate implementation of any rate increases. Further, private grants are not allowed to be the state fund portion of Medicaid expenditures. Thus, we respectfully request that these clauses be deleted.

### **SUPPORT SB450 RELATING TO AUTISM**

Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee:

Mahalo for the opportunity to submit testimony in **support of SB450**. BAYADA is a not-for-profit health care company committed to serving our community. We provide services across the state, with behavioral health services for QUEST members on Oahu and Maui.

As a behavioral health service provider, we have struggled to meet the needs of children with autism on Med-QUEST due to the increased costs of operating a business without increased rates for our services. QUEST rates for the coverage of intensive behavioral therapy (IBT) for treatment of children under 21 years of age with autism spectrum disorder (ASD), also referred to as applied behavior analysis (ABA), were set in 2015 and have not increased, despite the increased costs of living and increased costs for employers over the last eight years. Wages have gone up nearly 30% since 2015 in Hawai'i, forcing businesses to shoulder the cost without proportionate rate increases, making it harder to attract candidates and businesses to the field of supporting individuals with autism and their families.

We greatly appreciate the efforts taken in 2024 to include funding for increased rates for ABA QUEST funded services. **These funds were nonrecurring, only providing an increase for 2025, therefore it is imperative we pass additional legislation in the 2025 session to maintain these rates.**

**Without the increased rates, we are not able to adequately serve the children with autism and their families who need us.** As an organization, our values are compassion, excellence, and reliability; however, due to difficulties in attracting and retaining staff we find ourselves troubled that we cannot consistently deliver these values to our clients. Currently, **we must maintain a waitlist for clients to access services because there is more demand than we are able to meet with our current providers.** At our Oahu location, 40% of those on our waitlist are QUEST members. At our Maui location, 66% are QUEST members. We closed our Big Island and Kauai insurance-based services, despite ongoing community need, due to losses based on unsustainable rates in 2018. These waitlists are only representative of our organization and are similar across providers.



WE LOVE WHAT WE DO

The increased rates approved in last year's legislative session were published by Med-QUEST for use beginning 01/01/2025 but then required each provider work with the managed care organization (MCO) administering the QUEST benefit to members to work out these new rates within their provider contracts. At this point, we have not yet been able to contact the increased rates and therefore have not been able to adjust pay rates for staff and increase our hiring.

We respectfully request the Committee pass this bill in support of maintaining increased rates for what we believe are under-covered behavioral health services.

## **SUPPORT SB450 RELATING TO AUTISM**

**Honorable Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee,**

On behalf of the Hawai'i Association for Behavior Analysis (HABA), we sincerely thank you for your leadership in passing the recent increase in Medicaid rates for applied behavior analysis (ABA) services. After nearly a decade of stagnant rates, 2025 finally brings an increase—but the funds that were passed were nonrecurring so they are only for 2025. We urge you to pass this bill to maintain the increased rates and prevent disruptions in services for families who depend on them.

ABA is a **medically necessary** service covered under QUEST for individuals under 21 with an autism diagnosis, as mandated by federal law (EPSDT, Social Security Act §1905(r)). It is the gold standard for improving independence, reducing the need for long-term support, and improving the quality of life. .

As noted in the recent ABA rate study ([DC233](#)), providers continue to face **workforce shortages** due to low reimbursement rates, leading to **long waitlists** and limited access to services, particularly on neighbor islands. Some providers have even **stopped accepting QUEST** due to unsustainable rates. Without competitive reimbursement, families will continue to struggle to access the services their children desperately need.

The Legislature took an **important first step** by increasing rates last session, but these were just made available on 01/01/2025 and many providers are still working on their updated contracts with the QUEST health plans therefore not yet able to bill the increased rates. However, we know that without **maintaining these adjustments**, providers will not be able to offer competitive pay and will likely lose staff, resulting in families facing uncertainty about their children's care or being unable to access care at all. Investing in ABA services now ensures



children receive early intervention, reducing long-term costs and allowing them to **reach their full potential**.

In an effort to improve the accuracy of the preamble, we offer the following recommendation because indirect time is not separately billable:

Furthermore, the legislature finds that modeled rates for individual one-to-one services increased significantly for all scenarios. However, modeled rates for group services decreased for the lowest and medium rate scenarios. ~~Part of the decrease stemmed from the fact that indirect time has become separately billable since the med-QUEST division rates were set and was thus not included in the rate. Another reason was that~~ Group rates were decreased to reflect the number of members served simultaneously, rather than allowing the same rate to be charged concurrently for each client, which is the med-QUEST division's existing guideline.

We urge you to **pass SB450** to secure a **sustainable future** for ABA services in Hawai'i. Thank you for your time and consideration.

Esteemed Chair Buenaventura, Vice Chair Aquino, and Members of the Committee:

I write today on behalf of The Council of Autism Service Providers (CASP) in support of SB 450. CASP is a non-profit trade association of autism service provider organizations that have demonstrated commitment to promoting and delivering evidence-based practices for individuals with autism. CASP represents the autism provider community to the nation at large, including government, payers, and the general public. CASP provides information, education, and promotes the generally accepted standards of care for applied behavior analysis, ABA.

Of particular interest to our members is the coverage of evidence-based care in both private health insurance plans as well as through Medicaid. Timely access to medically necessary treatment, including applied behavior analysis, is critical for children with autism spectrum disorder (ASD).<sup>1</sup>

The State of Hawaii took an important step in 2015, when it passed legislation requiring coverage of medically necessary care for ASD. Since then, individuals diagnosed with ASD have had access to meaningful interventions, reducing their need for special education services, improving their quality of life, and opening doors for further education and employment. CASP deeply appreciates the temporary rate increases established during the thirty-second legislative session in 2024.

This coverage includes children under the age of 21 who are enrolled in MedQUEST, assuring access to medically necessary care pursuant to Medicaid's Early Periodic, Screening, Diagnostic and Treatment

(EPSDT) mandate and CMS' Informational Bulletin on Clarification of Medicaid Coverage of Services to Children with Autism.<sup>2</sup> EPSDT requires that these services be provided without delay. The previously referenced CMS bulletin states:

*EPSDT also requires medically necessary diagnostic and treatment services. When a screening examination indicates the need for further evaluation of a child's health, the child should be appropriately referred for diagnosis and treatment without delay. Ultimately, the goal of EPSDT is to assure that children get the health care they need, when they need it – the right care to the right child at the right time in the right setting.*

*The role of states is to make sure all covered services are available as well as to assure that families of enrolled children, including children with ASD, are aware of and have access to a broad range of services to meet the individual child's needs.*

Ensuring an adequate network is established by offering appropriate rates is critical. The existing MedQUEST rates were increased temporarily to reflect the increased cost of providing services. This has caused our member organizations to maintain wait lists for children who are in dire need of services and is in direct contradiction to the requirements of EPSDT.


As indicated below, other states with similar costs of living have permanent rates (orange) more in line with economic forces. Further, recent CMS guidance from SHO 24-0005 was consistent with these concerns:

*“Although adequate provider rates are not, in and of themselves, enough to ensure a sufficient network, without them, any steps a state might take to improve the provider workforce likely will be less effective.”<sup>3</sup>*

According to the most recent estimates from the Centers for Disease Control, 1 in every 36 children are diagnosed with autism spectrum disorder.<sup>4</sup> This means that more than 2.78% of Hawaii’s children on Medicaid have an autism spectrum disorder and many are unable to access the most basic, evidence-based treatments for their diagnosis.

On behalf of CASP and our member organizations serving individuals with autism in Hawaii, we ask that you pass SB450, which appropriates funds to make the temporary reimbursement rates for ABA service providers permanent. Thank you for your efforts to ensure all MedQUEST beneficiaries, including children with autism, have access to life-changing, evidence-based care.

My name is Fred Yuen and I am a Board Certified Behavior Analyst and owner/director of Behavioral and Therapeutic Services of Hawai'i. I am writing in strong support of SB450, which seeks to increase Med-QUEST reimbursement rates for Applied Behavior Analysis (ABA) services.

As a provider, I see firsthand the positive impact of ABA therapy on individuals with autism and other developmental disabilities. However, the current Med-QUEST reimbursement rates make it extremely challenging to maintain a high-quality ABA program. These rates make it difficult to recruit and retain qualified behavior technicians, leading to high turnover and impacting the consistency of care and safety for our clients.

SB450's proposed increase is crucial. It will allow us to offer competitive wages and benefits, attracting and retaining the skilled professionals necessary to provide effective ABA therapy. Currently the state of providers that are recruited are those that may stay for no longer than 1-2 years. This high turnover rate puts a huge stress on the industry. Higher rates will allow this industry to higher providers that will stay for career durations.

Investing in ABA therapy through appropriate reimbursement rates is an investment in the future of these individuals, leading to improved outcomes and reducing the need for more costly interventions down the line.

I urge the committee to support SB450. It is essential for ensuring access to quality ABA services for individuals with developmental disabilities.

Thank you for the opportunity to provide testimony supporting SB450, which seeks appropriate funding for the Med-Quest Division to address non-covered or under-covered behavioral health services for Med-Quest beneficiaries.

I am the President of Behavior Analysis No Ka Oi, Inc., a Kaka'ako-based clinic that has been providing services to individuals with autism for over 15 years. Our clinic specializes in applied behavior analysis (ABA), an empirically validated, medically necessary treatment for children diagnosed with autism and related disorders. While the passing of Luke's Law in 2015 was a significant milestone, requiring health insurance coverage for autism diagnosis and treatment, the Medicaid fee schedule for ABA services has remained unchanged.

Over the past decade, operational costs have risen significantly. Expenses related to rent, employee health insurance and benefits, and mileage reimbursements for employees commuting to homes and community sites have all increased. Despite these rising costs, the lack of increases to the Medicaid fee schedule has severely impacted our ability to recruit and retain qualified providers.

We cannot offer competitive wages compared to school-based services, which are reimbursed at higher rates. This has led to challenges in hiring the best providers and retaining experienced staff. Many of our qualified professionals have relocated to the mainland, where the cost of living is lower, and fee schedules are more favorable, or leave the field completely. As a result, our clinic now has a waitlist of approximately three years for services. While the passage of Luke's Law was a monumental advancement in securing services for the people of Hawai'i, it is not impactful if those it was meant to serve cannot find providers.

In conclusion, additional funding for the Med-Quest Division is essential to address the gap in non-covered or under-covered behavioral health services. This funding will ensure that medically necessary ABA services are accessible to individuals with autism in Hawai'i and help clinics like ours recruit and retain qualified providers to meet the growing demand for services.
