TESTIMONY IN <u>SUPPORT</u> OF SB55 — RELATING TO ADMINISTRATIVE RULES

Aloha Chair McKelvey, Vice-Chair Gabbard and other members of the Committee,

The Grassroot Institute of Hawaii would like to offer support for <u>SB55</u>, which would require all state agencies adopting, amending or repealing a rule to make the full text of the proposed rule available on the website of the Office of the Lieutenant Governor in a digitally accessible and searchable format.

Administrative rules govern all aspects of life in Hawaii, from invasive species control to deadlines for the issuance of professional licenses, but currently there is no statewide system that makes it possible for the public to know of and track proposed changes to agencies' administrative rules.

Instead, an interested individual must follow dozens of agencies' calendars and websites for periodic and non-standardized rulemaking notices.

The amendments proposed in SB55 would make it far easier for affected parties to learn of changes to administrative rules, thereby promoting transparency and civic engagement in agency rulemaking.

Dear Chair, Vice Chair and Members of the Committee:

My name is Peter Fritz. I am an individual with a disability, an attorney and an advocate for individuals with disabilities that has filed ADA complaints against the State. I am a former chair of the Disability and Communication Access Board (DCAB) and the Rehabilitation Advisory Council. I am testifying in support of the INTENT of SB 55.

The intent of Senate Bill 55 is to provide greater accessibility to administrative rules posted on the Lieutenant Governor's website by requiring those documents to be "in a digitally accessible and searchable format." However, the standard for what constitutes a digitally accessible and searchable format are not specified. Without specifications, it is impossible for an entity to comply with the requirements of this bill.

This bill ignores the fact that the State of Hawaii is required to comply with Title II of the Americans with Disabilities Act. (ADA). Title II has standards, regulations and case law interpreting what is an ADA accessible document. An individual has a cause of action for any discriminatory conduct in federal court. There are no remedies in SB 55.

The Lieutenant Governor testified at other hearings that staff are assigned to post documents that comply with the ADA. Other states, such as Florida, California, and New Jersey have addressed accessibility by incorporating the Title to ADA standards specific standards into their statutes and Hawaii should do the same. I am a member of the Florida Bar and I can provide a copy of the Florida statute. I made such a suggestion at a Hawaii Deaf Blind Task Force meeting.

With respect to a possible claim that Hawaii has already established a statewide standard because of the committee created by Act 172, Session Laws Hawaii 2022, that committee was tasked with developing a report recommending accessibility standards and electronic information technology (EIT) accessibility standards to be implemented by all state entities. Act 172 did not have any requirements to implement these standards as part of Hawaii Revised Statutes. The standards in the report stand by themselves and have no enforceability.

To ensure that the same accessibility standards apply to all state agencies, I respectfully request that the Committee hold this bill in and pass legislation that establishes a statewide standard for accessible documents.

I support this measure and recommend there be more distinct requirements and standards of how each agency interfaces their rules, proposals, etc. so that it is not simply a link to an agency and we have to navigate that agency's website.
