# SB 672 – RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE UNIVERSITY OF HAWAII

Chair Kim, Vice Chair Kidani and Members of the Committee:

Thank you for the opportunity to provide testimony in support with amendments to SB 672 relating to the University of Hawai'i which authorizes the issuance of general obligation bonds and appropriate funds for a capital improvement project (CIP) for the repair, maintenance, and demolition of buildings at Waimānalo Research Station.

The renaming of the college was approved in October 2024 to better align CTAHR's name to its land-grant mission of improving the human condition and human use of natural resources through research, education and Cooperative Extension. We respectfully offer the following amendment: SECTION 1., lines 2-3, to correct the name of the college to university of Hawaii at Manoa college of tropical agriculture and human [resources] resilience (CTAHR).

The Waimānalo CARES (CTAHR Agricultural Research and Extension Stations) Center is part of a statewide network of CARES centers that provides crucial support for local farmers, ranchers, and the local community conducting agricultural research, Extension and 'āina based educational activities from K-12 to graduate levels for the public good. CTAHR appreciates the purpose of SB 672 which authorizes the issuance of general obligation bonds in the sum of \$4,000,000 for fiscal year 2025-2026 for CIP at the Waimānalo research station. There is a new opportunity presented by the adjacency of the former Meadow Gold Dairies (MGD) land to the Waimānalo research station. CTAHR now manages the MGD under a Right of Entry with DLNR, and CTAHR would like to build a state-of-the-art animal science teaching, research, and Extension facility and further expand field research and the GoFarm program to meet food self-sufficiency goals, and obtain national accreditation for its Animal Science undergraduate program. CTAHR respectfully requests an amended sum of \$5,500,000 of the general obligation bonds for CIP at Waimānalo research station with the additional \$1,500,000 for Phase 1 of the redesign of MGD land at the Waimānalo research station.

We support SB 672 with the suggested amendments, provided that its passage does not replace or adversely impact priorities as indicated in our BOR Approved Budget. Thank you for the opportunity to submit testimony.

Aloha Chair Kim, Vice-Chair Kidani, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 672, which authorizes the issuance of general obligation bonds and appropriates funds for a capital improvement project for the repair, maintenance, and demolition of buildings at the Waimanalo Research Station.

The Waimānalo Research Station (WRS) was established by the University of Hawai'i in 1950. The 127 acres in Waimānalo, O'ahu are deemed ceded lands and must be used for educational and other public purposes. The station is adjacent to the former Meadow Gold Dairies (MGD) site, which CTAHR manages under a Right of Entry with the State of Hawai'i, Department of Land and Natural Resources.

The Waimānalo Research Station is part of a larger network of agricultural experimental stations and Cooperative Extension offices across the State, which supports Research, Extension, and Instruction (REI) endeavors for UH researchers, specialists, Extension faculty, staff, and students. WRS provides critical research and extension services benefiting Hawai'i's farmers and ranchers. It is a testing ground for innovative agricultural techniques, including soil health, pest and disease management, organic farming practices, and crop improvement.

WRS is home to research on specialty crops, tropical fruits, and sustainable farming techniques, helping Hawai'i's producers remain competitive. It plays a key role in training new and existing farmers through outreach programs, workshops, and hands-on demonstrations.

Many of the station's facilities are outdated, deteriorating, and needing repair, limiting their ability to support research and extension programs. Without repairs and modernization, the station will be unable to meet the growing needs of Hawai'i's agricultural community. Upgrading and repairing key infrastructure will expand research opportunities, attract funding, and improve the station's ability to serve local farmers.
