**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) supports the bill with amendments, provides comments, and respectfully suggests amendments.

**PURPOSE**: The purpose of this bill is to expand the Preschool Open Doors Program's eligibility criteria. Repeals the requirements that Preschool Open Door program providers be accredited.

The Department recommends maintaining group child care centers as the type of care for the Preschool Open Doors program. The Preschool Open Doors program is an investment in early learning that provides children the opportunity to experience a structured preschool environment so that they are better prepared for kindergarten. Group child care centers offer the most comparable experience for the child prior to their kindergarten entry as care services are provided in a classroom setting led by a qualified teacher, and enrollment consists of children of the same age. If this measure is passed to add accredited family child care, the Department recommends amending the term accredited "family child care center" on page 4, line 1, to accredited "family child care home," which exists in current law.

DHS respectfully recommends the following amendments:

- Section 2, paragraph (b), on page 2, lines 11 and 12, to read: Subject to the availability of funds, the program shall continuously serve [three-and-four year old] children who are in the [two] three years prior to kindergarten entry <u>until they enter kindergarten</u> pursuant to section 302A-411...
- Section 2, paragraph (c) (3), on page 4, lines 1 to 3, deleting the entire paragraph
- Section 2, paragraph (c) (4), on page 4, lines 4 to 5, to read: <u>An exempt</u> <u>center-based provider that meets the requirements of</u> section 346-152.5.
- Section 2, paragraph (d), on page 4, lines 6 to 8, to read: <u>Participation</u> in the program shall not require group child care centers or group child care homes to be accredited by an approved accredited body.
- Section 2, paragraph (e), on page 4, lines 9 to 13, to read: Enrollment in the program shall be voluntary. A parent or guardian of a child enrolled in the program [shall] may share in the costs of the program through a copayment according to a sliding fee scale that is based on needpursuant to rules adopted by the department.

Regarding accreditation addressed in Section 4, currently, there are 144 out of 455 group child care centers and infant and toddler centers that are accredited by the National Association for the Education of Young Children (NAEYC) and the National Early Childhood Program Accreditation (NECPA). Though DHS recognizes and supports the added quality that accreditation adds to the care a child receives at a group child care center, DHS also recognizes that accreditation is a costly and lengthy endeavor for group child care center operators. As the number of child care centers has been declining since prior to the COVID-19 pandemic, at this time, the mandatory accreditation requirement for the centers for families to receive Preschool Open Doors subsidies will likely have a negative impact on the available inventory of preschools that families could select from.

The average cost for the initial fees to obtain NAEYC accredited status is \$4,155, and fees for initial NECPA accredited status are \$2,331. These costs may vary depending on the licensed capacity of the group child care center. These fees are the accrediting organization's fees for processing and assessing an applying group child care center's request for accreditation.

Notably, these accreditation fees do not include additional costs that a group child care center may incur to meet the accrediting organization's standards. Once accredited, both organizations have annual fees to maintain their accreditation.

The Early Learning Board (ELB) formulates statewide policy relating to early learning, as well as directing the Executive Office on Early Learning (EOEL).

The Executive Office on Early Learning (EOEL) offers the following comments in support of S.B. No. 712 and defers to the Department of Human Services (DHS) regarding implementation and funding.

The Preschool Open Doors program plays a crucial role in helping families afford quality child care. This legislation will expand access to early learning opportunities for Hawai'i's families by expanding eligibility for the Preschool Open Doors program to include 2-year-olds (children three years prior to kindergarten entry) and extending the program to cover a broader range of community-based providers licensed by DHS.

Re: Support for SB712, Relating to the Preschool Open Doors Program

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

**ECAS supports, with amendments, SB712**, which would expand the Preschool Open Doors program's eligibility criteria and significantly increase access to early learning programs for young children and their families. *No appropriation is requested as part of this measure.* 

High-quality early learning programs provide children with the experiences and environments that are pivotal to school readiness and lead to improved educational, economic, health and well-being outcomes for children, lasting into adulthood. The Preschool Open Doors (POD) program currently provides key financial assistance to families to facilitate access for 3 and 4-year-old children to these child care and early learning programs. The POD program changes proposed in this measure would expand eligibility to 2-year old children and decrease some of the additional barriers that have restricted and/or are projected to limit full uptake of the assistance available to, and critically needed by families.

By expanding POD eligibility to include 2-year-olds, this bill acknowledges the importance of early childhood development during these formative years and addresses a substantial gap in child care support for families with younger children. The bill will also reduce the significant financial burden many families face regarding child care expenses. Hawai'i has some of the highest child care tuition rates in the nation, with expenses for families comparable to, and at times even exceeding, housing costs. Assistance for 2-year olds, as well as the proposed adjustment to continuous services, and reduction to the family co-payment to a maximum share of one dollar, will all alleviate financial pressures, enabling families to remain in the workforce and achieve greater economic stability, while simultaneously laying a strong foundation necessary for our keiki to grow and thrive.

Expansion of the child care settings in which POD assistance may be applied, will also be instrumental to increasing children's access to early learning opportunities. Inclusion of family child care homes, and removal of the accreditation requirement for child care centers will significantly increase the availability of child care seats for children in the current landscape where capacity and vacancies are highly limited. We strongly encourage the continued promotion of program quality through the accreditation support programs recently established by



the Department of Human Services, and the rate incentives embedded in the POD payment structure, without the limitations to choice and access posed by an accreditation *requirement*.

We would like to especially highlight the inclusion of family child care providers as a much-needed option for local families to access early learning opportunities for their children. Family child care providers can often better meet the needs of families with non-traditional parental work hours, match the cultural and linguistic preferences of families, and are often found in rural communities in which larger child care centers cannot be sustained. Enacting policy that recognizes family child care providers as eligible for POD funding would result in immediate growth in the number of available early learning slots for local keiki.

Related to quality practices that promote school readiness, we would also like to note that high quality early learning experiences that prepare children for kindergarten can be made available to children as much in family child care settings as in formal child care center classroom settings.

To proactively address any potential concerns regarding inclusion of family child care homes as eligible POD providers, we respectfully recommend the following amendments to Section 2, subsection (c), subsection (3), page 4, lines 1-3:

(3) An accredited family child care center A family child care home that is registered by the department in accordance with section 346-171; provided that they meet at least one of the following quality standards:

- is accredited through the National Association for Family Child Care or National Early Childhood Program Accreditation;
- ii. participates in a partnership program that aligns with federal Head Start or state prekindergarten program standards; or
- iii. demonstrates adherence to evidence-based practices that support child development or school-readiness as approved by the department.

Parents and Children Together (PACT) <u>supports SB 712</u> Relating to the Preschool Open Doors Program, which expands the program's eligibility criteria.

SB 712 expands access to early learning services to keiki as young as two years old by amending the existing statute in several ways, including: the removal of the accreditation requirement; the inclusion of family child care providers as eligible for the POD program; and the capping of a family's copayment at one dollar. These changes will result in more local keiki being able to access early learning services at a younger age.

Research continues to show that—despite the expansion of state-funded early learning services and programs—less than 40% of 4-year-olds and less than 15% of 3-year-olds are enrolled in state-funded programs—clearly demonstrating a continued lack of access for many children and families.

While family child care providers are generally limited in their inclusion in state-funded early learning offerings and programs, research indicates that they can play an outsized role in a community's overall early learning framework. Studies have also found that family child care providers are an important option. Low-income families, those with non-regular work hours, and ethnic or racial minorities are likely to utilize family child care providers. Making family child care providers eligible for POD funding would result in immediate growth in the number of available early learning slots for local keiki.

Founded in 1968, PACT is a statewide community-based organization providing a wide array of innovative and educational social services to families in need. Assisting more than 15,000 people across the state annually, we help identify, address, and successfully resolve challenges through our 20 programs. Among our services are early education programs, domestic violence prevention and intervention programs, child abuse prevention and intervention programs, childhood sexual abuse supportive group services, child and adolescent behavioral health programs, sex trafficking intervention, poverty prevention and community building programs.

Dear Chair San Buenaventura, Vice Chair Aquino, and the Members of the Committee,

Members of AAUW of Hawaii thank you for this opportunity to testify in **strong support of SB 712, Relating to the Preschool Open Doors Program** which will:

- Expand eligibility to include children ages 2-5 years old.
- Expand eligibility to include Family Child Care Centers.
- Allow for continuous eligibility until kindergarten entry.
- Remove the accreditation mandate (but does continue to require licensure).

Hawai'i is experiencing a child care crisis. The demand for available, quality, and affordable child care far exceeds the current capacity in Hawaii. There is only one opening for every four children ages six and below. The situation is even worse for those seeking a child care space for infants and toddlers with only one opening for every 37 children. This leaves families, and single parent households in particular in a bind. Without available child care services, many parents end up in a no-win position. They can either stay home with their young children and face increasing economic hardship or be stuck scrambling to find someone to "watch" their children. These informal child care settings can be unsteady and often do not provide the necessary early childhood educational and developmentally appropriate activities which lead to a child being ready to enter kindergarten.

In Hawai'i, family members, especially grand parents have often stepped in to provide child care. Unfortunately, kupuna are finding it financially necessary to remain in, or return to, the workforce in order to make ends meet in our ever increasing expensive state.

In addition, having children actually penalizes women in the workforce. The Institute for Women's Policy Research reports 50.5% of households with children in Hawai'i have mothers who are the main source of family income. However, women working full time experience what's known as the "**Motherhood Penalty**". Working mothers make only \$.74 for every dollar working fathers make in Hawaii while the overall gender wage gap in Hawai'i where working women make \$.84 for every dollar a working man make.

The cost of licensed child care ranges from approximately \$13,000 to \$23,000 per year depending on the age of the child. The median income for a single parent family is \$43,050, which means that child care for an infant would use up over 50% of the salary; leaving little left over to pay for transportation, parking, food, housing and taxes. Child care is the second largest cost to families following housing expense.

One of the major obstacles preventing mothers from securing a well-paid, stable job is finding and retaining available, affordable, quality child care including Family Child Care Centers. For some parents, having quality Family Child Care as an option is extremely important for those who work nontraditional hours or live in rural communities where there are few center-based options. These licensed family centers provide qualify care are often located close to homes or places of working. Currently there are 22 Family Child Care Centers progressing through the accreditation process here in Hawaii adding to the existing pool of qualified providers.

This measure increases the availability and access to the quality and affordable early child care including an important array of child care setting options. Having quality Child care is so important for early childhood development and also allows parents the stability to continue in the workforce to provide for their family and contribute to society.

The Hawai'i State Coalition Against Domestic Violence (HSCADV) addresses the social, political, and economic impacts of domestic violence on individuals, families, and communities. We are a statewide partnership of domestic violence programs and shelters.

On behalf of HSCADV and our 25 member programs statewide, I respectfully submit testimony in strong support of SB712. I am testifying in support of this bill, which would incentivize early learning employers in Hawai'i to participate in Preschool Open Doors Expansion (Preschool Scholarships).

To ensure families have access to high quality early childhood care and education from birth to kindergarten, we must fairly compensate our early care and education workforce and provide them with opportunities for professional advancement. Early learning registered apprenticeship programs are a proven recruitment and retention strategy, offering apprentices higher compensation and valuable on-the-job learning experiences as they work towards earning a higher education degree. ELRAPs have also been successful at increasing the quality of early learning programs as they develop a well-prepared, well-supported, and well-compensated ECE workforce.

However, many early learning providers are unable to participate in ELRAPs because they cannot afford to pay the higher wages of apprentices and ensure wage parity for existing staff. The ELRAP grant would remove this financial barrier by providing funding for eligible providers to participate in state- or federally-approved ELRAPs. The grant would also allow providers to pay their existing staff higher wages, ensuring that wages are comparable to federal wage requirements or prevailing industry standards.

On behalf of Hawai'i Children's Action Network (HCAN) Speaks!, mahalo for the opportunity to testify in **STRONG SUPPORT of S.B. No. 712 in its original text without any content edits**, as it expands the eligibility criteria for the Preschool Open Doors (POD) program, expands setting options, and removes the requirements that POD providers be accredited. This measure is essential in increasing access to early learning for families across Hawai'i, particularly those with young children who face financial an geographical barriers to participation.

 The Need for Subsidies for Families with Two-Year-Olds – The early years of a child's life are crucial for cognitive, social, and emotional growth. However, the cost of early learning remains a significant burden for many families. Expanding POD eligibility to include twoyear-olds ensures that more children receive the early learning experiences necessary for future success, reducing long-term disparities in opportunities.

Research consistently shows that early intervention and structured environments significantly impact a child's future achievements and overall well-being. Providing subsidies for families with younger children would allow more parents/guardians to enter or remain in the workforce, ultimately strengthening Hawai'i's economy while ensuring children receive the foundational experiences they need.

2. Expanding Eligible Child Care Settings to Include Family Child Care Homes – Currently, families in rural areas face significant barriers to accessing child care due to the limited availability of center-based programs, long waitlists, and transportation challenges. The exclusion of family child care homes from the POD program disproportionately impacts low-income and underserved families, denying many keiki across Hawai'i access to early learning opportunities. Family child care homes provide a nurturing, culturally responsive environment, offering flexible hours, smaller group sizes, and care that aligns with families' values and needs. Expanding POD to include these provider options would

ensure all keiki, regardless of location or economic status, have access to essential early learning opportunities.

This expansion would promote equity in early education, support working families, and strengthen Hawai'i's early learning workforce. Many family child care home providers are small business owners who play a vital role in addressing the state's child care shortage, especially for families with non-traditional work hours. Recognizing and funding these providers through POD would create a more inclusive system that serves all keiki, not just those with access to center-based care.

3. Removing Accreditation Requirement to Increase Accessibility – Currently, a limited number of group child care centers and infant-toddler centers in Hawai'i hold accreditation from organizations such as the National Association for the Education of Young Children (NAEYC) and the National Early Childhood Program Accreditation (NECPA). While accreditation is one indicator of standards, it is a costly and time-consuming process for providers. The high costs associated with accreditation, which can exceed \$4,000 for initial fees alone, often create barriers for smaller, community-based child care centers.

Since the number of child care centers in Hawai'i has been declining, removing the accreditation requirement will allow more providers to participate in the POD program, thereby expanding options for families in need. Many non-accredited centers still maintain strong care and development programs but cannot afford the financial and administrative burden of accreditation. This change will ensure that families have a broader selection of preschools to choose from without limiting access due to accreditation requirements.

By passing **S.B. No. 712**, the Legislature can take a crucial step toward making early learning more accessible and affordable for Hawai'i's families. I respectfully urge you to support this bill as it's currently written to expand early learning opportunities and strengthen our state's commitment to the well-being and future success of our keiki.

With SB 712, the POD program will expand to add 2-year-olds. This expansion will alleviate financial pressures so more families will remain in the workforce and achieve greater economic stability, while simultaneously laying a strong foundation for their 2- year olds to grow and thrive.

In SB 712, the types of early learning programs for eligible families are listed on pg. 3, line 18-21 and p. 4, line 1-4. I am in agreement with licensed group child care centers, licensed group child care homes, licensed infant and toddler child care centers, and exempt center-based providers.

I've been an advocate for early childhood care and education since the 1980s. I am professor emerita of University of Hawai'i Maui College, where I was the program coordinator from 2000-2019. I am also the current chair of the Early Learning Board, however this testimony is my personal testimony.

This bill to expand access to Preschool Open Doors (POD) would greatly benefit Hawai'i's working families who need early care and education for their keiki beyond the school day and for the full year.

Our early learning system is broad and complex, and this additional state funding will supplement the current federal and state funding that families can access.

High quality programs facilitate children's growth and development, with well qualified, hopefully equitably compensated staff. As director of a small faith-based preschool in the 1980s, we were (Ala Lani United Methodist Preschool) the first on Maui to be accredited by the National Association for the Education of Young Children (NAEYC) in 1987. It entailed a lot of work and it was very rewarding (but not financially at that time!) to be acknowledged as a high quality program. The accreditation process is extra work and programs need extra support and funding to achieve and maintain quality.

It's important to note that the requirement for the Dept. of Human Services (DHS) to support accreditation stays in place and DHS and other entities have launched programs for accreditation support. As these programs progress, there'll be better information and data on what and how much funding is needed to bring more programs up to accreditation standards.
