# **Testimony in Support of SB733**

Submitted to the Senate Judiciary Committee by Evan Weber, Managing Director, Our Hawai'i, 1/31/2025

Chair Rhoads, Vice Chair Gabbard, and all Committee members,

On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, we write in in strong support of House Bill 772, relating to a continuous legislative session, which would enhance accessibility, responsiveness, and efficiency in Hawaii's lawmaking process. Our members and supporters are local people — kama'āina and kānaka 'oiwi, keiki and kūpuna, from Kaua'i to Kohala, Kailua to Kapolei and every place in between. They have joined our movement to fight for a Hawai'i that puts local people — not big money interests — first. This bill would help enhance that vision and goal.

The current legislative schedule makes it nearly impossible for most ordinary working people to participate in the democratic process. The rapid pace and flurry of bills is overwhelming, and ordinary people can barely track what is going on, let alone make time to submit testimony, speak with their representatives, or show up to make their voices heard.

This means that the legislature is dominated by paid lobbyists, the professional class, retirees, and the wealthy. What about the farmers and fishermen? What about the fast food workers? What about the domestic workers? Janitors? Restaurant servers?

Shouldn't their voices get to equally be heard?

By establishing a continuous session, SB 733 ensures that everyday people—who must balance work, family, and other commitments—have greater opportunities to engage with their elected representatives, provide testimony, and follow legislative developments in real time.

Additionally, a year-round Legislature could be supportive to Legislators and their staff by allowing for more deliberation, debate, and research — resulting in more thoughtful policymaking. Rather than compressing debate and decision making into a short window, a year long legislature would allow for a more intentional approach to addressing urgent and complex issues. Lawmakers will have more time to consider the long-term impacts of their decision, including the true budgetary impacts, and provide for more extended research and deliberation.

Lastly, a year-long legislature could make practical the Capitol abiding by the full extent of the Sunshine Laws that apply to most other governmental bodies, leading to greater public transparency and accountability.

For these reasons, we urge you to support SB 733 to make our government more accessible and representative of the people it serves.

Dear Chair Rhoads, Vice Chair Gabbard, and Members of the Committee,

HAPA is submitting testimony in STRONG Support of SB733, which, among many relevant to a continuous legislature, establishes a continuous Legislature and requires the Legislature to convene at least once monthly.

Complex challenges like the housing shortage, growing environmental concerns, and the need for quality public education, amongst many issues, call for more time than our current session allows. By meeting throughout the year, lawmakers can address issues as they arise rather than waiting for the next session or a special session.

In just the past five years, our state has experienced many emergency crises that require faster or more flexible responses. Recent environmental emergencies like the Red Hill fuel leak revealed the need for steady and ongoing legislative oversight. During the COVID-19 pandemic, policies had to be revisited and adjusted often. Even with the Lahaina fire, we needed our state legislature to address the urgent need for improved disaster response protocols and long-term recovery plans for affected communities. However, this part-time calendar just cannot keep pace with the constant changes.

Thousands of bills are introduced each year, yet many do not receive full consideration under the current framework. Measures are even frequently postponed because committee chairs believe they lack sufficient time to make informed decisions. Consequently, more than half of the proposals introduced at the beginning of the legislative session are either deferred or not scheduled for a hearing.

It is important to note that the state Constitution did not prevent the legislature from meeting for only 60 days prior to 1968, and this change was only enacted during the 1968 constitutional convention.

Additionally, a year-round legislature will improve transparency and public engagement. When hearings are more frequent and predictable, residents can schedule testimony without feeling rushed and not deter them from participating. This also helps residents living in the neighbor islands and rural areas who may face travel or technology obstacles, giving them more time to prepare and, should they choose, be present in person.

Thank you for considering one of the many bills introduced this year that aim to expand the legislative session from 60 days, to year round or continuous. More than 3000 bills between house and the senate were introduced this year. The pace at which the hearings are held is completely unsustainable for anyone who's not financially compensated to participate in.

I'm hoping that by expanding to a year round or continuous model, lawmakers could have more time to collaborate in advance on legislation, so 4 similar bills are not introduced. We can also pay lawmakers a full time salary for a full time job, so there would be no need for outside employment. The pace at which hearings are scheduled, testimony is accepted, and provided for review can be expanded, so the general public can have proper oppertunity to participate. More time for bill review could allow for fiscal notes to be added to bills; allowing everyone to understand the financial impact the bill truly has.

Many of the good government reforms we are aiming to pass would be easier to implement with a year round model.

#### Aloha JDC Committee Members,

I appreciate the effort of SB733 to make our state legislature better able to serve the people. Being a legislator *should* be a full-time job if a legislator is going to do a good job.

However, it makes no sense whatsoever to disqualify legislators who maintain a second job in the private sector, but allow a second job in government (except for emergency civil defense and disaster relief positions). No one can hold two jobs (or appointments) simultaneously and do them both well. Besides, isn't this double dipping? It's not right.

I request that Section 8 of SB733 be simple, clear, and amended to read as follows:

#### DISQUALIFICATIONS OF MEMBERS

**Section 8.** No member of the legislature, during the term for which the member is elected or appointed, shall hold any other position of employment, except the member may serve in the United States military reserves, reserve police officers, or officers of emergency organizations for civilian defense or disaster relief. The legislature may prescribe further disqualifications and exceptions.

Moreover, a year-round Legislature fosters more thoughtful policymaking. It allows for a more measured approach to addressing urgent issues rather than compressing debate into a short window. This system will lead to greater transparency and accountability, as lawmakers will have more time to consider the long-term impacts of their decisions.

For these reasons, I urge you to support SB 733 to make our government more accessible and representative of the people it serves.

## **Opposition to SB733**

SB733 proposes a fundamental shift in Hawaii's governance by transitioning the legislature from a part-time to a full-time body, requiring lawmakers to meet at least once a month. While this may seem like a step toward increased efficiency, in reality, it creates more bureaucracy, increases costs, and restricts citizen representation in government. This bill should be opposed for several key reasons.

#### 1. Increased Costs Without Justification

Transitioning to a full-time legislature means significantly higher costs for taxpayers. Legislators will require higher salaries, expanded staff, and more resources to operate year-round. Hawaii already faces budget challenges in areas like housing, education, and public infrastructure—why should taxpayers foot the bill for lawmakers to stay in session continuously? The bill offers no clear evidence that a full-time legislature would result in better governance, only that it would cost more.

2. Unnecessary Expansion of Government

The current part-time legislative system ensures that government remains limited and accountable. Requiring lawmakers to meet every month invites overregulation, more laws, and increased government interference in citizens' lives. More session time does not necessarily lead to better laws—it often leads to over-legislation, where lawmakers feel compelled to pass bills simply because they have more time to do so.

#### 3. Exclusion of Working Professionals from Public Office

One of the most troubling aspects of SB733 is its ban on private-sector employment for legislators. This restriction effectively shuts out working professionals, business owners, and industry experts from serving in government. Instead, it creates a political class of career legislators who are disconnected from the real-world challenges of Hawaii's economy. The best legislatures are made up of individuals with diverse backgrounds and experiences, not just full-time politicians.

4. No Real Demand for a Year-Round Legislature

Hawaii has functioned effectively with a part-time legislature for decades. There is no overwhelming public demand for continuous sessions, nor is there evidence that the state's current system is failing due to a lack of legislative time. Most pressing issues can already be handled through special sessions, making a full-time legislative body redundant and unnecessary.

## 5. Increased Political Influence and Lobbyist Power

A year-round legislature would give lobbyists and special interest groups even more time to influence lawmakers. The longer legislators are in session, the more opportunity there is for outside pressure to shape policy, often at the expense of everyday citizens. A part-time system limits the power of professional lobbyists and forces legislators to focus on the most critical issues rather than being pulled in every direction.

## Conclusion

SB733 is a costly, unnecessary expansion of government that would burden taxpayers, restrict citizen participation, and encourage career politicians rather than citizen-legislators. The current part-time system keeps government accountable and ensures that laws are passed efficiently. There is no compelling reason to change this system other than to increase legislative pay and power. Instead of creating a full-time legislature, Hawaii should focus on improving efficiency within the existing framework. For these reasons, SB733 should be strongly opposed.
