<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) appreciates the intent of this bill and provides comments. DHS respectfully requests that any appropriation not reduce or replace priorities identified in the executive budget.

<u>PURPOSE</u>: This bill appropriates funds to the Department of Human Services to improve Supplemental Nutrition Assistance Program (SNAP) rates, including establishing additional positions. Effective 7/1/2027. (SD1)

The Committee on Health and Human Services amended the measure by inserting an effective date of July 1, 2027, to allow the Department of Human Services to fill vacant existing positions in their SNAP processing centers.

DHS will discuss with the Department of Human Resources Development (DHRD) the implementation of differential pay increases as a strategy to fill vacancies and retain dedicated staff.

Presently, the Department has a workforce vacancy rate of approximately 25 percent for eligibility workers and 50 percent for clerical staff in our processing centers for SNAP and

cash assistance applications. High vacancies and challenges to both recruitment and retention of the workforce can be attributed to retirements, a lack of interested applicants, and opportunities for higher-wage jobs, which, combined, make the vacancies very difficult to fill. The Department is engaged in constant recruitment through a Wikiwiki Hire process, which includes weekly interviewing on Oahu.

The inability to sustain staffing negatively impacts overall processing and staff morale. There is a lack of staff to support the eligibility process through document processing, application registration, and other administrative functions integral to operations.

The Department would appreciate additional resources to strengthen the SNAP program, provided an appropriation does not reduce or replace priorities identified in the executive budget.

**EOA Position:** The Executive Office on Aging (EOA), an attached agency to the Department of Health (DOH) supports the intent of SB960 SD1.

**Fiscal Implications:** Appropriates funds to the Department of Human Services (DHS) for FY2025-2026 and the same sum for FY2026-2027 to strengthen access to the Supplemental Nutritional Assistance Program (SNAP) by authorizing differential pay increases, establishing new positions for SNAP program, and taking on new initiatives to improve program participation rates.

**Purpose and Justification:** The purpose of this measure is to appropriate funds to DHS to improve Supplemental Nutrition Assistance Program rates, including establishing additional positions. The COVID 19 pandemic significantly increased food insecurity for many individuals, including kūpuna. With the high cost of living and increasing costs for healthcare and prescription drugs many kūpuna live on fixed incomes and struggle financially.

For individuals and families dealing with food insecurity SNAP provides a safety net and helps those with limited income buy nutritious food, enabling them to maintain a healthy diet. As discussed in the bill by eliminating the net income criteria more households will be eligible for SNAP. Additionally, by enhancing staffing for the SNAP program more households, including kupuna may access SNAP benefits, experience food security and live healthier, more fulfilling lives.

**Recommendation**: EOA supports the intent of SB960 SD1 and defers to the DHS for its implementation.

I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery-oriented services.

- 3. **Indirect Community Support:** SNAP also supports caregivers and families of individuals with behavioral health illnesses. When families can access healthy meals, it creates a more stable and supportive environment for everyone.
- 4. **Reduced Financial Stress:** Many people with behavioral health illnesses face financial instability due to employment challenges or medical costs. SNAP helps reduce food insecurity, alleviating one major source of stress, which can exacerbate mental health symptoms.

By improving nutrition, reducing food insecurity and providing critical support, SNAP benefits act as a foundation for better health and recovery for those managing behavioral health challenges.

Dear Chair Marten, Vice Chair Olds, and members of the Committee:

Thank you for the opportunity to submit testimony in support of **S.B. 960**, which would appropriate funds to the Department of Human Services (DHS) to improve Supplemental Nutrition Assistance Program (SNAP) rates, including increasing positions and pay.

Serving more than 160,000 residents, SNAP is one of the most critical public benefit programs in the nation. It is an economic lifeline for these families, yet many who are eligible still struggle to obtain or maintain benefits due to bottlenecks at the state level. In recent weeks, SNAP applicants have been facing wait times of 3 to 4 hours to complete the required eligibility interview, and in some cases are unable to get through at all. Many have reported having to submit their paperwork more than once because it was lost. As a result, only 62% of eligible residents end up enrolled in SNAP—only 35% of our kūpuna population.<sup>2</sup>

DHS is aware of the issues, and working overtime to fill vacancies, streamline procedures, and alleviate the bottlenecks. Eligibility and clerical workers are doing their best despite being overwhelmed and underpaid, but the situation may worsen before it improves. Because of the recent rule change to eliminate net income limits for eligibility, there is expected to be an extra 14,000 households eligible for SNAP benefits later this year. With large increases in SNAP applications upcoming, it is more urgent than ever to fund this first step towards administrative efficiency.

The SNAP office put in budget requests for performance-based incentives for eligibility workers and contracting clerical staff, but both did not make it into this year's budget. By implementing higher pay for staff, there is more incentive to fill current vacancies and lower turnover rates, ultimately increasing internal capacity.

Thank you for considering these comments in your deliberation of S.B. 960. The high volume of applicants are all struggling Hawai'i residents who need a system that works for them, not against them, and these administrative fixes are a step in the right direction.

Aloha Chair Marten, Vice Chair Olds, and members of the committee,

On behalf of Hawai'i Foodbank, I express our support for SB 960, SD1 Relating to the Supplemental Nutrition Assistance Program (SNAP). This bill appropriates funds to the Department of Human Services to improve SNAP participation rates, including establishing additional positions.

For over 40 years, Hawai'i Foodbank has provided daily and emergency assistance to those facing food insecurity in Hawai'i. As the state's leading hunger-relief organization, Hawai'i Foodbank distributes food to families and individuals on O'ahu and in Kaua'i County through direct service programs and through our network of 266 agency partners and pantries. Last year, we served an average of over 150,000 people each month, distributing a total of 21 million pounds of nutritious food, including 5.9 million pounds of fresh produce.

Hawai'i Foodbank is also contracted as a SNAP outreach provider through the State. In this role, our team has seen firsthand the challenges SNAP applicants face. Our data shows that individuals wait 2.6 hours on average to speak with a representative and one client reported waiting over 9 hours. As a result, many give up on the process entirely due to the inability to get help and so many eligible residents, including our kūpuna, are not enrolled in this vital program.

The Department of Human Services SNAP department is critically understaffed. Increasing pay for SNAP workers and adding staff positions within the Department of Human Services would fill vacancies, improve efficiency, and boost enrollment, bringing in much-needed support to struggling families in our state. We also ask that you move up the effective date of the bill to July 1, 2025 to provide this critical support to DHS as soon as possible.

Food security is a critical issue in Hawai'i, where one in three households lack comprehensive access to healthy, nutritious food. SNAP is one of our most important anti-hunger programs, offering choice and healthy options for families who need extra support putting food on the table.

Food+ Policy **strongly supports SB960**, which seeks to improve Supplemental Nutrition Assistance Program (SNAP) access by allocating funding to the Department of Human Services for increased staffing. This investment is critical to ensuring that eligible families receive timely benefits, supporting both food security and economic resilience in Hawaii.

At the "We Grow" Summit, hosted by the Hawai'i Youth Food Council (HYFC), youth from across the state shared their lived experiences with food insecurity. Their testimonies underscored the harsh reality that many families face—parents working multiple jobs with grueling hours, yet still struggling to put food on the table. These economic pressures not only threaten health and well-being but also fracture family bonds. **SNAP provides an essential lifeline, but staffing inefficiencies prevent families from accessing these benefits when they need them most.** 

Testimonies from community members have highlighted unacceptable delays in SNAP processing, including an average of four-hour hold times, insufficient staffing, missing deposits, late mail notices, which result in delayed or lost applications. SB960 takes meaningful action by strengthening the SNAP workforce, which in turn bolsters the local economy, alleviates stress for families, and advances Hawaii's long-term food resilience.

SNAP has already made the commitment to support over 160,000 Hawai'i residents event though it lacks significant operational support. SB960 ensures both current and future recipients receive timely and effective assistance. Every dollar spent through SNAP generates \$1.50 in economic activity, benefiting local farmers, food retailers, and businesses. **Allowing** applications to be lost or delayed due to staffing shortages is not just a failure of governance—it is a missed opportunity for economic growth and community stability.

This bill aims to improve SNAP participation rates by establishing additional positions at DHS and implementing measures to strengthen access to this vital program. SNAP serves as a crucial safety net for low-income individuals and families across the state, assisting them in purchasing nutritious food.

In Hawai'i, SNAP plays a critical role in supporting many of our most vulnerable residents. In fact, more than half of SNAP recipients in Hawai'i are in families with children, and SNAP lifted 62,000 people above the poverty line in Hawai'i, including 26,000 children, per year between 2015 and 2019, on average.<sup>1</sup>

The average SNAP benefit per household with children in Hawai'i was \$1,098 per month in fiscal year 2022. In 2024, Hawai'i received \$732.5 million in SNAP benefits, not only lifting up low-income families, but also directly supporting approximately 900 food retailers in Hawai'i.

There is a lot of room to enhance SNAP's reach. From 2017 to 2019, only 62% of eligible Hawai'i residents participated in SNAP,<sup>2</sup> indicating that there are tens of thousands people in Hawai'i who need the support of SNAP but are not getting it.

The additional positions and other improvements proposed by this bill would not only reduce food insecurity in our state, but also stimulate the local economy with millions more dollars going to local food retailers. In addition, the bill would improve DHS's administrative efficiency and effectiveness.

Mahalo for this opportunity to provide testimony. Please pass this bill.

Chair Marten, Vice Chair Olds and Members, Committee on Human Services and Homelessness:

Catholic Charities Hawai'i **strongly supports SB 960 SD1**, which appropriates funds to the Department of Human Services (DHS) to improve Supplemental Nutrition Assistance Program (SNAP) rates.

Catholic Charities Hawai`i (CCH) is a tax exempt, community-based organization that has been providing social services in Hawai`i for over 77 years. CCH has programs serving elders, children, families, veterans, houseless persons and immigrants. Our mission is to provide services and advocacy to the most vulnerable people in Hawai`i. We serve over 40,000 people each year throughout the state. This bill is one of our economic justice priorities.

Food. A basic human necessity. Kids need it to grow strong and healthy. Parents need it to work hard and be productive. Kupuna need it to continue living actively in our community. SNAP is a godsend for those who qualify. However, the effectiveness of this program currently is hampered by understaffing at this DHS service. Furthermore, the State has removed the net income eligibility criteria which opens up the SNAP services to approximately 13,000 to 14,000 new households! This could result in \$45,000,000 in benefits to our local families.

This expansion of SNAP to workforce families who are struggling with food insecurity is greatly needed. However, applying for SNAP benefits is very frustrating under the current system. For example: Our client, a 71 year old man, only gets \$1205 in Social Security and his rent is \$725. We helped him recertify for SNAP benefits, which was difficult due to no response from the SNAP office during his scheduled phone interview. He had to go in person to get certified and it took 3 trips to the DHS office to be seen and complete the task. He was eventually reapproved for benefits. Without SNAP, he would have trouble affording food and his rent. He has multiple serious health conditions which he has to carefully monitor and is unable to work, so he is on a low, fixed income. Having SNAP means he can afford nutritious food and maintain his housing so he does not become homeless.

We strongly support funding to enable DHS to implement differential pay increases and other initiatives as strategies to fill vacancies and retain experienced staff and to make other needed improvements.

**Take action now!** Funding to strengthen the SNAP program will help local people to remain in Hawaii, and give hope for a better and healthier life for children, adults, kupuna, etc. We urge your support for this bill. AlohaCare appreciates the opportunity to provide testimony in **support** of **SB960 SD1**. This measure appropriates funds to the Department of Human Services to improve Supplemental Nutrition Assistance Program rates, including establishing additional positions.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 70,000 Medicaid and dual-eligible health plan members on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

AlohaCare's commitment to whole person care includes addressing a variety of social determinants of health, including access to care, economic stability, and nutrition among other factors. According to the Hawai'i Foodbank, approximately 1 in 3 families in Hawai'i are food insecure. We understand that without access to affordable healthy food, the health and well-being of our members is negatively impacted. Increasing access to SNAP is critical in closing the food access gap, decreasing the financial burden on families, and improving overall health outcomes.

From keiki to kūpuna, access to nutritious meals will improve overall health and decrease adverse health outcomes. Families with access to SNAP are more likely to see their doctors for routine health checkups, preventing chronic health conditions and increasing the ability to manage disease.<sup>2</sup> For our pregnant mothers and babies,

maternal and early childhood access to SNAP is correlated to improved birth outcomes and long-term health outcomes as adults. For elderly populations, access to healthy food may be the difference in whether they can continue living in their communities independently, decreasing the need for medical interventions and emergency department visits.<sup>3</sup> Investing in SNAP, and making sure the program is staffed appropriately, is a long-term solution that will support our 'ohana and most vulnerable populations' health and quality of life.

Hawaiʻi Public Health Institute (HIPHI)¹ and the Healthy Eating, Active Living² (HEAL) coalition is in **support with amendments of SB 960 SD1**, which appropriates funds to the Department of Human Services to improve Supplemental Nutrition Assistance Program rates, including establishing additional positions.

Please amend this bill for it to go into effect in 2025, not 2027.

One in three households in Hawai'i face food insecurity.<sup>3</sup> Federal Supplemental Nutrition Assistance Program (SNAP) benefits are a lifeline to many of these residents. Local families in need receive over \$600 million annually in SNAP benefits.<sup>4</sup> Unfortunately, the state has made accessing these benefits incredibly difficult. The state needs to improve the enrollment process and ensure local SNAP-eligible residents can receive the federal benefits they need.

#### One Additional Worker Could Provide \$2 Million in Federal Benefits

Our SNAP office enrolls over 60,000 households annually, with less than 300 staff. That is more than 200 applications per staff member. Given the extreme backlog, adding one extra person to our SNAP department could be the difference between 200 families receiving SNAP benefits or not. At an average benefit per household of over \$9,600 annually, this worker could help provide these 200 families in need with \$2 million in total federal food assistance.

#### **Difficulty Enrolling**

Local Hawai'i residents face immense barriers when trying to enroll in SNAP. Wait times often exceed four hours, causing many applicants to abandon the process out of frustration. Physical office locations are frequently inaccessible, further compounding the issue. When residents call the Department of Human Services (DHS) at their scheduled time for the required interview, their calls often go unanswered, leaving them unable to complete the process. Days or weeks later, they receive a callback from an unrecognized number at an unscheduled time, making it difficult for many applicants to answer—especially if they are at work or attending to other responsibilities. As a result, their missed interview leads to a denial of their application, creating an unfair cycle that denies residents the support they need.

Currently, only 62% of eligible residents participate in the program, with participation among kūpuna even lower at just 35%. Systemic challenges, including incorrect application denials and missed interview opportunities, leave many families without the critical support they need.

#### **SNAP Office is Understaffed Following Increased Demand**

In fiscal year 2023-2024, the SNAP department processed 90,000 applications—a 50% increase from 60,000 in 2017-2018. Despite this dramatic rise in demand, staffing levels have remained stagnant at around 275 employees for several years. This lack of sufficient staffing has made the enrollment process so difficult. To adequately support residents, the state must increase staffing to match the escalating demand.

With demand already on the rise, fifty thousand additional households have become eligible for SNAP this month as the net income threshold was removed from the eligibility test. The need for more staff is urgent now—and will become even more critical as more families apply.

We must increase both the number of budgeted positions and the pay for these roles to ensure they are filled. Raising salaries will help attract and retain qualified staff, while expanding available positions across the board will allow for targeted recruitment in areas with low vacancy rates, ensuring equitable access to services statewide.

During the height of the pandemic our state sprung into action to improve the unemployment office staffing situation. With over 100,000 eligible individuals currently missing out on SNAP benefits, we must take bold, urgent action to streamline the application process and ensure that every qualified person can access the support they need.

#### 10:1 Return on Investment

Our low SNAP participation rate means far fewer Hawai'i residents are accessing critical federal benefits than they should. Since half of SNAP processing staff salaries are covered by federal funds, increasing staffing levels would require the state to contribute only half the investment.<sup>10</sup>

Adding an additional \$10 million for staff on top of the roughly \$20 million we spend now would bring in an additional \$10 million in funding from the federal government for those staff. If that can help raise the SNAP participation rate from 62% to just 75%, we could bring in over \$100 million in additional federal funding annually. A \$10 million investment now would give more than a 10:1 return on investment, with more than \$100 million coming back to the state.

By failing to hire enough staff to ensure a smooth and efficient application process, we are effectively leaving federal dollars on the table and missing an opportunity to better support our community.

#### **Variable Vacancy Rates**

Many staff locations face high vacancy rates, making it challenging to fill positions. However, some sites have lower-than-average vacancies, presenting an opportunity to quickly expand the workforce. By adding positions to these locations, we could bring in dozens of new employees to strengthen the department.

Please pass this bill to ensure that federal SNAP benefits remain a reliable and accessible lifeline for all eligible residents in need.

On behalf of Hawai'i Foodbank, I express our support for SB 960, SD1 Relating to Supplemental Nutrition Assistance Program (SNAP). This bill appropriates funds to the Department of Human Services to improve SNAP participation rates, including establishing additional positions.

For over 40 years, Hawai'i Foodbank has provided daily and emergency assistance to those facing food insecurity in Hawai'i. As the state's leading hunger-relief organization, Hawai'i Foodbank distributes food to families and individuals on O'ahu and in Kaua'i County through direct service programs and through our network of 266 agency partners and pantries. Last year, we served an average of over 150,000 people each month, distributing a total of 21 million pounds of nutritious food, including 5.9 million pounds of fresh produce.

Hawai'i Foodbank is also contracted as a SNAP outreach provider through the State. In this role, our team has seen firsthand the challenges SNAP applicants face. Our data shows that individuals wait 2.6 hours on average to speak with a representative and one client reported waiting over 9 hours. As a result, many give up on the process entirely due to the inability to get help and so many eligible residents, including our kūpuna, are not enrolled in this vital program.

The Department of Human Services SNAP department is critically understaffed. Increasing pay for SNAP workers and adding staff positions within the Department of Human Services would fill vacancies, improve efficiency, and boost enrollment, bringing in much-needed support to struggling families in our state.

Food security is a critical issue in Hawai'i, where one in three households lack comprehensive access to healthy, nutritious food. SNAP is one of our most important anti-hunger programs, offering choice and healthy options for families who need extra support putting food on the table.

Expanding benefits to 300% of the FPL will allow families to have a gradual decline in benefits as their income rises, allowing families to earn their way out of poverty rather than being stuck in a no-win situation where they lose thousands in benefits just by earning \$1 over the income limit. \*\*TESTIMONY IN SUPPORTING S.B. NO. 960, S.D. 1\*\*

Aloha e nā hoa o ka Senate,

I am Tiare Smith, a Native Hawaiian whose 45 years in Kahalu'u, Oʻahu, have bound me inextricably to the rhythms and resilience of this land. As a descendant of those who thrived through aloha 'āina, I bear witness to the struggles of our people against the rising tide of economic hardship. It is with this legacy and a fervent belief in communal well-being that I offer my unequivocal support for Senate Bill 960 (SB960). By appropriating funds to bolster staffing for the Supplemental Nutrition Assistance Program (SNAP), this measure confronts Hawaii's precipitous cost of living with a robust, equitable solution. Far from disenfranchising our communities, it amplifies their strength, ensuring safety, efficacy, and fiscal prudence while nourishing our most vulnerable.

#### ### I. Enhancing Safety Through Nutritional Security

SB960 fortifies the safety of our social fabric by expanding access to SNAP, a lifeline for over 130,000 residents and a conduit for \$630 million annually into our economy. The elimination of the net income limit, as endorsed by Governor Green in 2024, promises an additional \$45 million to reach 13,000-14,000 more households—each receiving \$3,200 yearly. Yet, this potential remains unrealized without sufficient staffing. By funding differential pay and new positions, SB960 ensures that families in Kahalu'u and beyond can access these benefits swiftly, safeguarding their health and stability against food insecurity—a peril antithetical to our communal ethos.

### ### II. Elevating Efficacy with Strategic Investment

The efficacy of SNAP hinges on its implementation. Understaffing at the Department of Human Services (DHS) has long hampered participation rates, leaving federal dollars untapped. SB960's targeted investment in personnel—authorizing pay incentives and new roles—promises to streamline processing and outreach, particularly for economically disadvantaged communities. This is no mere expenditure; it is a catalyst to unlock hundreds of millions in reimbursable federal funds, amplifying the program's reach and reinforcing its status as the nation's premier anti-hunger initiative. Efficacy demands execution, and SB960 delivers precisely that.

#### ### III. Cost-Effectiveness Through Federal Leverage

Critics may balk at the upfront cost to taxpayers, but SB960's fiscal logic is unassailable. By enhancing SNAP staffing, the state leverages fully reimbursable federal benefits—each dollar spent on administration potentially yielding \$10-\$15 in economic return. The \$45 million immediate gain cited in the University of Hawaii study is but a harbinger of long-term prosperity, with participation growth poised to inject hundreds of millions more. This is not a drain on resources but a reinvestment in our people, rendering SB960 a paragon of cost-effectiveness.

### ### IV. Equity as the Cornerstone of Support

Equity animates my endorsement. As a Native Hawaiian, I know the weight of systemic barriers—high food costs, limited access, and bureaucratic delays—that disproportionately burden rural and indigenous communities like Kahalu'u. SB960's focus on staffing to serve "economically disadvantaged" areas directly addresses these disparities, ensuring that SNAP reaches those historically sidelined. By nourishing families without regard to net income, it upholds our cultural mandate of mutual care, fostering an equitable future where no one is left hungry.

#### ### V. Addressing Concerns with Pragmatic Solutions

While SB960's merits are compelling, potential drawbacks warrant consideration. I offer the following solutions to mitigate these concerns, aligning with safety, efficacy, cost-effectiveness, and equity:

- 1. \*\*Mitigating Upfront Taxpayer Costs\*\*
  - \*\*Concern\*\*: General fund appropriations strain state budgets.
- \*\*Solution\*\*: Phase in staffing over two years, starting with a \$1 million pilot in 2025-2026 for high-need areas (e.g., rural Oʻahu), then scaling to \$2 million in 2026-2027. Pair this with a \$50,000 federal grant application to offset initial costs, saving \$500,000-\$1 million upfront while ensuring safety through gradual implementation.
- 2. \*\*Preventing Waste or Mismanagement\*\*
  - \*\*Concern\*\*: Flexible spending risks inefficiency.
- \*\*Solution\*\*: Mandate a \$20,000 annual DHS audit of SNAP expenditures, publicly reported, and cap "other initiatives" at 10% of funds (\$200,000 max). This enhances efficacy with oversight, saving \$100,000-\$300,000 yearly by curbing waste, and ensures equitable use.
- 3. \*\*Ensuring Participation Growth\*\*
  - \*\*Concern\*\*: Staffing alone may not boost enrollment.

- \*\*Solution\*\*: Allocate \$30,000 yearly for a community outreach program—partnering with Native Hawaiian organizations—to educate 5,000-7,000 households, doubling participation gains at 1/10th the cost of broad media (\$300,000). This bolsters efficacy and equity cost-effectively.

# 4. \*\*Accelerating Impact\*\*

- \*\*Concern\*\*: The July 1, 2027, start delays relief.
- \*\*Solution\*\*: Amend the effective date to July 1, 2025, using \$500,000 in existing DHS reserves for immediate hires. This ensures safety by delivering aid sooner, saving \$1 million in future emergency food programs through proactive support.

# 5. \*\*Avoiding DHS Overload\*\*

- \*\*Concern\*\*: Rapid staffing could overwhelm the system.
- \*\*Solution\*\*: Implement a \$40,000 training module for 20 new hires annually, phased over six months, and contract temporary staff (\$100,000/year) during peak rollout. This enhances efficacy, saves \$150,000-\$200,000 in turnover costs, and ensures equitable service delivery.

These solutions transform potential pitfalls into pillars of strength, maximizing SB960's impact with minimal burden.

#### ### VI. Conclusion

SB960 is a visionary step toward a Hawaii where no family goes hungry. It fortifies our safety, enhances efficacy, leverages cost-effective federal funds, and champions equity—values I hold dear as a Native Hawaiian of Kahalu'u. With the proposed refinements, its promise becomes unassailable. I urge the Senate to pass this bill, ensuring our people thrive, not merely survive. Hunger is our foe; SB960 is our weapon.
