<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) appreciates the intent of this bill and provides the following comments.

<u>PURPOSE</u>: The purpose of the bill is to change access to the supplemental nutrition assistance program (SNAP) for adult members aged sixty (60) years or older and adults with disabilities.

The Department has identified that the current SNAP household count is at approximately 84,000, with the number of individuals participating totaling nearly 160,000. Individuals aged sixty (60) years of age or older comprise twenty (20) percent of the overall number of SNAP participants and are part of approximately thirty-five (35) percent of all SNAP households. More research is needed to determine the number of households that are only composed of individuals aged sixty (60) years or older and the number of households entirely composed of adults with disabilities. However, we anticipate the proposed change to the number of eligible senior households would increase the overall workload and overload the

processing capacity to process benefit eligibility determination using our current eligibility system and the present workforce.

The United States Department of Agriculture (USDA), Food and Nutrition Service (FNS) oversees SNAP and allows states the option to extend the certification period for SNAP households aged sixty years or older from twelve (12) months to twenty-four (24) months without a waiver. However, due to limitations of our present eligibility system, certification periods cannot be extended automatically beyond the 12 months.

If the State were to implement this option with the current system limitation, it would require the Department to manually extend and track each individual household meeting the extension criteria. Manually extending and tracking these cases would potentially increase payment issuance errors that the state could not afford as the Department's SNAP program is currently under corrective action for its high payment error rate during the COVID-19 pandemic, which resulted in being assessed as a liability payment owed to the federal agency. The error rates have since decreased; however, DHS has requested an emergency appropriation in HB1099 and SB1418 that describes what is necessary to address the current penalty.

The Department will be implementing a new eligibility system in the fall of 2026 that will be able to support what is proposed in this measure by having the ability to implement and automate the extended 24-month certification period. Consequently, if the measure moves forward, DHS requests an extended effective date that considers the timeline for our new eligibility system.

Position: Support

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, manufacturers and distributors of food and beverage related products in the State of Hawaii.

HFIA supports this measure. Food insecurity has reached alarming rates in our state in recent years. Current data suggests up to 30% of families in the State face food insecurity and that in some areas that number could be as high as 40%.

The Supplemental Nutrition Assistance Program (SNAP) is a vital resource to help families in need in Hawaii. It also benefits all Hawaii consumers by bringing much needed Federal funds into our food systems and acting as a stabilizing force in the food industry at large.

Ensuring that everyone who needs food assistance has access to SNAP should be a top priority for our state Government.

Setting the minimum certification period for SNAP to 12 months or 24 months for kupuna households gives families and kupuna more time to utilize these benefits and achieve financial stability. This timeline can help ensure that eligible users do not lose benefits due to having to rapidly reapply. The adjusted certification timeline may reduce the

administrative burden on the Department of Human Services if they are not having to process reapplications so frequently.

AlohaCare appreciates the opportunity to provide testimony in **support** of **SB961**. This measure requires the Department of Human Services to adjust the minimum certification periods for Supplemental Nutrition Assistance Program benefits households, participate in the Elderly Simplified Application Project, and report to the Legislature.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 70,000 Medicaid and dual-eligible health plan members on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

AlohaCare's commitment to whole person care includes addressing a variety of social determinants of health, including housing, economic stability, and nutrition among other factors. We understand that without access to affordable healthy food, the health and well-being of our members is negatively impacted. For example, researchers from the Centers for Disease Control and Prevention found that food insecurity is associated with obesity among US adults in Hawai'i and 11 other states.¹

From keiki to kupuna, increasing access to nutritious meals will improve overall health and decrease adverse health outcomes. Families with access to SNAP are more likely to see their doctors for routine health checkups, preventing chronic

health conditions and increasing the ability to manage disease.² For our pregnant mothers and babies, maternal and early childhood access to SNAP is correlated to improved birth outcomes and long-term health outcomes as adults. For elderly populations, access to healthy food may be the difference in whether they can continue living in their communities independently, decreasing the need for medical interventions and emergency department visits.³ Investing in SNAP is a long-term solution that will support our 'ohana and most vulnerable populations' health and quality of life.

Hawai'i Public Health Institute (HIPHI)¹ and the Healthy Eating, Active Living² (HEAL) coalition is in **support of SB 961**, which requires the Department of Human Services to adjust the minimum certification periods for Supplemental Nutrition Assistance Program benefits for households, and would participate in the Elderly Simplified Application Project.

One in three households in Hawai'i faces food insecurity. Federal Supplemental Nutrition Assistance Program (SNAP) benefits are a lifeline to many of these residents. Local families in need receive over \$600 million annually in SNAP benefits. Unfortunately, the state has made accessing these benefits incredibly difficult. The state needs to improve the enrollment process and ensure local SNAP-eligible residents can receive the federal benefits they need.

Short Certification Periods

Residents in Hawai'i face frequent SNAP recertification requirements, with some needing to re-certify as often as every six months. Kūpuna (60 years and over) are required to recertify annually, even though federal regulations permit them to do so only once every three years.³

Hawai'i has the opportunity to extend SNAP certification periods to the federal maximum for all recipients. This change would significantly reduce the paperwork burden on families and kūpuna, easing stress and administrative challenges.

Importantly, it would also reduce the risk of losing benefits during the recertification process, a common issue caused by paperwork difficulties and bureaucratic barriers. By adopting this policy, Hawai'i can ensure more consistent access to essential food assistance for its residents.

Decreased Workload for SNAP Staff

Hawai'i's SNAP department faces overwhelming demand for its services, yet it lacks sufficient staffing to meet that demand effectively. By reducing the frequency of recertification, the department can significantly decrease its administrative workload.

This would free up valuable resources and allow staff to focus on improving the overall efficiency and accessibility of both the SNAP application and recertification processes. Streamlining these operations would benefit not only the department but also the thousands of residents who rely on SNAP for essential food assistance.

Please pass SB 961 to ensure we're doing everything we can to make SNAP as accessible as possible. Mahalo for your consideration.

Dear Chair San Buenaventura, Vice Chair Aquino, and members of the Committee:

Thank you for the opportunity to submit testimony in support of **S.B. 961**, which would require the Department of Human Services (DHS) to adjust the minimum certification periods for Supplemental Nutrition Assistance Program (SNAP) benefits households, participate in the Elderly Simplified Application Project (ESAP), and report to the Legislature.

SNAP is a critical lifeline for more than 160,000 Hawai'i residents. Without it, many of these individuals would not have any money to pay for food at all. Since benefits are federally funded, federal rules require tedious paperwork and documentation both upon initial application and for periodic recertification. Some SNAP users lose these crucial benefits during the recertification process, despite no changes to eligibility. This phenomenon, known as "churn," adds significantly to the administrative burden of administering SNAP at the state level.

This bill would provide some relief for the churn issue. Federal rules allow states to extend the SNAP certification period to 12 months for most households, with just a six-month "interim report." However, Hawai'i currently requires a full recertification every six months, increasing the possibility for churn. For households with seniors or people with disabilities, Hawai'i allows a longer 12-month certification, but for these households, it can be as long as 24 months, or even up to 36 months using what's known as the ESAP waiver. In addition to the three-year certification period, this waiver allows those who are 60+ to waive the recertification interview and allows for a simplified application process. As of 2024, 23 other states have already implemented ESAP and there are more to follow suit. Ta

Table 1. Hawai'i certification periods vs. maximum federal certification periods

Group	Hawaiʻi's current certification period	Maximum allowable certification period
Kūpuna (ages 60+) or adults with disabilities	Every 12 months	Every 36 months*
All other households	Every 6 months	Every 12 months

The proposed extended certification periods for most households have twofold benefits, reducing workload for both applicants and eligibility staff. We have a unique opportunity to ease the burden on both sides of the application process. Thank you for considering these comments in your deliberation of S.B. 961.

Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 0961, RELATING TO THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This measure, as received by your Committee, would direct the Department of Human Services (DHS) to:

- (1) Set the minimum certification periods for Supplemental Nutrition Assistance Program (SNAP) benefits to 24 months for households in which all adult members are 60 years of age or older, and 12 months for all other households;
- (2) Participate in the SNAP Elderly Simplified Application Project to adjust the benefit periods and other requirements for recipients based on age and disability status; and
- (3) Report demographic and utilization data to the 2027 and 2027 Legislatures.

This bill would take effect upon approval.

SNAP, formally known as the "Food Stamps Program", is the largest federal food assistance program that is currently in operation. It provides food-purchasing assistance for low- and no-income people. SNAP provided assistance to approximately 40 million persons in 2018, at an expenditure of \$57.1 billion. Approximately 9.2% of American households received SNAP benefits at some point during 2017, with approximately 16.7 of all children living in households receiving SNAP benefits.

Founded during the height of the Great Depression, SNAP is the cornerstone of our national social safety net. It is intended to prevent mass starvation precipitated from unemployment and homelessness. The program was also seen as a way of helping the poor while boosting the economy and ensuring that America's farmers would obtain a fair price for their labors by allowing government to purchase and distribute excess goods in time of crisis.

The COVID-19 Pandemic demonstrated how food scarcity and poverty threatened the health and welfare of our citizens in times of dire crisis. With so many people unemployed, entire families struggled to put food on the table on a consistent basis. Lines at the food bank and food drives stretched for miles and people waited for hours to receive surplus food.

While COVID-19 no longer poses the threat it did in years past, Hawaii's citizens still struggle because of stagnant wages and the rising cost of housing, food and other essentials. The lines for surplus food are still long as citizens continue to be challenged in putting food on their tables.

The HPCA has strongly endorsed this Program in previous years and we continue to urge your support. Additional SNAP benefits for a recipient can mean the difference between having to decide whether someone's last amount of cash will go for food or rent or medications or other necessities.

For these reasons, the HPCA respectfully urges your favorable consideration of this measure.

On behalf of Hawai'i Foodbank, I express our support for SB 961 Relating to Supplemental Nutrition Assistance Program (SNAP). This bill requires the Department of Human Services to adjust the minimum certification periods for SNAP benefits households, participate in the Elderly Simplified Application Project, and report to the Legislature.

For over 40 years, Hawai'i Foodbank has provided daily and emergency assistance to those facing food insecurity in Hawai'i. As the state's leading hunger-relief organization, Hawai'i Foodbank distributes food to families and individuals on O'ahu and in Kaua'i County through direct service programs and through our network of 266 agency partners and pantries. Last year, we served an average of over 150,000 people each month, distributing a total of 21 million pounds of nutritious food, including 5.9 million pounds of fresh produce.

Hawai'i Foodbank is also contracted as a SNAP outreach provider through the State. In this role, our team has seen firsthand the challenges SNAP applicants face. SNAP provides essential support to many families, but the complicated application and recertification process often causes eligible recipients to lose their benefits.

Extending the certification period for all recipients would reduce these barriers and ensure more people maintain their benefits. Participating in the Elderly Simplified Application Program would allow kūpuna to recertify only once every three years. These changes would ease the burden on both applicants and DHS SNAP staff, improving access to this vital program for everyone.

Food security is a critical issue in Hawai'i, where one in three households lack comprehensive access to healthy, nutritious food. The Department of Human Services SNAP department is critically understaffed and we support measures that will help address the shortage. SNAP is one of our most important anti-hunger programs, offering choice and healthy options for families who need extra support putting food on the table.

The current recertification process involves complex paperwork, often resulting in beneficiaries losing their benefits due to the difficulties encountered. By extending the certification period, Hawai'i can reduce the risk of benefit loss, providing much-needed stability for families in need. For kūpuna, the Elderly Simplified Application Program would allow them to recertify every three years, easing their burden significantly.

This extension would also lessen the workload on SNAP staff, improving the efficiency of the application process for everyone involved. I urge lawmakers to support SB 961, as it will enhance access to food security for our most vulnerable populations. Thank you for considering the positive impact of this legislation.
