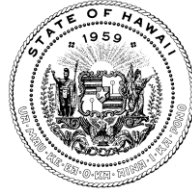

Re: S.C.R. 149, REQUESTING THE OFFICE OF THE STATE FIRE MARSHAL TO CONVENE A VEGETATION MANAGEMENT WORKING GROUP TO STUDY, EVALUATE, AND MAKE RECOMMENDATIONS FOR REGULATIONS THAT DEFINE PROPERTY OWNER OBLIGATIONS FOR VEGETATION MANAGEMENT ON PUBLIC AND PRIVATE PROPERTY TO MITIGATE WILDFIRE RISK.

The **DLIR appreciates the intent** of this measure, which requests the convening of a Vegetation Management Working Group to study, evaluate, and make recommendations to mitigate wildfire risk. While Act 209 (SLH 2024) established the Office of the State Fire Marshal within the DLIR, the Legislature is currently deliberating its permanent, executive placement.

The Governor's Package includes HB1064, which proposes transferring the Office of the State Fire Marshal and the State Fire Council to the Department of Defense (DOD). Given the DOD's mission in disaster readiness, response coordination, and public safety, it is a more appropriate agency for overseeing fire protection and emergency management functions. The current version of HB1064 places the Office of the State Fire Marshal under the DOD.

The DLIR lacks the expertise in vegetation management, hazard mitigation, and utilities regulation necessary to effectively support the objectives of this measure. Therefore, the department respectfully requests the removal of the Director of Labor and Industrial Relations as Chairperson of the Vegetation Management Working Group, as well as the removal of DLIR from its role in providing administrative support to the Group.

Chair Elefante and Members of the Committee:

My name is Michael Angelo, and I am the Executive Director of the Department of Commerce and Consumer Affairs (Department) Division of Consumer Advocacy. The Department supports this resolution.

The purpose of this resolution is to request that the Office of the State Fire Marshal to convene a Vegetation Management Working Group (Working Group) to study, evaluate, and make recommendations for regulations that define property owner obligations for vegetation management on public and private property to mitigate wildfire risk. In its review of vegetation management, the Working Group is to consider the (1) wildfire risk mitigation actions being proposed as part of the Hawaiian Electric Company's Climate Adaptation Transmission and Distribution and Resilience Program and Wildfire

Safety Strategy filed with the Public Utilities Commission (Commission) as Docket No. 2022-0135 and Docket No. 2025-0156, respectively; and (2) the hazard mitigation plans of electric utilities, including the Kauai Island Utility Cooperative, filed with the Commission as part of a non-docketed proceeding under Case No. 2023-04661 in response to the Order No. 40396. Further, the resolution requests that: (1) the State Fire Marshal, or the Director of Labor and Industrial Relations' designee, serve as the chairperson of the Working Group; (2) a representative of the Division of Consumer Advocacy of the Department, with experience in matters related to regulated public utilities, be appointed by the Director of the Department to serve as a member of the Working Group (while also naming a number of other agencies and stakeholders for inclusion in the Working Group), (3) the Working Group submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than 20 days prior to the convening of the Regular Session of 2026, and (4) the Working Group be dissolved on June 30, 2026.

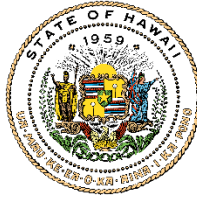
The tragedy and devastation of the wildfires that arose on Maui during the August 8, 2023, windstorm must be prevented from reoccurring. Vegetation management (including the creation of firebreaks and the removal of buildup of flammable vegetation), is viewed as essential for the mitigation of wildfire risks and the promotion of safer conditions for our communities and the environment. Thus, the Department supports the convening of a Working Group to make recommendations for regulations that define property owner obligations for vegetation management on public and private property to mitigate wildfire risk, as advanced by this resolution.

The Department appreciates that the resolution specifically requests that the Working Group consider the Commission's on-going proceedings regarding wildfire safety and climate adaptation and resilience, as applicable, for the electric utilities. As we noted with respect to similar measures, the Department believes that it is important to incorporate the results of these reviews into best practices for vegetation management to mitigate wildfire risk.

Senate Concurrent Resolution 149 urges the Office of the State Fire Marshal to convene a vegetation management working group to study, evaluate, and recommend regulations that define property owner obligations for vegetation management on public and private property to mitigate wildfire risk. **The Department of Land and Natural Resources (Department) supports this measure and provides comments and proposed amendments.**

The Department supports this resolution to coordinate fire-prone vegetation management. The tragic wildfires of August 2023 underscored the urgent need for comprehensive vegetation management strategies across the state. With increasing drought conditions, the proliferation of invasive grasses, and the proximity of flammable vegetation to critical infrastructure, Hawai'i must act decisively to reduce fuel loads and mitigate wildfire risk through clearly defined responsibilities and coordination.

The Department recommends the following amendments. The Department recommends that the Senate strike the language on Page 3, Line 7, regarding the Department of Labor and Industrial Relations as legislation proposes to move the Office of the State Fire Marshal out of the Department of Labor and Industrial Relations. The Department also recommends adding the Department of Land and Natural Resources Chairperson or the Chairperson's designee to the working group. Finally, the Department recommends amending the paragraph on page 2, lines 19-26, to read as follows:

Position:

The Public Utilities Commission ("Commission") supports this resolution and offers the following comments for consideration.

Comments:

The Commission appreciates the intent of these resolutions to develop regulations defining property owner obligations for vegetation management on public and private property to mitigate wildfire risk.

The combination of an electric utility's numerous easement and right-of-way agreements, along with the fragmented ownership of public and private lands in a state with limited land availability, poses significant challenges to developing clear and consistent vegetation management regulations. The Commission is committed to participating in the working group and working with the other members to find viable solutions.

The Commission would also suggest looking into how other states have addressed electric utility liability for removing vegetation, such as in Washington¹ and Oregon.²

Re: Testimony providing comment with a requested amendment for SCR 149/ SR 120

Aloha Honorable Chair, Vice-Chair, and Committee Members:

Mahalo for the opportunity to submit testimony and propose an amendment to SCR 149/SR 120. This resolution calls upon the Fire Marshal to convene a vegetation management working group to develop recommendations clarifying property owner obligations for mitigating wildfire risks through vegetation management on public and private lands. In crafting this resolution, it is worth noting that regulations in other states appropriately limit vegetation management requirements to electric utilities due to the unique wildfire hazards posed by high-voltage power lines. These precedents underscore the importance of tailoring policies to specific risk factors while avoiding unnecessary obligations for telecommunication service providers.

Hawai'i's current state laws and regulations form a complex patchwork of policies addressing wildfire prevention and control, including managing trees and vegetation. While electric utilities submit vegetation management programs to the Public Utilities Commission, outlining how they address overgrown vegetation and trees encroaching on high-voltage power lines, telecommunication facilities do not pose the same fire hazards as electric utility infrastructure.

Hawaiian Telcom’s communication equipment, by nature, does not independently create wildfire risks, making our role in vegetation management appropriately limited. When notified of necessary vegetation maintenance or identifying it ourselves, our local managers proactively engage property owners or right-of-way holders to address vegetation concerns. In instances where tree trimming is required to access electric utility poles, we collaborate by requesting the electric utility to prune the affected area, ensuring safe access for our teams.

We respectfully request that SCR 149/SR 120 be amended with the precedent set by similar changes to wildfire fund legislation, which appropriately excludes telecommunication service providers by striking the language on Page 4, line 2, as illustrated below:

Aloha Honorable Chair Elefante, Vice-Chair Wakai, and Committee Members;

The International Brotherhood of Electrical Workers Local 1260 (IBEW 1260) would like to offer the following testimony **in SUPPORT of SCR149 and SR120 with proposed amendments.**

IBEW Local 1260, is comprised of approximately 3,000 members throughout Hawaii and Guam and consists of a diverse and highly-skilled workforce that supports the electric utility infrastructure across our state as well as government service contracts and broadcasting. We are committed to protecting the well-being of the members we serve and the community at large.

The two resolutions offered request the Office of the State Fire Marshall to convene a vegetation management working group to study, evaluate, and make recommendations for regulations that define property owner obligations for vegetation management on public and private property to mitigate wildfire risk.

IBEW Local 1260 strongly supports the intent of the resolutions, however, we would respectfully request that you insert language to include discussion regarding the training and qualifications required to perform line clearance tree trimming around and/or near electric utility facilities.

The Bureau of Labor Statistics has reported that the Tree Industry average annual fatal-incident rate is thirty (30) times greater than the All-Industry average annual fatal-incident rate¹. Senate Bill 11 which was introduced to address wildfire vegetation management included language that required minimum standards of training and qualifications based on Occupational Safety and Health Administration and American National Standards Institute Safety Standards. California has already adopted state law² where it states in part that *"All electrical line clearance tree trimmers performing work to comply with the trim list vegetation management requirements in an electrical corporation's wildfire mitigation plan shall be qualified line clearance tree trimmers or trainees under the direct supervision and instruction of qualified line clearance tree trimmers."*
Requiring minimum safety standards for those performing work at or near electric utility facilities not only ensures the safety of the public, but of those performing this extremely hazardous work.

Respectfully, we request that SCR149 and SR120 be amended to include the following:

SCR149/ SR120 Propose Amendments:

Requesting the office of the state fire marshal to convene a vegetation management working group to study, evaluate, and make recommendations for REGULATIONS that define property owner obligations for vegetation management on public and private property TO MITIGATE wildfire RISK, and make recommendations that define a line clearance tree trimmer and establish minimum safety standards, training, and qualifications for individuals performing line clearance tree trimming at or near electric utility facilities.

WHEREAS, on August 8, 2023, catastrophic wildfires swept through various communities on the island of Maui; and

WHEREAS, the wildfires significantly impacted human life and the health, community housing, education, economy, and environment of Maui residents; and

WHEREAS, the presence of grass, trees, and other vegetation adjacent to or under electric utility lines is a significant fire risk; and

WHEREAS, in response to the wildfires, in 2023 the House of Representatives established six interim working groups, including the Wildfire Prevention Working Group, which were charged with evaluating specific topics related to the Lahaina wildfire and making recommendations for specific legislative action; and

WHEREAS, the Wildfire Prevention Working Group found that people are the primary drivers of wildfires in Hawaii, as ninety-nine percent of wildfires are caused by human ignitions; and

WHEREAS, the Wildfire Prevention Working Group also found that guinea grass, fountain grass, molasses grass, and buffelgrass can form continuous fuel beds, ignite easily, attain extremely high fine fuel loads, and grow back more vigorously in the post-fire environment than the majority of native vegetation; and

WHEREAS, utility companies have miles of utility lines installed throughout the State on public and private lands, including within the public rights of way and mountainous areas of the State; and

WHEREAS, a significant portion of these public lands is covered with unmanaged grasses, trees, and other vegetation that may pose a significant wildfire risk; and

WHEREAS, the Bureau of Labor Statistics has reported that the Tree Industry average annual fatal-incident rate is thirty (30) times greater than the All-Industry average annual fatal-incident rate; and

WHEREAS, the Legislature recognizes that other state jurisdictions have recognized the additional hazard presented to individuals performing line clearance tree trimming at or near electric utility facilities and have adopted state law requiring minimum safety standards, training and qualifications for individuals performing such work; and

WHEREAS, additional study into appropriate vegetation management will enable the State to develop appropriate policies, regulations, and guidance for the parties responsible for the management of vegetation on public and private lands to mitigate wildfire risk and establish minimum safety standards, training, and qualifications for individuals performing line clearance tree trimming at or near electric utility facilities; now, therefore,

BE IT RESOLVED by the House of Representatives of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, that the Office of the State Fire Marshal is requested to convene a Vegetation Management Working Group (Working Group) to study, evaluate, and make recommendations for regulations that define property owner obligations for vegetation management on public and private property to mitigate wildfire risk, as well as minimum safety standards, training, and qualifications for individuals performing line clearance tree trimming at or near electric utility facilities; and

BE IT FURTHER RESOLVED that in its review of vegetation management, the Working Group is requested to consider the following:

(1) Wildfire risk mitigation actions being proposed as part of the Hawaiian Electric Company's Climate Adaptation Transmission and Distribution and Resilience Program and Wildfire Safety Strategy filed with the Public Utilities Commission as Docket No. 2022-0135 and Docket No. 2025-0156, respectively; and

(2) The hazard mitigation plans of electric utilities, including the Kauai Island Utility Cooperative, filed with the Public Utilities Commission as part of a non-docketed proceeding under Case No. 2023-04661 in response to Public Utilities Commission Order No. 40396; and

BE IT FURTHER RESOLVED that the Working Group is requested to include the following members:

(1) The State Fire Marshal, or the Director of Labor and Industrial Relations' designee, who is requested to serve as the chairperson of the Working Group;

(8) The mayor of each county, or the mayor's designee; and

BE IT FURTHER RESOLVED that the Working Group is requested to submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2026; and

BE IT FURTHER RESOLVED that the Department of Labor and Industrial Relations is requested to provide administrative support to the Working Group, including drafting of the report; and

BE IT FURTHER RESOLVED that the Working Group is requested to dissolve on June 30, 2026; and
