Our community needs help from the State to push back on powerful lobbyists who advocate watering down requirements for the timely construction of critical infrastructure when proposing development projects in South Maui.

During multiple sessions with public testimony, it was abundantly clear the South Maui community residents wanted to 'REQUIRE' construction of essential infrastructure improvements before or concurrently with new development projects. Completion should be before occupancy. Residents were so concerned that approximately 80-100 residents testified. They wanted to ensure enforceability. This wording is not unique. Other communities across the United States have adopted similar policies.

Given that developers make promises but keep returning with less and less, enforceable wording is required. Trust is not an option.

As more development projects are completed, road capacity, sewers, drainage systems, etc. need to keep pace; thus ensuring the health and safety of the residents as well as preventing damage or costly retrofits. The time to update infrastructure is before or concurrently with, new development projects.

We are tired of broken promises and excuses.
