
Chair McKelvey, Vice Chair Gabbard, and Members of the Committee, thank you for the opportunity to testify on S.C.R 53 and S.R 35 which requests the comptroller to cooperate with the Hawai'i State Public Library System (HSPLS) to identify rural and underserved communities in the State with a need for better telecommunication access for residents to participate in the State legislative process.

The Department of Accounting and General Services (DAGS) supports the intent of S.C.R. 53 / S.R. 35 and offers the following **comments**. DAGS does not have the expertise to determine whether or not a community is underserved and lacks connectivity. The department recommends that the Office of Planning and Sustainable Development and the Hawai'i Broadband and Digital Equity Office support DAGS and HSPLS in the analysis by conducting

the necessary research.

The HSPLS currently has 51 libraries that have been outfitted with internet access (wifi), laptops, are environmentally controlled (air conditioning), and have staff capable of providing the necessary support to potential users wanting to access legislative hearings. The State's libraries are designed to support residents with disabilities to ensure access to the services available there.

The Hawaii State Council on Developmental Disabilities **supports SR35/SCR53**, which is requesting the comptroller to cooperate with the Hawaii State Public Library system to identify rural and underserved communities in the state with a need for better telecommunication access for residents to participate in the State legislative process.

This measure is particularly significant to the intellectual and developmental disabilities (I/DD) community. Access to the legislative process is fundamental to civic engagement, and individuals with I/DD—many of whom live in rural and underserved areas—face unique challenges when it comes to participating in government proceedings. These barriers include limited transportation options, financial constraints, and insufficient access to accessible telecommunication services.

By leveraging the Hawaii State Public Library System's established infrastructure, this measure has the potential to significantly reduce these barriers. Libraries are already trusted community hubs that offer free internet access, and with fifty-one locations statewide, they are

well-positioned to provide individuals with I/DD and other underserved populations with the opportunity to engage directly in legislative processes.

The importance of remote participation cannot be overstated. For individuals with I/DD, traveling to the Capitol is often costly and physically challenging. Additionally, caregivers and support staff who assist individuals with I/DD are frequently unable to take extended time off work to attend hearings in person. Providing accessible telecommunication options at designated locations would empower these individuals to voice their concerns, advocate for their needs, and participate fully in shaping public policy.

We commend the Legislature's commitment to ensuring that all residents—including those with disabilities and those in rural areas—have equitable access to the legislative process. By improving telecommunication infrastructure, this resolution will promote inclusiveness, strengthen civic engagement, and enhance the effectiveness of the legislative process for all Hawai'i residents.
