#### In consideration of SENATE CONCURRENT RESOLUTION 183 and SENATE RESOLUTION 153 ENDORSING AND REAFFIRMING SUPPORT FOR THE PROGRESS ACHIEVED BY THE ALOHA+ CHALLENGE THROUGH ITS INTEGRATED APPROACH AND SIX AMBITIOUS TARGETS TO BE REACHED BY 2030

#### The Department of Land and Natural Resources (Department) supports this measure.

The Department has made substantial progress on the Aloha+ Challenge goals to manage the State's natural resources and provide a green workforce and education. The State's Watershed Initiative is committed to protecting 30% (253,000 acres) of Hawaii's highest-priority forests by 2030. In 2010, only 10% of these forests were protected. Now, 22% are protected, in large part due to Capital Improvement Project funding provided by the Legislature. The Department also is undertaking the "Holomua Marine Initiative" which is a community-based planning approach to ensure local knowledge is guiding marine resource management planning for our State's ocean resources. The Department also tracks progress on other Aloha+ Challenge goals, such as native species protection, invasive species control, and increasing freshwater capacity. With support from the Legislature and other partners, we can continue to make progress on these initiatives that protect the precious natural resources of Hawai'i.
