The following additional budget requests are being proposed to update amounts requested in the operating budget:

# **Department of Education**

# School Support - Food Services (EDN 400/MD)

Add \$20,000,000 in general funds for FY 26 for the Food Services Program shortfall due to increased costs to provide students meals. The projected deficit can be attributed to a multitude of factors, including increased operating costs, rising food prices, and steady school meal prices charged to students.

## **Department of Transportation**

## Highways Administration (TRN 595/DB)

Add \$2,400,000 in special funds for FY 26 and \$2,800,000 in special funds for FY 27 to maintain and expand the Photo Red Light Imaging Detector System, including seeking additional locations to expand to the neighbor islands, and provide staffing for the county Office of the Prosecuting Attorneys and the four county police departments.

## 2. Adjustments to the CIP Request:

The following additional budget request is being proposed to update amounts requested in the CIP budget:

#### **Department of Transportation**

#### Airports Administration (TRN 195)

Add \$1,373,000 in special funds for FY 26 and FY 27 to Airports Division Capital Improvement Program Project Staff Costs, Statewide, Item C-11, for additional plans, design, and construction. House Bill No. 300 currently includes \$6,127,000 in special funds and \$200,000 in other funds for FY 26 and FY 27. An additional \$1,373,000 in special funds for both fiscal years are to fund wages and fringe for nine new project-funded staff positions to create a new airfield section to implement military airfield reconstruction.

PROJECT MAY ALSO INCLUDE FUNDS FOR NON-PERMANENT CAPITAL IMPROVEMENT PROGRAM RELATED POSITIONS (OTHER FUNDS FROM PASSENGER FACILITY CHARGES).
