SECTION 5. Salary increases and cost adjustments provided
 in this Act for any officer or employee whose compensation is
 paid, in whole or in part, from federal, special, or other funds
 shall be paid wholly or proportionately, as the case may be,
 from the respective funds.

6 SECTION 6. Funds appropriated or authorized by this Act
7 that are not expended or encumbered by June 30, 2026, and
8 June 30, 2027, of the respective fiscal years, shall lapse as of
9 those dates.

10 SECTION 7. In accordance with section 9 of article VII of the Constitution of the State of Hawaii and sections 37-91 and 11 12 37-93, Hawaii Revised Statutes, the legislature has determined 13 that the state general fund expenditure ceiling for fiscal year 14 2025-2026 has already been exceeded by \$ or per 15 cent. In addition, the appropriations contained in this Act 16 will cause the state general fund expenditure ceiling for fiscal year 2025-2026 to be further exceeded by \$ 17 , or one per 18 cent. The reasons for exceeding the general fund expenditure 19 ceiling are that the appropriations made in this Act are 20 necessary to serve the public interest and to meet the needs 21 addressed by this Act.
