A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION REVIEWS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

2 SECTION 1. The legislature finds that section 6E-8, Hawaii 3 Revised Statutes, plays an important role in the protection and 4 management of the State's historic properties and burial sites. 5 Section 6E-8(b), Hawaii Revised Statutes, requires the department of Hawaiian home lands, prior to any proposed project 6 7 relating to lands under its jurisdiction, to consult with the department of land and natural resources regarding the effect of 8 9 the project upon historic property or a burial site. 10 The purpose of this part is to allow the department of

Hawaiian home lands to review the effect of any proposed project on historic properties or burial sites for lands under its jurisdiction.

SECTION 2. Section 6E-8, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows:

16 "(b) [The] Notwithstanding subsection (a), the department

13	SECTION 3. The purpose of this part is to transfer the		
14	administrative placement of the island burial councils to the		
15	office of Hawaiian affairs.		
16	SECTION 4. Section 6E-43.5, Hawaii Revised Statutes, is		
17	amended to read as follows:		
18	"§6E-43.5 Island burial councils; creation; appointment;		
19	composition; duties. (a) There shall be established within the		
20	[department] office of Hawaiian affairs five island burial		
21	councils, one each for Hawai`i, Maui/Lāna`i, Moloka`i, O`ahu,

1 and Kaua`i/Ni`ihau, to implement section 6E-43. Each council 2 shall consist of nine members, except the Moloka'i council, 3 which shall consist of five members. Each council shall consist 4 of no more than three representatives of development and large 5 landowner interests; provided that the Moloka`i council shall 6 consist of no more than one representative of development and 7 large landowner interests. The remaining council members shall 8 represent the geographic regions identified in paragraphs (1) 9 through (5). At all times, at least two of the regional 10 representatives of each council shall have been appointed from a 11 list of nominees submitted to the governor by the office of 12 Hawaiian affairs, as provided under subsection (b). Each 13 council shall include at least one representative for each 14 geographic region identified as follows: 15 (1) The Hawai`i council shall include the following 16 geographic regions: Kohala, Kona, Ka`ū, Puna, Hilo, 17 and Hāmākua; 18 The Maui/Lāna`i council shall include the following (2) 19 geographic regions: Honua`ula, Lahaina, Wailuku, 20 Makawao, Hāna, and Lāna`i;

2		geographic regions: West Moloka`i, Central Moloka`i,

6		Ko`olaupoko, Ko`olauloa, and Waialua; and
7	(5)	The Kaua`i/Ni`ihau council shall include the following

9		Kawaihau, Hanalei, and Ni`ihau.
10	Regional	representatives shall be selected from the Hawaiian
11	community	on the basis of the representatives' understanding of

14	(b)	Appointment of members to the councils shall be made
15	by the go	vernor, in accordance with section 26-34 and subsection
16	(a), from	[lists] <u>a list</u> for each council submitted by [the
17	departmen	t and] the office of Hawaiian affairs. Lists to fill
18	vacancies	on the councils shall be submitted as follows:
19	(1)	For vacancies attributable to the expiration of terms,

1 of December before the expiration of the terms, except 2 as provided in subsection (c); and 3 (2) For a vacancy that occurs during a council 4 representative's term, the list shall be submitted 5 within thirty business days after the vacancy occurs, 6 except as provided in subsection (c). 7 [(c) The department may submit any list to fill a vacancy 8 up to fifteen days after the office of Hawaiian affairs submits 9 its list for the same vacancy; provided that the failure of the 10 department to submit any list by any relevant deadline or 11 fifteen days after the office of Hawaiian affairs submits its 12 list, whichever occurs later, shall be construed as a waiver of 13 the department's right to submit a list. 14 (d) (c) Notwithstanding section 26-34(b) or any other law 15 to the contrary, any council member whose term has expired may 16 continue in office as a holdover member until the member's 17 reappointment to a second term is confirmed or a successor is 18 nominated and appointed; provided that a holdover member shall 19 not hold office beyond the end of the fourth regular session of 20 the legislature following the expiration of the member's term of 21 office.

1 [(e)] (d) The [department,] office of Hawaiian affairs, in 2 consultation with the councils, [office of Hawaiian affairs,] 3 representatives of development and large landowner interests, and appropriate Hawaiian organizations, such as Hui Malama I Na 4 Kupuna O Hawai`i Nei, shall adopt rules pursuant to chapter 91 5 necessary to carry out the purposes of this section. 6 The council members shall serve without compensation, but shall be 7 reimbursed for necessary expenses incurred during the 8 9 performance of their duties. The councils shall be a part of 10 the [department] office of Hawaiian affairs for administrative 11 purposes.

12 [(f)] (e) The councils shall hold meetings and acquire 13 information as they deem necessary and shall communicate their 14 findings and recommendations to the department [-,] or office of 15 Hawaiian affairs, as appropriate. Notwithstanding section 92-3, 16 whenever the location and description of burial sites are under 17 consideration, the councils may hold closed meetings. A 18 majority of all members to which each council is entitled shall 19 constitute a quorum to do business. Concurrence of a majority 20 of the members present at a meeting shall be necessary to make 21 any action of a council valid.

 Hawaiian affairs.

4 All employees who occupy civil service positions and whose 5 functions are transferred to the office of Hawaiian affairs by 6 this Act shall retain their civil service status, whether 7 permanent or temporary. Employees shall be transferred without 8 loss of salary, seniority (except as prescribed by applicable 9 collective bargaining agreements), retention points, prior 10 service credit, any vacation and sick leave credits previously 11 earned, and other rights, benefits, and privileges, in 12 accordance with state personnel laws and this Act; provided that 13 the employees possess the minimum qualifications and public 14 employment requirements for the class or position to which 15 transferred or appointed, as applicable; provided further that 16 subsequent changes in status may be made pursuant to applicable 17 civil service and compensation laws.

18 Any employee who, prior to this Act, is exempt from civil 19 service and is transferred as a consequence of this Act may 20 retain the employee's exempt status, but shall not be appointed 21 to a civil service position as a consequence of this Act. An

1 exempt employee who is transferred by this Act shall not suffer any loss of prior service credit, vacation or sick leave credits 2 3 previously earned, or other employee benefits or privileges as a 4 consequence of this Act; provided that the employees possess 5 legal and public employment requirements for the position to 6 which transferred or appointed, as applicable; provided further 7 that subsequent changes in status may be made pursuant to 8 applicable employment and compensation laws. The administrator 9 of the office of Hawaiian affairs may prescribe the duties and 10 qualifications of these employees and fix their salaries without 11 regard to chapter 76, Hawaii Revised Statutes. 12 SECTION 6. All appropriations, records, equipment,

13 machines, files, supplies, contracts, books, papers, documents, 14 maps, and other personal property heretofore made, used, 15 acquired, or held by the department of land and natural 16 resources relating to the functions transferred to the office of 17 Hawaiian affairs shall be transferred with the functions to 18 which they relate.
