## A BILL FOR AN ACT

RELATING TO PROCUREMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a well-trained
- 2 workforce is essential for the State's economic growth and the
- 3 successful construction of public buildings, infrastructure, and
- 4 other development projects.
- 5 Therefore, the purpose of this Act is to require
- 6 contractors and subcontractors bidding on public works projects
- 7 to utilize apprentices in state-registered apprenticeship
- 8 programs, thereby further incentivizing bidders to participate
- 9 in state-registered apprenticeship programs, and quaranteeing a
- 10 steady supply of trained labor.
- 11 SECTION 2. Section 103-55.6, Hawaii Revised Statutes, is
- 12 amended as follows:
- 1. By amending subsection (a) to read:
- "(a) A governmental body, as defined in section 103D-104,
- 15 that enters into a public works contract under this chapter
- 16 having an estimated value of not less than \$250,000, shall
- 17 [decrease the bid amount of a bidder by five per cent if the



- 1 bidder is a party to an apprenticeship agreement registered with
- 2 the department of labor and industrial relations for each
- 3 apprenticeable trade the bidder will employ to construct the
- 4 public works, and in conformance with chapter 372.] apply a five
- 5 percent bid preference if the bidder and subcontractors utilized
- 6 by the bidder are parties to all registered apprenticeship
- 7 agreements for the apprenticeable trades to construct the
- 8 project pursuant to chapter 372, and approved by the department
- 9 of labor and industrial relations. This requirement shall not
- 10 apply to contractors or subcontractors employing trades or
- 11 classifications for which no state-approved apprenticeship
- 12 program exists. The lowest total bid, taking the preference
- 13 into consideration, shall be awarded the contract unless the
- 14 solicitation provides for additional award criteria. The
- 15 contract amount awarded, however, shall be the amount of the
- 16 price offered, exclusive of the preference."
- 17 2. By amending subsection (c) to read:
- 18 "(c) At the time of submission of a competitive sealed bid
- 19 or a competitive sealed proposal by a bidder, the bidder shall
- 20 furnish written proof [of] that either it or its subcontractors
- 21 being a party to a registered apprenticeship agreement for

### Description:

Requires a bidder and their subcontractors for certain public works construction contracts to utilize apprentices if the bidder receives a bidding advantage for being a party to an apprenticeship agreement registered with the State at the time of general bidding and is awarded the contract. Effective 7/1/3000. (HD1)
