A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds the department of 1 2 corrections and rehabilitation oversees eight correctional facilities throughout the State: Halawa correctional facility, 3 4 Waiawa correctional facility, Kulani correctional facility, the 5 women's community correctional center, Hawaii community 6 correctional center, Kauai community correctional center, Maui 7 community correctional center, and Oahu community correctional 8 center. It also contracts with CoreCivic to transfer and 9 incarcerate nine hundred thirty-eight male inmates at Saguaro correctional center in Arizona, despite the availability of open 10 11 beds at Waiawa correctional facility and Kulani correctional 12 facility.

13 The legislature recognizes that some correctional 14 facilities throughout the State face issues of overcrowding and 15 understaffing, which threatens the safety and well-being of 16 incarcerated individuals and corrections staff. As of December

1 2024, there were nine hundred forty-seven individuals 2 incarcerated at the Oahu community correctional center. 3 The legislature further finds that the department of 4 corrections and rehabilitation reported that from 2021 to 2023, 5 approximately thirty to forty per cent of inmates incarcerated in the State's correctional facilities were homeless immediately 6 7 prior to entry, and an even larger percentage exit to 8 homelessness. The Hawaii correctional system oversight 9 commission reported that eighty-six per cent of the inmate 10 population needs substance use treatment at some level, Native 11 Hawaiians are disproportionately incarcerated, and many in 12 Hawaii's correctional facilities need mental health services. 13 The legislature further finds that the department of 14 corrections and rehabilitation, with the support of the 15 department of accounting and government services, is proposing 16 to construct a new, expanded one thousand three hundred bed jail 17 to replace the Oahu community correctional center through a 18 public-private partnership. 19 The estimated cost to replace the Oahu community 20 correctional center according to the department of corrections

1 construction is \$1,000,000,000. This proposed new jail would 2 make it the single largest public works project in state history 3 and does not include the recurring costs of operation. To date, 4 the department of corrections and rehabilitation has expended 5 approximately \$25,000,000 on planning consultants, including 6 public relations professionals on this proposed project.

7 Furthermore, the legislature finds that expenditure of 8 taxpayer dollars on this proposed project is proceeding even 9 though the department of corrections and rehabilitation has made 10 no discernable effort to maintain and repair existing 11 facilities, including at the Oahu community correctional center. 12 Moreover, the department of corrections and rehabilitation has 13 not immediately implemented actionable changes at the Oahu 14 community correctional center that do not require new 15 construction, as outlined by the Hawaii correctional system 16 oversight commission.

In addition, the legislature finds that the department of corrections and rehabilitation should work collaboratively with justice system partners, beginning on Oahu, to increase diversion infrastructure to substantially reduce incarceration levels in the State's jails, address the root causes of

1 individuals' involvement with the criminal legal system, and 2 decrease pre-trial detention times to six months or less. 3 The legislature further finds that the department of 4 corrections and rehabilitation has also not provided a full 5 accounting of how past funding relating to the proposed project 6 has been spent. Finally, the legislature finds that the 7 department of corrections and rehabilitation is proceeding with 8 this project without a current comprehensive systems-wide 9 approach to master planning. The department of corrections and 10 rehabilitation is requesting another \$30,000,000 to issue a 11 request for proposals to replace the Oahu community correctional 12 facility even though the department's last ten-year master plan 13 update was completed in 2003. The last report lacked an 14 analysis of data-driven systems strategies to significantly 15 reduce the number of individuals who hold pretrial status in the 16 State's jails and divert those who are houseless, poor, and in 17 need of mental health care and substance use treatment to the 18 appropriate service providers.

Accordingly, the purpose of this Act is to:

20 (1) Require and appropriate funds for the office of the

(a) The office of the auditor shall perform a 10 comprehensive forensic audit of the department of corrections 11 and rehabilitation and department of accounting and general 12 services regarding spending related to the planning, design, 13 financing, construction, and maintenance of a new jail to 14 replace the Oahu community correctional center. 15 (b) The forensic audit shall include, at a minimum: 16 (1) A review of accountability measures within the 17 department of corrections and rehabilitation and 18 department of accounting and general services related 19 to the planning of a new jail to replace the Oahu 20 community correctional center;

1 (c) The office of the auditor shall submit a report of its 2 findings and recommendations, including any proposed 3 legislation, to the legislature no later than twenty days prior 4 to the convening of the regular session of 2026. 5 SECTION 3. The department of corrections and 6 rehabilitation and department of accounting and government 7 services shall fully cooperate with and provide any necessary 8 assistance to the office of the auditor with respect to the 9 comprehensive forensic audit and shall respond promptly to all 10 requests from the office of the auditor, including providing 11 records and other information requested during the course of the 12 audit. 13 SECTION 4. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2025-2026 for 16 the office of the auditor to perform a comprehensive forensic 17 audit pursuant to section 2 of this Act. 18 The sum appropriated shall be expended by the office of the auditor for the purposes of this Act. 19

20 SECTION 5. This Act shall take effect on July 1, 2025.21
