A BILL FOR AN ACT

RELATING TO ELECTRIC VEHICLE CHARGING INFRASTRUCTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the adoption of
 electric vehicles in the State continues to grow at increasing
 rates, with electric vehicles accounting for fifteen per cent of
 all new car sales in 2024, up 11.5 per cent from the year prior.
 There is a need for charging infrastructure to support this
 growth and ensure that there is an equitable transition to clean
 transportation.

8 The legislature further finds that providing electric 9 vehicle charging options at workplaces is beneficial for several reasons. Workplace charging provides options for people who may 10 not be able to charge at home--typically renters, those who live 11 in apartments, and low- and moderate-income families--the 12 opportunity to participate in the savings and other benefits of 13 14 owning an electric vehicle. Workplace charging also encourages daytime charging, which benefits the grid by shifting energy use 15 from peak evening hours to daytime hours, when energy is cheaper 16 17 and cleaner.

(a) The Hawaii state energy office, in 3 consultation with the department of accounting and general 4 services and department of transportation, shall survey existing 5 state facilities statewide that include parking, including but 6 not limited to state-owned parking lots that serve a state 7 facility, regardless of whether the lots are physically attached 8 9 to a building, and prioritize retrofitting these state 10 facilities in accordance with readily available information, including location, expected future demand for charging, 11 12 estimated costs for retrofits of parking stalls, other make-ready work, other planned improvements that would allow for 13

14 electric vehicle charger-ready retrofit work to be performed at 15 the same time, retrofitting for level 1 or level 3 charging at 16 high-priority sites where appropriate, and other factors that 17 the Hawaii state energy office deems relevant.

(b) The Hawaii state energy office shall submit a report
to the legislature no later than twenty days prior to the
convening of the regular session of 2026. The report shall
include the results of the survey conducted pursuant to

subsection (a), identifying between four to ten high-priority
 state facilities to be retrofitted to include electric vehicle
 charging infrastructure.

4 SECTION 4. It shall be the goal of the State to retrofit5 state facilities to be electric vehicle charger-ready.

6 SECTION 5. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ or so 8 much thereof as may be necessary for fiscal year 2026-2027 to 9 conduct detailed cost assessments to determine the cost to 10 install, or contract for the installation of, retrofits and 11 electric vehicle charging systems at the high-priority state facilities identified pursuant to section 3 of this Act and to 12 13 perform, or contract for, these installations.

14 The sum appropriated shall be expended by the Hawaii state
15 energy office for the purposes of this Act.

16 SECTION 6. New statutory material is underscored.

17 SECTION 7. This Act shall take effect on July 1, 3000.
