A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many of Hawaii's
- 2 farmers and ranchers are finding difficulty in securing the
- 3 financial support necessary to build a thriving, vibrant
- 4 business. Various sources of funding, including grants provided
- 5 by the United States Department of Agriculture, State, counties,
- 6 and private entities, are available for farmers and ranchers.
- 7 Access to grants from the United States Department of
- 8 Agriculture and other sources can increase production capacity,
- 9 provide new business opportunities, and increase employment
- 10 opportunities within the State's agricultural industry.
- 11 The legislature further finds that farmers and ranchers
- 12 applying for grants may have to complete an application process
- 13 that is sometimes complex. Without specific technical expertise
- 14 in grant writing, many farmers and ranchers may be deterred from
- 15 applying for those grants. Well-trained and skilled grant
- 16 specialists would be able to assist farmers and ranchers in
- 17 obtaining and fulfilling the requirements of grants.

1 The purpose of this Act is to appropriate funds to 2 establish grant specialist positions within the department of agriculture to assist farmers and ranchers in applying for, 3 4 obtaining, and fulfilling the requirements of grants offered by the United States Department of Agriculture, State, counties, or 5 6 private entities. 7 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 8 or so much thereof as may be necessary for fiscal year 2025-2026 for 9 10 the establishment of full-time equivalent (FTE) grant specialist positions within the department of agriculture to 11 12 assist farmers and ranchers in applying for, obtaining, and 13 fulfilling the requirements of grants offered by the United 14 States Department of Agriculture, State, counties, or private 15 entities; provided that the grant specialist positions shall 16 prioritize assisting farmers and ranchers who produce local food 17 that is at least partly consumed within the State. The sum appropriated shall be expended by the department of 18 19 agriculture for the purposes of this Act.

1 SECTION 3. This Act shall take effect on July 1, 3000.
