A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the agricultural
2	industry in Hawaii has been significantly affected by climate
3	change, globalization, the influx of devastating invasive
4	species and diseases, market conditions, a lack of agricultural
5	workers, and various other factors. The legislature further
6	finds that the State must modernize and adapt its policies and
7	laws accordingly. The legislature also finds that unnecessary
8	or obsolete sections of the Hawaii Revised Statutes are actually
9	impeding the growth and success of agriculture in Hawaii and
10	should be carefully reviewed to ensure that this important part
11	of the islands' economy and way of life can survive and thrive
12	into the future.
13	Therefore, the purpose of this Act is to establish and
14	appropriate funds for a working group within the department of
15	agriculture to review and make recommendations on amending or
16	repealing unnecessary or obsolete laws pertaining to
17	agriculture.

8		county of Maui;
9	(12)	The executive director of the Hawaii Farm Bureau, or
10		the executive director's designee, who shall be
11		invited by the chairperson of the working group;

- 5 recommendations on amending or repealing unnecessary or obsolete
- 6 laws pertaining to agriculture, including:
- 7 (1) Restrictions on leases of state agricultural land that 8 prohibit a residence on the property;
- 9 (2) Restrictions on leases of state agricultural land that
 10 prohibit the raising of poultry and swine on the
 11 property;
- 12 (3) Caps on agricultural operation loan rates;
- 13 (4) Regulations governing agricultural workforce
 14 development and farm labor access;
- 15 (5) Water access and permitting; and
- 16 (6) Procurement policies that impact the use of locally
 17 grown food in state institutions.
- 18 (d) The issues identified in subsection (c) shall not be
 19 construed to limit the laws pertaining to agriculture that the
 20 working group may consider for review and recommendation.

- 1 (e) Members of the working group who are employed by the
- 2 State and serving in their official capacity on the working
- 3 group shall serve without compensation. Other members of the
- 4 working group who are not employed by the State shall receive
- 5 compensation for their travel expenses.
- 6 (f) The working group shall submit a report of its
- 7 findings and recommendations, including any proposed
- 8 legislation, regarding its review of unnecessary or obsolete
- 9 laws pertaining to agriculture to the legislature no later than
- 10 twenty days prior to the convening of the regular session of
- 11 2026.
- 12 (g) The working group shall cease to exist on June 30,
- 13 2026.
- 14 SECTION 3. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so
- 16 much thereof as may be necessary for fiscal year 2025-2026 for
- 17 the working group established pursuant to section 2 of this Act.
- 18 The sum appropriated shall be expended by the department of
- 19 agriculture for the purposes of this Act.
- 20 SECTION 4. This Act shall take effect on July 1, 2050.
