# A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the island of Hawaii
- 2 needs an additional advanced life support ambulance to augment
- 3 the Hawaii county emergency medical services system for
- 4 residents of the North Kona area.
- 5 The legislature further finds that access to primary health
- 6 care in North Kona is challenging for the community. For many
- 7 residents, primary care services are as many as thirty miles
- 8 away. Coupled with economic and transportation challenges,
- 9 emergency medical services have become the access point for
- 10 health care to many residents.
- 11 The legislature further finds that resources to operate an
- 12 additional ambulance will help reduce death and disability among
- 13 residents and visitors on the island of Hawaii. A timely
- 14 response to a 911 call is critical to increase the likelihood of
- 15 successful outcomes for injured or sick individuals. Given the
- 16 island's significant growth and aging population, an additional
- 17 ambulance is needed and will be cost-effective.

## H.B. NO. 784 S.D. 1

- 1 The purpose of this Act is to appropriate funds for the
- 2 operation of an advanced life support ambulance to be based in
- 3 the Makalei area on the island of Hawaii, including operating
- 4 costs and personnel costs for state-certified emergency medical
- 5 service personnel.
- 6 SECTION 2. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so
- 8 much thereof as may be necessary for fiscal year 2025-2026 and
- 9 the same sum or so much thereof as may be necessary for fiscal
- 10 year 2026-2027 for the operation of an advanced life support
- 11 ambulance for the island of Hawaii, including operating costs
- 12 and personnel costs for state-certified emergency medical
- 13 service personnel, to be based in Makalei.
- 14 The sums appropriated shall be expended by the department
- 15 of health for the purposes of this Act.
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2026-2027 for
- 19 personnel services and other current expenses.
- The sum appropriated shall be expended by the Hawaii health
- 21 systems corporation for the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2050.
