## HOUSE CONCURRENT RESOLUTION

---

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO  
CONVENE A WORKING GROUP TO ASSESS ENVIRONMENTAL AND  
CONSERVATION INITIATIVES NEEDED TO TRANSITION VOLCANO,  
HAWAII, INTO A BIOSPHERE AREA THAT PROMOTES ENVIRONMENTAL  
SUSTAINABILITY AND COMMUNITY WELL-BEING AND COMPLEMENTS THE  
NEIGHBORING HAWAIIAN ISLANDS BIOSPHERE RESERVE.

1 WHEREAS, the Hawaiian Islands Biosphere Reserve was a  
2 United Nations Educational, Scientific and Cultural Organization  
3 (UNESCO) biosphere reserve that was comprised of Hawaii  
4 Volcanoes National Park and Haleakala National Park; and  
5

6 WHEREAS, UNESCO biosphere reserves are recognized for their  
7 commitment to balancing human activity with environmental  
8 conservation and sustainable development; and  
9

10 WHEREAS, to become a UNESCO biosphere reserve, an area must  
11 be nominated by its national government and meet certain  
12 criteria related to conservation, sustainable development, and  
13 scientific research; and  
14

15 WHEREAS, although Hawaii Volcanoes National Park met these  
16 high environmental and conservation standards, the greater  
17 Volcano, Hawaii, area suffers from many issues that threaten its  
18 environment and natural resources; and  
19

20 WHEREAS, Volcano, Hawaii, has been subject to invasive  
21 plant species, Rapid Ohia Death, ungulates, declining native  
22 plant populations, and forest loss and degradation; and  
23

24 WHEREAS, Volcano, Hawaii, should adopt similar  
25 environmental and conservation initiatives as Hawaii Volcanoes  
26 National Park; now, therefore,

1 BE IT RESOLVED by the House of Representatives of the  
2 Thirty-third Legislature of the State of Hawaii, Regular Session  
3 of 2025, the Senate concurring, that the Department of Land and  
4 Natural Resources is requested to convene a working group to  
5 assess environmental and conservation initiatives needed to  
6 transition Volcano, Hawaii, into a biosphere area that promotes  
7 environmental sustainability and community well-being and  
8 complements the neighboring Hawaiian Islands Biosphere Reserve;  
9 and

11 BE IT FURTHER RESOLVED that the working group is requested  
12 to consist of the following individuals:

14 (1) The State Representative from House District 5, who  
15 shall serve as Chair of the working group; and  
16  
17 (2) A representative from the Volcano Community  
18 Association, to be invited by the Chair of the working  
19 group; and  
20

21 BE IT FURTHER RESOLVED that the working group is requested  
22 to:

24 (1) Conduct a literature review that assesses existing  
25 reports and studies that provide insight into the  
26 environment, natural resources, and socioeconomic  
27 conditions of Volcano, Hawaii;  
28  
29 (2) Develop best practices for native ohia forest  
30 stewardship that inform sustainable development, land  
31 use, green infrastructure development, and water  
32 resource management;  
33  
34 (3) Develop a community engagement strategy that increases  
35 education and awareness of environmental issues in  
36 Volcano, Hawaii;

38 (4) Develop a monitoring and evaluation system that tracks  
39 the progress of environmental and conservation  
40 initiatives in Volcano, Hawaii; and

1 (5) Identify potential buffer zones and conservation  
2 easements for activities that support ohia forest  
3 preservation and sustainable development; and  
4

5 BE IT FURTHER RESOLVED that the working group is requested  
6 to determine the scope of the actions and initiatives to be  
7 conducted in the biosphere area; and  
8

9 BE IT FURTHER RESOLVED that the working group is requested  
10 to submit a report of its findings and recommendations,  
11 including any proposed legislation, to the Legislature and the  
12 Hawaii County Council no later than twenty days prior to the  
13 convening of the Regular Session of 2026; and  
14

15 BE IT FURTHER RESOLVED that the Department of Land and  
16 Natural Resources is requested to provide any necessary  
17 administrative support to the working group, including the  
18 preparation and drafting of the report; and  
19

20 BE IT FURTHER RESOLVED that the working group shall cease  
21 to exist on June 30, 2026; and  
22

23 BE IT FURTHER RESOLVED that a certified copy of this  
24 Concurrent Resolution be transmitted to the President of the  
25 Volcano Community Association Board of Directors.
