## HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF TRANSPORTATION, DEPARTMENT OF EDUCATION, AND MAUI COUNTY DEPARTMENT OF PUBLIC WORKS TO COLLABORATE TO PROPOSE VIABLE SOLUTIONS TO IMPROVE PEDESTRIAN AND TRAFFIC SAFETY AND RELIEVE TRAFFIC CONGESTION AROUND HAIKU ELEMENTARY SCHOOL.

WHEREAS, Haiku Elementary School is a public educational 1 institution providing pre-kindergarten through grade five 2 curriculum, serving a significant number of students and 3 families on Maui's north coast; and 4 5 WHEREAS, traffic congestion around Haiku Elementary School, 6 particularly during school drop-off and pick-up times, has 7 become a growing concern, impacting the safety of students and 8 9 efficiency of traffic flow in the area; and 10 WHEREAS, pedestrian and vehicle safety concerns, including 11 the need for safer crosswalks, better signage, improved routing, 12 and more efficient traffic management, have been raised by 13 parents, teachers, and community members; and 14 15 WHEREAS, the Department of Transportation, Department of 16 17 Education, and Maui County Department of Public Works are key stakeholders with the expertise to address these issues; and 18 19 WHEREAS, collaborative efforts between these departments 20 are necessary to develop comprehensive solutions that will 21 22 improve traffic safety and reduce congestion around Haiku Elementary School; now, therefore, 23 24 BE IT RESOLVED by the House of Representatives of the 25 Thirty-third Legislature of the State of Hawaii, Regular Session 26 27 of 2025, that the Department of Transportation, Department of Education, and Maui County Department of Public Works are 28 requested to collaborate to propose viable solutions to improve 29
