
HOUSE RESOLUTION

RELATING TO THE SALARIES OF CERTAIN STATE OFFICIALS.

1 WHEREAS, Article XVI Section 3.5, The Constitution of the
2 State of Hawaii ("Constitution") creates a Salary Commission
3 ("Commission") to review and recommend salaries for the governor,
4 the lieutenant governor, department heads of the executive
5 departments, members of the legislature, justices and judges of
6 all state courts; and
7

8 WHEREAS, under the Constitution, the Commission is required
9 to make a decision by the fortieth legislative day of the 2007
10 regular session and every six years thereafter and shall submit
11 its recommendations to the legislature; and
12

13 WHEREAS, since 2006, the Commission has met, and submitted
14 recommendations to the legislature in 2007, 2013, and 2019
15 respectively; and
16

17 WHEREAS, Section 26-56, Hawaii Revised Statutes, as amended
18 provides further guidance on the recommendations of the
19 Commission; and
20

21 WHEREAS, the salaries recommended by the Commission shall
22 become effective on July 1 of the next fiscal year unless
23 disapproved by the legislature by adoption of a concurrent
24 resolution approved by a simple majority in each house of the
25 legislature prior to adjournment sine die of the legislative
26 session in which the recommended salaries are submitted; and

28 WHEREAS, if the Commission's recommendations are
29 disapproved by the legislature, the commission shall reconvene
30 in November next following the legislature's disapproval to
31 review the reasons for disapproving its salary recommendations;

1 WHEREAS, the Commission, if reconvened after a disapproval
2 of their recommendations, may submit a report of its findings
3 and submit a new salary recommendation to the legislature at the
4 next regular session; and

6 WHEREAS, the Commission's reconvening following a
7 legislative disapproval shall not toll the six-year cycle; and

8
9 WHEREAS, the 2025 Commission on Salaries issued its Report
10 and Recommendations to the 2025 Legislature on March 4, 2025 to
11 increase the salaries and adjust the salary schedules for
12 certain State officials; and

13
14 WHEREAS, the State Legislature wishes to express its
15 appreciation for the work of the 2025 Commission on Salaries,
16 but concludes that the salary increases and salary adjustments
17 recommended by the 2025 Commission on Salaries are excessive in
18 light of current economic conditions in the State of Hawaii and
19 should be rejected; now, therefore,

20
21 BE IT RESOLVED by the House of Representatives of the
22 Thirty-third Legislature of the State of Hawaii, Regular Session
23 of 2025, by a simple majority of its entire membership,
24 disapproves the recommendation of the 2025 Commission on
25 Salaries and the salary and salary schedule increases
26 recommended therein; and

28 BE IT FURTHER RESOLVED that the Commission shall reconvene
29 no later than November 2025 to review the reasons for the
30 legislatures disapproval, submit a report of its findings, and
31 submit a new salary recommendation to the legislature in the
32 2026 legislative session; and

34 BE IT FURTHER RESOLVED that certified copies of this
35 Resolution be transmitted to the Office of the Governor, the
36 Office of the Lieutenant Governor, the Chief Justice of the
37 Judiciary, The Senate President, The Speaker of the House, and
38 the Chair of the 2025 Commission on Salaries.
