

## HOUSE RESOLUTION

REQUESTING THE GOVERNOR'S COORDINATOR ON HOMELESSNESS AND THE CITY AND COUNTY OF HONOLULU TO ESTABLISH A TWO-YEAR HOMELESSNESS SANCTUARY PILOT PROGRAM TO PROVIDE A SAFE LOCATION ON PUBLIC LAND FOR HOMELESS INDIVIDUALS AND FAMILIES TO RESIDE AND ACCESS SERVICES.

WHEREAS, homelessness is a significant problem across the 1 State; and 2 3 WHEREAS, on the island of Oahu in particular, there is a 4 large population of unsheltered individuals, many of whom suffer 5 from issues relating to mental health or drug use; and 6 7 WHEREAS, many homeless individuals have been cited or 8 arrested for being in public parks after hours, trespassing, or 9 illegally camping on sidewalks and other public areas; and 10 11 12 WHEREAS, this trend demonstrates that homeless families and individuals need a stable location to live in safety and with 13 14 dignity; and 15 WHEREAS, one way to create this safe and stable location is 16 to establish sanctuary locations where homeless individuals and 17 18 families can safely live, sleep, and access services; and 19 WHEREAS, providing consistent access to social services at 20 these sanctuaries will put homeless individuals and families in 21 a better position to escape the cycle of homelessness; and 22 23 WHEREAS, providing access for mental health services and 24 substance abuse treatment could encourage participation in those 25 programs; and 26 27 WHEREAS, in addition to services from public agencies, 28 local nonprofit organizations, churches and other faith-based 29
