A BILL FOR AN ACT

RELATING TO PARKING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the statewide SECTION 1. parking program for persons with disabilities was established to 2 issue disability parking permits to applicants who are certified 3 by a physician or advance practice registered nurse. A vehicle 4 5 displaying a disability parking permit is authorized to park in spaces designed and reserved for persons with mobility 6 disabilities. However, improper use and insufficient 7 8 enforcement impact access for legitimate program participants. 9 The legislature further finds that adoption of electric 10 vehicles is a vital step in the State's efforts to combat 11 climate change, reach the 2045 mandated carbon neutrality, and 12 create a more sustainable future. The legislature has made .13 efforts to encourage and facilitate the adoption of electric 14 vehicles with tax credits and designated charging parking 15 spaces. These parking spaces not only encourage the adoption of 16 electric vehicles but are a vital component to personal and 17 statewide use. The ability to park in an electric vehicle space

The state reserved parking space enforcement fine shall 6 be enforced and collected by the district courts and be 7 deposited into the safe routes to school program special fund 8 established pursuant to section 291C-4. 9 (b) Any person who uses a parking space reserved for 10 persons with disabilities and refuses or fails to present an 11 identification card issued under this chapter or the rules 12 adopted thereunder to an enforcement officer upon request shall 13 be guilty of a traffic infraction under chapter 291D [and 14 shall, be fined no less than \$250 nor more than 500[-], and 15 pay any costs incurred by the court related to assessing the 16 fine. In addition to any other applicable penalties and fines, 17 any person who violates this subsection shall be assessed an 18 additional state reserved parking space enforcement fine of 19 \$100. The state reserved parking space enforcement fine shall 20 be enforced and collected by the district courts and be
