A BILL FOR AN ACT

RELATING TO STATE-OWNED HISTORIC PROPERTIES AND INHERITED LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to establish a 2 state-owned historic properties preservation plan working group 3 to: 4 Identify all state-owned historic properties and (1)5 inherited lands; Develop a state-owned historic properties preservation (2) plan; 7 8 Identify a permanent funding source to ensure (3) 9 sustainable preservation efforts; and 10 (4)Develop frameworks for public-private partnerships that involve lineal descendants, cultural 11 12 practitioners, and nonprofit organizations. SECTION 2. (a) There is established within the department 13 14 of land and natural resources a state-owned historic properties preservation plan working group. 15 16 (b) The working group shall consist of the following 17 members:

1	(1)	The administrator of the state historic preservation
2		division, who shall serve as chair;
3	(2)	The chairperson of the board of land and natural
4		resources or the chairperson's designee;
5	(3)	The chief executive officer of the office of Hawaiian
6		affairs or the chief executive officer's designee;
7	(4)	The director of the planning department of each county
8		or their designees;
9	(5)	A cultural practitioner from each county to be
10		nominated by the office of Hawaiian affairs; and
11	(6)	Any other individuals that the chair may choose to
12		invite.
13	(c)	The working group shall:
14	(1)	Conduct a comprehensive inventory of state-owned
15		historic properties;
16	(2)	Evaluate the condition and significance of each state-
17		owned historic property;
18	(3)	Create actionable preservation and rehabilitation
19		plans, prioritizing properties at risk;
20	(4)	Develop criteria for the allocation of funds;

1	(5)	Explore and propose permanent funding mechanisms,
2		including new taxes, appropriations by the
3		legislature, grants and donations from public-private
4		partnerships, and revenue from adaptive reuse
5		projects;
6	(6)	Establish partnerships with lineal descendants,
7		cultural practitioners, and nonprofit organizations;
8		and
9	(7)	Promote community engagement and stewardship programs
10	(d)	The members of the working group shall serve without
11	compensat	ion but shall be reimbursed for expenses, including
12	travel ex	penses, necessary for the performance of their duties.
13	(e)	No member of the working group shall be subject to
14	chapter 8	4, Hawaii Revised Statutes, solely because of the
15	member's	participation in the task force.
16	(f)	The working group shall convene monthly and shall
17	submit an	interim report to the legislature every six months;
18	provided	that the working group shall also submit a conclusive
19	report of	its findings and recommendations, including any
20	proposed	legislation, to the legislature prior to the

21 dissolution of the working group, detailing completed

- 1 inventories and assessments and proposed preservation and
- 2 funding plans.
- 3 (g) The working group shall dissolve eighteen months after
- 4 its establishment.
- 5 SECTION 3. This Act shall take effect upon its approval.
