A BILL FOR AN ACT

RELATING TO RARE DISEASES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that over thirty million
- 2 people in the United States are affected by one of over seven
- 3 thousand rare disease. Rare diseases, also known as orphan
- 4 diseases, are classified as diseases that impact fewer than
- 5 twenty thousand people. Because of the small population of
- 6 patients, individuals suffering from rare diseases suffer many
- challenges, such as delays in obtaining a diagnosis, shortages
- 8 of medical specialists who can provide treatment, and a lack of
- 9 affordable access to therapies and medication used to treat rare
- 10 diseases. The small patient population can also make the
- 11 development of treatments for these diseases equally
- 12 challenging, particularly when it comes to conducting clinical
- 13 trials.
- 14 The legislature further finds that as of December 2024,
- 15 twenty-nine states have established rare diseases advisory
- councils. These councils address the needs of rare disease 16
- patients and families by giving stakeholders an opportunity to 17



- 1 share experiences, identify barriers, and propose solutions to
- 2 help the rare disease community. Members of a rare disease
- 3 advisory council are typically diverse, including members of the
- 4 rare disease community, health care providers, health insurers,
- 5 researchers, the biotech industry, and state government.
- 6 The purpose of this Act is to establish a rare disease
- 7 advisory council in the department of health to advise the State
- 8 on the needs of rare disease patients.
- 9 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 10 amended by adding a new part to be appropriately designated and
- 11 to read as follows:
- 12 "PART . RARE DISEASE ADVISORY COUNCIL
- 13 § -1 **Definitions**. For the purposes of this part:
- "Council" means the rare disease advisory council.
- 15 "Department" means the department of health.
- 16 "Rare disease" means a disease or condition that affects
- 17 fewer than twenty thousand people in the United States.
- 18 S -2 Rare disease advisory council; establishment;
- 19 duties; members; term; reports. (a) There is established
- 20 within the department, for administrative purposes only, an
- 21 advisory council to be known as the rare disease advisory

- 4 (b) The council shall:
- (1) Develop a landscape or survey of the needs of raredisease patients, caregivers, and providers in the

- **8** (2) Develop policy recommendations that:
 - (A) Improve patient access to, and quality of, rare disease specialists, affordable and comprehensive health care coverage, relevant diagnostics, timely treatment, and other needed services; and
 - (B) Research and identify priorities related to treatments and services for persons with rare diseases, including recommendations for preventing discrimination against rare disease patients, including in disaster and public health emergency-related planning;
- 19 (3) Research and make recommendations to the department or
 20 any other appropriate state agency, health care
 21 provider, or health insurer that provides services to

1		persons with rare diseases on the impact of coverage,
2		cost-sharing, tiering, or other utilization management
3		procedures on the provision of treatment and care
4		services;
5	(4)	Research and identify priorities related to treatments
6		and services provided to persons with rare diseases in
7		the State;
8	(5)	Publish a list of existing, publicly accessible
9		resources on research, diagnosis, treatment, and
10		education relating to rare diseases in the State on
11		the council's website;
12	(6)	Identify areas of unmet needs for research that can
13		inform future studies and reports by the council;
14	(7)	Establish resources for academic institutions, state
15		agencies, health care professionals, and other
16		entities to provide training to employees on rare
17		diseases in the State;
18	(8)	Identify and distribute educational resources for
19		health care providers to foster recognition and
20		optimize treatment of rare diseases in the State;

18		(E)	An administrator from a biopharmaceutical
19			manufacturer licensed and operating in the State;

4	(H)	A member of the scientific community who is
5		engaged in rare disease research, including but
6		not limited to a medical research with experience
7		conducting research on rare diseases; and
8	(I)	Two state residents who either have a rare
9		disease or have experience caring for a person
10		with a rare disease.
11	(e) The	council shall annually elect a member from among
12	its members to	serve as chair.
13	(f) Exce	ept for the ex officio members or their designees,
14	the council me	mbers shall be appointed by the governor for
15	three-year sta	ggered terms as provided for in section 26-34.

17	of 2028, and e	every three years thereafter, the council shall
18	submit a repor	t to the governor and the legislature, which shall
