
SENATE CONCURRENT RESOLUTION

URGING THE SAFE ROUTES TO SCHOOL ADVISORY COMMITTEE TO
COLLABORATE WITH THE DEPARTMENT OF EDUCATION, DEPARTMENT OF
TRANSPORTATION, AND THE COUNTY OF HAWAII TO CONDUCT AN
INVENTORY OF BUS STOPS ON HAWAII ISLAND UTILIZED BY
CHILDREN TO TRAVEL TO SCHOOL AND DEVELOP STRATEGIES TO
IMPROVE SAFETY AT EACH LOCATION.

1 WHEREAS, ensuring the safety of Hawaii's keiki as they
2 travel to and from school is a paramount concern for families,
3 educators, and policymakers; and
4

5 WHEREAS, unlike other islands in the State, many students
6 on Hawaii island face unique transportation challenges,
7 including long travel distances, limited access to school bus
8 services, and reliance on the County of Hawaii's Hele-On public
9 transportation system through special arrangements with the
10 Department of Education; and
11

12 WHEREAS, these challenges are compounded by bus route
13 limitations, road infrastructure deficiencies, and the absence
14 of safe, dedicated school bus stops in certain rural and
15 underserved areas; and
16

17 WHEREAS, the availability and staffing of active bus routes
18 are critical concerns, as many school transportation services
19 struggle with driver shortages, funding constraints, and an
20 insufficient number of routes to accommodate all students safely
21 and efficiently; and

23 WHEREAS, the need for additional bus routes has become
24 increasingly evident, particularly in remote communities where
25 children must walk long distances along unsafe roads to reach
26 their nearest bus stop or school; and

1 WHEREAS, poorly designed or maintained bus stops, lack of
2 proper lighting, insufficient pedestrian crossings, and
3 hazardous traffic conditions pose significant risks to children;
4 and

6 WHEREAS, a comprehensive review of existing bus stops on
7 Hawaii island used by school-aged children is necessary to
8 identify deficiencies and develop recommendations for
9 improvements; now, therefore,

11 BE IT RESOLVED by the Senate of the Thirty-third
12 Legislature of the State of Hawaii, Regular Session of 2025, the
13 House of Representatives concurring, that the Safe Routes to
14 School Advisory Committee is urged to collaborate with the
15 Department of Education, Department of Transportation, and the
16 County of Hawaii to conduct an inventory of bus stops on Hawaii
17 island utilized by children to travel to school and develop
18 strategies to improve safety at each location; and

20 BE IT FURTHER RESOLVED that this inventory is requested to
21 include an assessment of safety conditions at each bus stop,
22 including but not limited to:

- 23
24 (1) The presence and condition of sidewalks and
25 crosswalks;

27 (2) Adequate lighting and visibility;

29 (3) Traffic patterns and congestion;
30
31 (4) Proximity to high speed roadways;

33 (5) The availability of shelters and seating;

35 (6) The adequacy of current bus routes in meeting student
36 transportation needs; and

38 (7) Any other potential hazards affecting student safety;

41 BE IT FURTHER RESOLVED that the Safe Routes to School
42 Advisory Committee, in coordination with the Department of



1 Education, Department of Transportation, and the County of
2 Hawaii, is requested to develop recommendations and propose
3 strategies to enhance the safety of these bus stops, including
4 infrastructure improvements, traffic calming measures,
5 additional bus routes, and community engagement initiatives; and
6

7 BE IT FURTHER RESOLVED that the County of Hawaii is
8 requested to use funding for its Safe Routes to School program
9 to support the efforts of the Safe Routes to School Advisory
10 Committee in conducting the inventory of bus stops on Hawaii
11 island and developing strategies to improve safety at each
12 location; and
13

14 BE IT FURTHER RESOLVED that the Safe Routes to School
15 Advisory Committee is requested to submit a report of its
16 findings and recommendations, including a prioritized list of
17 bus stops in need of immediate safety improvements, to the
18 Legislature no later than twenty days prior to the convening of
19 the Regular Session of 2026; and

21 BE IT FURTHER RESOLVED that certified copies of this
22 Concurrent Resolution be transmitted to the Governor,
23 Chairperson of the Board of Education, Superintendent of
24 Education, Director of Transportation, Chairperson of the Safe
25 Routes to School Advisory Committee, and Mayor of the County of
26 Hawaii.
