## SENATE CONCURRENT RESOLUTION

REQUESTING THE UNIVERSITY OF HAWAII SYSTEM TO ESTABLISH A VETERINARY MEDICINE EXPANSION WORKING GROUP TO EXPLORE THE FEASIBILITY OF DEVELOPING A DOCTOR OF VETERINARY MEDICINE PROGRAM.

1 WHEREAS, the State faces a critical shortage of veterinarians, especially in rural areas and for large animal 2 3 and agricultural veterinary services; and 4 5 WHEREAS, the State's lack of a Doctor of Veterinary Medicine program forces aspiring veterinarians to seek education 6 on the United States mainland or internationally, which can 7 increase financial burdens and reduce the likelihood that a 8 9 newly licensed veterinarian will return to Hawaii to practice; 10 and 11 WHEREAS, Windward Community College's Veterinary Technology 12 program has a strong foundation in veterinary education, 13 providing students with hands-on experience and producing 14 skilled veterinary technicians; and 15 16 WHEREAS, the establishment of a Doctor of Veterinary 17 Medicine program in Hawaii could include collaborations between 18 the University of Hawaii System, private veterinary practices, 19 and national accredited bodies to ensure academic excellence and 20 21 program sustainability; now, therefore, 22 BE IT RESOLVED by the Senate of the Thirty-third 23 Legislature of the State of Hawaii, Regular Session of 2025, the 24 House of Representatives concurring, that the University of 25 26 Hawaii System is requested to establish a Veterinary Medicine Expansion Working Group to explore the feasibility of developing 27 28 a Doctor of Veterinary Medicine program; and 29
