
SENATE CONCURRENT RESOLUTION

REQUESTING THE OFFICE OF WELLNESS AND RESILIENCE TO DEVELOP A
REPORT TO ADDRESS THE DEVELOPMENTAL NEEDS OF CHILDREN BORN
DURING THE CORONAVIRUS DISEASE 2019 PANDEMIC.

1 WHEREAS, the COVID-19 pandemic has had profound effects on
2 children born between the years 2018-2025, disrupting their
3 social, emotional, academic, and health development during their
4 most critical early years; and

5
6 WHEREAS, scientific evidence and expert testimonies
7 indicate that many children in this age group are experiencing
8 developmental delays, including challenges in communication,
9 fine motor skills, emotional regulation, and social interaction;
10 and

11
12 WHEREAS, early childhood education and support during these
13 formative years are crucial for long-term academic success and
14 overall well-being, yet these children may face compounded
15 challenges as they transition into middle and high school; and

16
17 WHEREAS, children who were born and raised during the
18 COVID-19 pandemic, especially those from birth to age five, are
19 at heightened risk for academic and developmental setbacks due
20 to the unique circumstances of their upbringing, including
21 reduced social interactions, increased screen time, and
22 disrupted routines; and

23
24 WHEREAS, families across the State endured significant
25 challenges during the COVID-19 pandemic, including heightened
26 fear of contracting the virus, economic instability due to
27 inflation and loss of income, and increased food and housing
28 insecurity; and

29
30 WHEREAS, caregivers have faced the additional burden of
31 adapting to online education for their children while managing



1 toxic stress within households, which has adversely affected the
2 social and emotional well-being of children from birth to age
3 five, a critical period for early childhood development; and
4

5 WHEREAS, climate crisis, such as the 2018 Kilauea eruption
6 and 2023 Maui wildfires, have further compounded the trauma for
7 children in affected areas, leading to additional challenges in
8 emotional and psychological well-being, especially for those who
9 were already vulnerable due to the COVID-19 pandemic; and
10

11 WHEREAS, trauma can have profound negative impacts on
12 students' social, emotional, and behavioral needs; and
13

14 WHEREAS, disparities in developmental outcomes have been
15 observed, disproportionately affecting children from
16 economically disadvantaged, minority, rural, and remote
17 communities, including Native Hawaiian communities; and
18

19 WHEREAS, recovery and catch-up interventions for these
20 children are essential to mitigate long-term impacts on their
21 educational and life trajectories; and
22

23 WHEREAS, educators and others who work with children have
24 also been profoundly impacted by the stressors of the COVID-19
25 pandemic, facing increased demands, and limited resources, as
26 well as their own experiences of toxic stress, leading to a
27 record number of educators leaving the profession and fewer
28 individuals entering the field; and
29

30 WHEREAS, the cascading effects of trauma within families,
31 schools, and communities have placed a significant strain on
32 community-based providers responsible for the care and
33 development of children, further challenging their ability to
34 support the social-emotional needs of children and families;
35 now, therefore,
36

37 BE IT RESOLVED by the Senate of the Thirty-third
38 Legislature of the State of Hawaii, Regular Session of 2025, the
39 House of Representatives concurring, that the Office of Wellness
40 and Resilience is requested to develop a report to address the
41 developmental needs of children born during the COVID-19
42 pandemic; and

2 BE IT FURTHER RESOLVED that the Office of Wellness and
3 Resilience is requested to include the following in its report:
4

5 (1) Trauma-informed care research and practices that:
6

7 (A) Identify the nature of trauma and the effects of
8 acute or chronic exposure to trauma;
9

10 (B) Present interventions and strategies to resist
11 re-traumatization for those impacted by trauma;
12 and
13

14 (C) Recommend cultural practices and research-
15 practiced, evidence-based interventions to
16 support children's transitions into middle
17 school, high school, and post-high school life;
18

19 (2) An outline of the existing services offered by the
20 Department of Education, Department of Health,
21 Department of Human Services, Office of Hawaiian
22 Affairs, Executive Office on Early Learning, and key
23 non-profits and community groups to address social and
24 emotional learning loss experienced during the COVID-
25 19 pandemic;
26

27 (3) A comprehensive analysis of the services available for
28 individuals and families affected by the 2023 Maui
29 wildfires;
30

31 (4) Information on existing services to support educators
32 and those who work directly with children and families
33 who may suffer from secondary traumatic stress due to
34 the COVID-19 pandemic and 2023 Maui wildfires; and
35

36 (5) Recommendations to strengthen efforts to support
37 frontline workers' self-care plans and provide
38 interventions to promote resiliency and well-being;

41 BE IT FURTHER RESOLVED that the Office of Wellness and
42 Resilience is requested to submit its report, including any



1 proposed legislation, to the Legislature by December 31, 2026;
2 and

4 BE IT FURTHER RESOLVED that certified copies of this
5 Concurrent Resolution be transmitted to the Governor and
6 Director of the Office of Wellness and Resilience.
