SENATE RESOLUTION

REQUESTING THE GOVERNOR, OR THE GOVERNOR'S DESIGNEE, TO CONVENE A WORKING GROUP ON SOLID WASTE MANAGEMENT.

WHEREAS, the permit for the Waimanalo Gulch Sanitary 1 2 Landfill in Kapolei on Oahu expires in 2028; and 3 WHEREAS, the City and County of Honolulu (City) has not 4 identified any sites for a new landfill that the Honolulu Board 5 of Water Supply finds acceptable because the sites identified 6 are located above aquifers and therefore development of a new 7 8 landfill there has the potential to contaminate ground water; and 9 10 WHEREAS, the City claims that the legally available and 11 feasible options for a new landfill are located above aguifers 12 and lands with soils classified by the Land Study Bureau's 13 14 detailed land classification as overall (master) productivity rating class A or B; and 15 16 17 WHEREAS, the United States Department of Defense holds that federal lands controlled by the military are not available for 18 landfill use under federal rules; and 19 20 WHEREAS, if no new landfill site is identified, the City 21 22 will be forced to pursue a legally prohibited expansion of the Waimanalo Gulch Sanitary Landfill; and 23 24 25 WHEREAS, a new landfill on Oahu is inherently problematic and is not necessarily the best way that communities in the 26 State can reduce and handle the solid waste produced by their 27 28 linear extract, package, and throw-away economy; now, therefore, 29 30 BE IT RESOLVED by the Senate of the Thirty-third 31 Legislature of the State of Hawaii, Regular Session of 2025, 32 that the Governor, or the Governor's designee, is requested to convene a Solid Waste Management Working Group; and 33 34

1 (13)A representative from the United States Armed Forces, who is requested to be invited by the Governor; and 2 3 4 BE IT FURTHER RESOLVED that the Governor, or the Governor's 5 designee, is requested to convene the initial meeting for the Solid Waste Management Working Group; and 6 7 8 BE IT FURTHER RESOLVED that the Solid Waste Management 9 Working Group is requested to elect a chair from among its members at the initial meeting of the working group, who is in 10 turn requested to convene subsequent meetings for the working 11 12 group; and 13 14 BE IT FURTHER RESOLVED that the Solid Waste Management 15 Working Group is requested to submit a report of its findings and recommendations, including any proposed legislation, to the 16 Legislature no later than twenty days prior to the convening of 17 18 the Regular Session of 2026; and 19 20 BE IT FURTHER RESOLVED that the report is requested to 21 include: 22 23 (1) Information on materials management policies and programs that reduce solid waste and protect the 24 25 environment, which includes the groundwater, earth, 26 and air; and 27 (2) A list of alternative technologies to address solid 28 29 waste management of waste that cannot typically be recycled or composted; and 30 31 32 BE IT FURTHER RESOLVED that certified copies of this Resolution be transmitted to the Governor, who is in turn 33 34 requested to transmit a copy to each stakeholder invited to 35 participate in the Solid Waste Management Working Group; Director of Health; Mayor of each county; and Manager and Chief 36 Engineer of the Honolulu Board of Water Supply. 37
